### SB 562--State agencies; purchase of insurance for automobiles

Staff briefed the committee on the bill.

The Chairman welcomed D. Keith Meyers, Director, Divisions of Facilities, Printing and Purchases, Kansas Department of Administration, who spoke in support of the bill (<u>Attachment 4</u>). Mr. Meyers explained that <u>SB 562</u> would require state agencies to purchase collision and comprehensive insurance for their agency owned vehicles.

Written testimony was submitted by Sherry C. Diel, Executive Director, Kansas Real Estate Commission (Attachment 5).

There being no further conferees to come before the committee, the Chairman closed the public hearing on SB 562.

Senator Adkins moved, with a second by Senator Jackson, to amend SB 562 to make the provisions of the bill permissive for comprehensive coverage and recommend SB 562 favorable for passage as amended. Motion carried on a roll call vote.

### HB 2705--State water plan fund, transfers from the state general fund

Staff briefed the committee on the bill.

The Chairman welcomed Ken Grotewiel, Assistant Director, Kansas Water Office, who testified in support of <u>HB 2705</u> (Attachment 6). Mr. Grotewiel explained that the bill is a technical cleanup to make it part of the original statute.

# HB 2571--Authorizing SRS child support enforcement employees to obtain birth certificate copies for certain children born out of wedlock

Staff briefed the committee on the bill.

Chairman Morris welcomed Jamie Corkhill, Policy Counsel for the Department of Social and Rehabilitation Services Child Support Enforcement, who presented testimony on behalf of Candy Shively, Deputy Secretary, Integrated Service Delivery, Kansas Department of Social and Rehabilitation Services, in support of <a href="HB 2571">HB 2571</a> (Attachment 7). Ms. Corkhill explained that SRS proposed the legislation to provide SRS staff and federal auditors access to information about children born out of wedlock. Such information is needed to perform their work. She mentioned that the benefits of the bill would be substantial and the cost to the state minimum.

The Chairman welcomed Dr. Lorne Phillips, State Registrar and Director, Center for Health & Environmental Statistics, Kansas Department of Health and Environment, who testified in support of <a href="HB 2571">HB 2571</a> (Attachment 8). Dr. Phillips explained that <a href="HB 2571">HB 2571</a> amends the Uniform Vital Statistics Act to allow Child Support Enforcement staff to obtain birth certificate information to improve their program management.

There being no further conferees to appear before the committee, the Chairman closed the public hearing on **HB 2571**.


Senator Helgerson moved, with a second by Senator Schodorf, to recommend **HB 2571** favorable for passage. Motion carried on a roll call vote.





### HB 2569 - Child Advocacy Centers

Senator Morris and members of the committee, I am Candy Shively, Deputy Secretary with SRS. Thank you for the opportunity to appear today to discuss House Bill 2569. This bill supports child advocacy centers which are child-focused, supportive environments in which forensic interviews of children who have been abused or neglected are completed. Child Advocacy Centers reduce the number of times a child must be interviewed which improves the quality of information obtained from the child. This in turn, increases achievement of prosecutions. This proposal would require specialized training, tracking of cases referred to the facility and a multi-disciplinary case review team. The centers would either provide or refer children for medical examination services and/or mental health therapy.

Currently, there are six child advocacy centers in the state. An additional center is being developed. These centers are funded primarily from sources such as grants and private donations. SRS staff have worked well with the existing centers and would welcome the opportunity to work with additional centers. Child advocacy centers are an excellent example of how SRS has come together with community partners to improve outcomes for children.

SRS supports the House amendment to this bill to include forensic interviews with children suspected of sexual abuse as well as physical, mental or emotional abuse. Sexual abuse interviews are one of the specialties of these centers and forensic interviews are extremely valuable in these cases.

SRS believes child advocacy centers are a positive addition to the child welfare system and the addition of more centers will benefit communities. Thank you for the opportunity to comment on this bill.

S.B. 562 Authorizing the Purchase of Collision and Comprehensive Coverage for Vehicles

Thank you for this opportunity to provide information regarding S.B. 562.

This bill would require state agencies to purchase collision and comprehensive insurance coverage for their agency owned vehicles. Historically, agencies have participated in a statewide policy for liability coverage bid through the Division of Purchases and approved by the Surety Bond Committee as required by statute. This cost of the liability insurance totaled \$1,105,212 during the most recent policy year, excluding the Department of Transportation. No statutory authority currently exists that would allow agencies or the Central Motor Pool to purchase collision and comprehensive insurance.

Agencies have been responsible for the damage that has occurred with agency owned vehicles. Agencies were also responsible for the damage to Central Motor Pool vehicles that were the fault of the drivers. During FY 2003, there were 87 accidents in this group of vehicles that were the fault of the drivers at a total cost of \$67,557. Agencies were not responsible for the damage to Central Motor Pool vehicles that were not the fault of the drivers. During FY 2003, there were 94 accidents that were not the fault of the drivers at a total cost of \$45,588. There were also 100 incidents of miscellaneous damage due to weather and vandalism totaling \$33,641.

Agencies have taken over ownership of Central Motor Pool vehicles. In addition to the liability coverage already acquired, this bill would require agencies to purchase comprehensive coverage for collision. An estimated cost of providing this coverage would be \$472 per vehicle. With 7,190 vehicles to insure, the total premium cost just for automobiles and trucks would total \$3,393,680.

The Kansas Real Estate Commission is a small agency. Part of our charge is to audit the records and trust accounts of real estate brokerages across the State. We have three vehicles for use by our auditors. After the elimination of the Central Motor Pool. the Commission was left to self-insure its vehicles. A loss of a \$15,000-\$20,000 vehicle would detrimentally affect small agency budgets. The Commission supports lifting the prohibition to allow agencies to purchase collision insurance. The Commission takes a neutral position on whether the purchase of collision should be mandatory for all agencies.

### Testimony on Restoration of SGF Transfer Amount to State Water Plan to The Senate Ways and Means Committee

Senator Morris and members of the Committee. I am Ken Grotewiel, Assistant Director of the Kansas Water Office. I am pleased to be here in support of HB 2705.

HB 2705 amends K.S.A. 2003 Supp. 82a-953a, repealing the existing section, and returning the State Water Plan Fund demand transfer to its original amount of \$6,000,000 when initially approved. The transfer amount was reduced through an amendment to this statute last year to \$3,773,949 for FY 2004. Passage of this bill continues to allow for annual adjustments to the amount of the demand transfer based on existing fiscal conditions as determined by the Governor and Legislature.

There will be no fiscal impact to the agency or the State General Fund by amending this statute back to the original demand transfer amount. There will be a positive fiscal impact on the State Water Plan Fund in years when the demand transfer is higher than the amount in the current statute or when it is at the \$6,000,000 level.

### H.B. 2571- CSE Access to KDHE Birth Information

Senator Morris and members of the committee, I am Candy Shively, Deputy Secretary with Social and Rehabilitation Services (SRS). I am here in support of House Bill 2571. SRS has proposed this legislation to provide SRS staff and federal auditors access to information about children born out of wedlock, needed to perform their work.

In 1996, federal welfare reform changed the philosophy and structure of federal audits of the Child Support Enforcement (CSE) program, measuring meaningful outcomes and encouraging performance improvement. Under the new audit structure, great reliance is placed on system-generated data submitted by the State. The audits now occur in two stages. First, federal auditors evaluate the reliability of the data submitted by the State. Second, if the State's data is reliable, they calculate the performance of the state in five key areas, including paternity establishment.

Through the cooperation of the Department of Health and Environment (KDHE), SRS submits to the federal government annual paternity statistics. An issue raised by federal auditors performing the Data Reliability Audit each year is SRS' inability to provide satisfactory access to information confirming the accuracy of data about children who were born out of wedlock. Kansas law (K.S.A. 65-2422d) bars KDHE from revealing a child was born out of wedlock. Federal auditors trying to measure SRS' success in establishing paternity cannot be told by KDHE a child was born out of wedlock, impeding their ability to confirm the accuracy of SRS statistics. This proposed legislation resolves the problem.

For the past several years, federal auditors have reluctantly accepted work-around solutions for confirming the reliability of KDHE's data about children born out of wedlock. However, that flexibility is a thing of the past. The U.S. Department of Health and Human Services (DHHS) in Washington, D.C., has recently identified specific information a state will be expected to provide in order to pass the Data Reliability Audit. SRS can no longer rely on goodwill and the flexibility of federal auditors — the law needs to be modified to authorize access to necessary KDHE information. The entrance conference initiating SRS' next Data Reliability Audit was held on March 23rd.

Federal specifications for confirming the reliability of data on children born out of wedlock are limited and make sense. Like SRS workers, federal auditors are subject to stringent ethical and legal requirements for preserving the confidentiality of information they receive during an audit.

The Data Reliability Audits are critical because failure to submit data passing the federal standard for reliability can cost the state all or part of federal incentive funds available. In recent years, Kansas has received between \$2.0 and \$3.0 million in incentives, all of which has gone into the SRS fee fund to help pay the state's share of CSE program costs.

The final change proposed to K.S.A. 65-2422d will allow SRS staff to request, for purposes of establishing parentage, a copy of a child's birth certificate directly from KDHE. That authority would not extend to children outside the CSE Program. Presently, if the custodial parent is unable to provide a certified copy of the birth certificate, SRS must require the parent to order one from KDHE — at a cost of \$12 to the parent. This may seem like an insignificant expense, but the vast majority of CSE paternity cases involve families currently receiving public assistance — those who can least afford to spend \$12 for a piece of paper. If SRS were able to order the birth certificate directly, it would relieve these families of the expense and allow 66% of the cost to be passed on to the federal government. The State's cost for this additional service to our economically vulnerable families is estimated to be less than \$3,000 per year.

The time lost during the current roundabout process delays completion of the paternity case and the first support payments in the case. SRS estimates the gain in time would allow \$87,000 in additional child support collections each year, of which \$21,000 would be State revenues.

SRS believes the provisions of H.B. 2571 are important to the continued success and improvement of paternity establishment services. I would be glad to respond to any questions you may have.
