Continued working HB-2053 - Premises registration and animal identification and tracking system

Chairman Taddiken advised the Committee that they are now looking at **HB-2053** as amended.

Senator Huelskamp moved that the language on page 1, in line 29, by inserting "fees," before "costs," in line 31, by striking "and" and inserting "or"; in line 36, after "such" by inserting "fees"; also in line 36, by striking "and" and inserting "or"; in line 39, after "such" by inserting "fees; also in line 39, by striking "and" and inserting "or"; in line 41, by striking "and" and inserting ",costs or";

and on page 2, line 2, language be changed after "fees" by inserting "costs or expenses."; in line 3, after "fees" by inserting "costs or expenses"; in line 5, after "for" by inserting "the cost of taking into custody, keeping and selling." The motion was seconded by Senator Francisco, Motion carried.

Senator Huelskamp moved that language be changed on page 3, line 30, before the period, by inserting "to the extent authorized by federal requirements"; line 40 after "provided" by inserting "or acquired"; in line 42, after the period, by inserting "Intentional disclosure of such data or records shall be a class C nonperson misdemeanor." The motion was seconded by Senator Ostmeyer. Motion carried.

Senator Huelskamp moved that the language on page 4, line 21, be changed by inserting "the development of premises registration, animal identification and tracking"; also in line 21 by striking "the program" and inserting "such systems." The motion was seconded by Senator Pine. Motion carried.

Senator Huelskamp requested that the word "obtained" rather than the word "acquired" be used. The motion was seconded by Senator Francisco, Motion carried.

<u>Senator Bruce moved that the bill be passed as amended. The motion was seconded by Senator Pine.</u>
