# MINUTES OF THE SENATE FEDERAL AND STATE AFFAIRS COMMITTEE

The meeting was called to order by Chairman Pete Brungardt at 11:35 a.m. on Thursday, April 28, 2005, in Room 231-N of the Capitol.

Chairman Brungardt called upon William Falstad, nominee as a member of the Kansas Racing and Gaming Commission, to give an opening statement regarding his background and qualifications. Mr. Falstad gave a brief overview of his education and work experience. He stated that his most recent experience as a member of the Kansas Lottery Commission had given him some added insight into the application of past experiences to the challenges that may be presented to him as a member of the Kansas Racing and Gaming Commission. (Attachment 1)

Following brief committee questions, the Chairman expressed the committee's appreciation to Mr. Falstad's attendance and participation in the confirmation hearing.

Senator Hensley made a motion to move to the full Senate the confirmation of William J. Falstad to be a member of the Kansas Racing and Gaming Commission, seconded by Senator Gilstrap, and the motion carried.

Chairman Brungardt opened the hearing on the confirmation of Stephen Martino as Executive Director of the Kansas Racing and Gaming Commission. He stated that the committee had a request by Representative Carl Krehbiel to address the committee regarding the Governor's nominee for the position of Executive Director.

Representative Krehbiel expressed his concerns regarding Mr. Martino's nomination relating to his qualifications, work experience, and political fund raising activities for the Governor's 2002 campaign. He spoke about substantial campaign contributions to the Governor from the gambling industry, and that the nomination of a major solicitor of campaign contributions to the position of overseeing the gambling industry could create an appearance of giving the gambling industry favorable treatment. Representative Krehbiel stated that he did not believe the nomination of Mr. Martino to this position would serve the public interest of the people of Kansas. (Attachment 2)

Senator O'Connor asked what percentage of the campaign funds came from the gaming industry. Representative Krehbiel responded that he did not have a specific number on that because it can be difficult to identify which interests are involved in that industry. He stated that he had heard from an individual who tracked these campaign donations, and he was not going to assert that the information he was given was absolutely correct, but he had been told the owner of the dog track in Wichita, by himself or by entities he controls, contributed \$250,000.

Following committee questions and comments, Chairman Brungardt called upon Stephen Martino to respond to the testimony and questions presented by Representative Krehbiel. Mr. Martino stated that he has never hidden from the fact that he raised money for the Governor, and it is included in his résumé as well as having been addressed at the last confirmation meeting. He explained that he started working for the Governor in February 2000 on a part-time basis while attending Washburn Law School as a full-time

student. Following graduation in December 2001, he assumed the position of Deputy Campaign Manager and Director of Finance. He said in that position he supervised all fund-raising activity for the campaign, and worked closely with then-Commissioner Sebelius to target potential donors. Mr. Martino stated that he left the Sebelius for Governor campaign August 1, 2002, five days before the primary election, and did no fund-raising for the campaign after that date. He briefly explained about his contacts with racing interests, and in fact, were minimal at best. He related two instances when he had contact with racing interests as detailed in his written testimony. He said at events he primarily was a scrivener and recorded what was said to ensure necessary follow-up occurred. (Attachment 3)

Mr. Martino reviewed the campaign finance reports from his tenure with the Governor's campaign, and it showed a total of \$9,000 contributed by racing interests, which he detailed in his written testimony. He said that the \$9,000 was one-third of one percent of all the money raised by the Governor's campaign during his service.

Senator Vratil referred to Representative Krehbiel's written testimony which classified his concerns into two categories; one of which was Mr. Martino's qualifications for the position. Senator Vratil stated that this committee explored his qualifications at the confirmation hearing held on March 30, and asked Mr. Martino if there was anything further that he would like to say to this committee in response to Representative Krehbiel's questions as presented in the last paragraph of the first page of his written testimony.

Mr. Martino responded in regard to the highest position he had obtained; he said at present he was an associate in a law firm. He said that it appeared to him there were four ways the Governor could go in making this type of appointment: (1) she could go out of state to find someone that she believes is qualified; (2) she can nominate someone from inside the state that absolutely has no experience, knowledge, or not having been engaged with anything remotely involved with gaming ever; (3) she could have nominated someone with extensive experience in the racing and gaming industry, and most likely that person would come from inside the industry itself which could cause a different set of problems; or (4) she could nominate someone with a knowledge of the Kansas gaming laws with an understanding of the legislative and public opinion history of gaming in the state. He stated that he felt he was a candidate from the last category. Mr. Martino explained that through the law firm he works for, he has represented a client, who is not regulated by the State of Kansas, but has an interest in monitoring Kansas gaming laws. This legal relationship has allowed him to research state law, court common law, and Attorney General's opinions in regard to gaming. He stated with that background and with substantial knowledge of the history of gaming in Kansas, and these qualities would serve him well should he be confirmed.

Senator Vratil referred to the other concern of Representative Krehbiel's which related to gambling industry contributions, and asked how much money did the gambling industry, the parent and subsidiary companies and suppliers contribute to the Sebelius campaign. Mr. Martino responded that he did not know, but he could say that the Sebelius campaign did receive contributions from several if not all of the Indian tribes that have casinos in the state. He said he could assure the committee that when he was raising money for the Sebelius campaign, gaming and racing contributions were not set out as some kind of separate category where special interest was directed. He stated that the campaign staff was raising a lot of money from a lot of people and from various businesses, attorneys, doctors, etc.; and it was done at 100% compliance of the law. He added that the was not aware of any ethical or legal infraction that was incurred by the Sebelius campaign in the fund raising.

Senator Vratil asked what was Mr. Martino's role in soliciting campaign contributions from the gambling industry. Mr. Martino replied that he could not recall doing anything out of the ordinary as it regards soliciting campaign contributions from gaming or specifically racing entities that wouldn't have been done for any other person, attorney, doctor, etc. Those were probably done on a call list, and it would have been unusual for him to place a personal phone call. He did not recall that happening with any racing entity. Mr. Martino referred to the two occasions in June and July of 2002 which are noted in his written testimony and talked about earlier. He said he was confident he did not personally solicit any funds at either of those events, nor does he remember making any telephone calls to any gambling entities.

Senator Vratil asked for clarification that at those two events he primarily took notes, and Mr. Martino responded that was his primary role.

Senator Gilstrap inquired what kind of management style he would have as Executive Director, and the number of staff he would have in that position. Mr. Martino replied that there are between 43 and 48 full time employees, and that he had managed staff before but not as large as the Racing and Gaming Commission. He said he felt the best way to lead staff was to set clear standards of conduct, encourage and foster open communications between himself and staff, also within the staff itself, and hold everyone accountable for his/her actions and make sure the State of Kansas gets an honest day's work out of everyone. He commented that a lot of the staff had extensive employment history and commitment to the agency, and he hoped that would continue and the people would feel good about the jobs that they do.

Senator O'Connor referred to Mr. Martino's confirmation packet of information, noted his wife works for the State of Kansas, and asked where she worked at the state. Mr. Martino replied that his wife is the Director of Communications and Marketing for the Department of Labor. (Attachment 4)

Committee questions and discussion continued relating to the possibility of having staff research the campaign contributions which are public documents. Mr. Martino stated that it was his understanding that Carol Williams, Executive Director of the Ethics Commission, had given him a "clean bill of political health."

Committee discussion continued regarding the possible research into the campaign contribution records, and it was the consensus of the committee that an investigation would not change what the committee had looked at or heard in previous discussions.

Senator Vratil made a motion to recommend confirmation of Mr. Martino as Executive Director of the Kansas Racing and Gaming Commission to the full Senate. Senator Gilstrap seconded the motion, and the motion carried.

Meeting was adjourned at 12:22 p.m.

# Testimony of Rep Carl Krehbiel in Opposition to the Nomination of Mr. Steve Martino for Executive Director, Kansas Racing and Gaming Commission

Thank you Chairman Brungardt and members of the Committee for giving me the opportunity to express my concerns about the nomination of Mr. Steve Martino for the position of Executive Director of the Kansas Racing and Gaming Commission.

At a time when one or more proposals for a significant expansion of gambling in several forms may be emerging, perhaps even today, I believe that the public interest demands that the person who next takes this position be beyond reproach, with unquestionable qualifications for the position, and a background that would not leave the person holding the position under a cloud of suspicion for his entire tenure. Consequently, I believe that confirming the nomination of Mr. Martino would not be appropriate.

I want to stress that I am not calling into question Mr. Martino's character or his qualities as a human being. I am sure that he is eminently qualified for many positions in the public and the private sectors—just not this one. And I am equally sure that there are many positions for which I am not qualified or suitable, and the same is true of anyone in this room.

But especially at this point in time, it is crucial that the next person to hold this position be unquestionably well qualified, and without baggage from recent activities that could constitute grounds for suspicion. I think this Committee should not just rubber-stamp a nomination, but rather needs to address some hard questions.

First, what are Mr. Martino's qualifications specifically for this position? The Commission oversees an industry of significant size – and indeed, an industry for which the Governor is seeking a major expansion. It is also an industry that many Kansans view as highly controversial. What is there in Mr. Martino's background and work experience that suggests he is qualified? What is the highest-level position he has held? What positions in business or government suggest that he is qualified for this specific position?

Second, Mr. Martino's activities as a prolific fundraiser for the Governor's 2002 campaign raise some crucial questions. How much money did the gambling industry, its parent and subsidiary companies, and its suppliers, contribute to the Sebelius campaign? What was Mr. Martino's role in soliciting campaign contributions from the gambling industry? If Mr. Martino was involved in such solicitations, then there are obvious questions of ethics about placing him in a position to play a major oversight role of an industry from which he solicited campaign contributions.

Third, since the Governor's campaign received substantial campaign contributions from the gambling industry, one must fear that the nomination of a major solicitor of campaign contributions to the position of overseeing the gambling industry suggests the appearance that a message is being sent to the gambling industry that it will receive favorable treatment. Could this be a precursor to major solicitations by a gubernatorial re-election campaign for large contributions from the gambling industry? The nomination of a major solicitor of campaign contributions certainly creates the disturbing appearance that this will be the case.

I am not suggesting that there is anything wrong with raising money legally for political campaigns, and again, I am not calling into question Mr. Martino's qualities as a human being. What I am questioning is the combination of no apparent qualifications for a specific position, a recent background of being a significant "rainmaker" at soliciting a sizeable amount of campaign contributions, and a key position responsible for oversight of an industry that is as controversial, volatile, and such a huge source of campaign contributions as the gambling industry. The result will be like pouring gasoline on an open flame. This is a combination that is most certainly *not* in the public interest.

The people of Kansas need to know that regulation of the gambling industry will be completely above board, above any suspicion, and conducted in a manner that looks out for the public interest, not the interest of politicians and the gambling industry itself. They need to be assured that there will be no cozy relationship between the regulator and the regulated industry. With all of the attention that has been focused on campaign finance in the last few years, the nomination of Mr. Martino clearly calls into question whether the public interest will be upheld in state regulation of the gambling industry.

The "Mission Statement" on the website of the Kansas Racing and Gaming Commission says that "The Kansas Racing and Gaming Commission is dedicated to protect the integrity of these industries through enforcement of Kansas laws and is committed to preserving and instilling public trust and confidence."

That is key – preserving and instilling public trust and confidence. The public can have neither trust nor confidence if this nomination is approved. The question I believe you have the responsibility to ask is: How does the nomination of Mr. Martino for this position serve the public interest of the people of Kansas? I would suggest that it obviously does not.

Dear Senator Brungardt:

I understand during the course of the Senate's confirmation review of my nomination to serve as executive director of the Kansas Racing and Gaming Commission that there have been questions regarding my past fund-raising activities on behalf of certain candidates and specifically for Governor Sebelius. In particular, I have heard that some question my fitness to regulate racing entities when I had previously been involved in raising funds from them. I would like to place these concerns in what I believe is their proper context and hopefully salve any further concern about my ability to serve the state in this capacity.

As my resume reflects and as you noted during my initial confirmation hearing, I have done some fund-raising on behalf of candidates for public office in Kansas. The overwhelming majority of that work was done on behalf of then-Insurance Commissioner Kathleen Sebelius, who I started working for in February 2000 on a part-time basis while I was a full-time student at Washburn University School of Law. Upon my graduation and after her campaign for Governor was launched, I assumed the position of deputy campaign manager and director of finance. In that role, I supervised all fund-raising activity for the campaign and worked most closely with then-Commissioner Sebelius to target potential donors. This campaign was, by most objective standards, widely successful in garnering financial support. However, both my recollection and the public records I have reviewed make clear that money raised from racing interests was not integral to the campaign's fund-raising success. You should also note that I departed the Sebelius for Governor campaign August 1, 2002, five days before the primary election. I did no fund-raising for the campaign after that date.

Specifically, as it relates to my contacts with racing interests, there was nothing unusual or out-of-the-ordinary. In fact, my contact with racing interests was minimal, at best. Like all fund-raising prospects, they would have received invitations to events and solicitation calls from the candidate. I do not remember making telephone calls or having any personal meetings with any racing interests save for two times: 1) I attended a dinner in Kansas City with then-Commissioner Sebelius; Bill Grace, part-owner of the Woodlands; Larry Seckington, who worked for Mr. Grace's company; and John Bottenberg, who is a registered lobbyist for the Woodlands; and 2) I attended a

dinner in Wichita with then-Commissioner Sebelius and Phil Ruffin, owner of the Wichita Greyhound Park. At both of these dinners, I primarily was a scrivener, recording what was said to ensure necessary follow-up occurred. I am confident that I did not solicit anyone directly for money. Furthermore, I have had no contact with any entity regulated by the Racing and Gaming Commission since I left the Sebelius for Governor campaign.

My review of the campaign finance reports from my tenure at the Sebelius for Governor campaign shows a total of \$9,000 contributed from racing interests:

- \$1,000 both from the Woodlands and Bill Grace on Dec. 14, 2001;
- \$2,000 from Phil Ruffin on March 7, 2002;
- \$1,000 from Bill Grace on March 11, 2002;
- \$2,000 each from Ruffin Holdings Inc. and Ruffin Hotel Corp. on July 3, 2002.

This \$9,000 is one-third of 1 percent of all the money raised by the Governor's campaign during my service.

No one — not the Governor, not anyone on her staff, not any legislator, Democrat or Republican, not any lobbyist for any racing or gaming entity — has suggested to me that because of my past campaign activities or because of contributions made to the governor's campaign that I should "take it easy" on any person, group or entity that the Commission would regulate. As you might imagine, such a suggestion is far-fetched and inconsistent with the Governor's values and mine. Simply put, I would not have accepted this nomination had any limits been placed on the exercise of my authority and responsibilities to the state and this agency. Rather, I believe I was nominated specifically because I would cast a fair but skeptical eye toward this industry in an effort to keep its operation beyond reproach. When offering me this nomination, the Governor asked for my best, and I intend to give nothing less in service to the state and her administration.

I hope I have addressed any lingering questions or concerns. Please let me know if any additional information would be helpful.
