MINUTES OF THE HOUSE FINANCIAL INSTITUTIONS COMMITTEE

Representative O'Malley presented the subcommittee report on <u>HB3003-Protection of certain personal information; restricting disclosure or use.</u> He summarized changed sections of the bill as a result of the subcommittee meeting on March 15. Section five of the original bill has been deleted and remaining sections have been reworded and renumbered. He stated that some of the revisions were made to be consistent with language used in other states. He said that this law is not as complicated as it looks and is a good faith attempt to compromise with all interested parties.

Some of the changes are: Skimmer devices would be illegal. No Social Security number would be required on many records unless required by Federal Law. Customer notification in the event of a date breach would be based on Delaware law. Information accounted for in federal law has been deleted. Credit freeze is available for persons with a valid police report of identity theft. Language has been added to be consistent with ALEC.

Following are motions entertained:

Representative O'Malley made a motion to adopt the bill and its balloons, which was seconded by Representative Olson. Motion passed.

Mr. Ron Gaches expressed support for the bill. Mr. Matthew Goddard stated that is a fair bill and a good compromise.

Chairman Cox invited further discussion.

Representative Dillmore made a motion to put back in lines 13-15 on page four. Motion seconded by Representative Hummerickhouse. Motion passed.

Representative Dillmore made a motion to strike the balloon on page 13 and use original language. Motion was seconded by Representative Burroughs.

Matthew Goddard expressed concern that people will use the credit freeze indiscriminately. He stated that this language is consistent with other states and federal law.

Ron Gaches said that the credit freeze should only be available to people who have had their identity stolen. His concern is that someone preparing to file bankruptcy would use the freeze to hide their financial situation from creditors.

Motion failed.

Revisor Bruce Kinzie suggested that on page 16 the word may be changed to shall. Chairman Cox motioned to follow the recommendation of Mr. Kinzie. Motion was seconded by Representative Olson. Motion passed.
