### **Bill Introductions**

Rep. Yonally requested a bill relating to local units of governments and surveys. He said that current law uses the term "competent engineers" and that he is requesting the term be changed to "licensed land surveyors." Rep. Yonally made a motion to introduce the proposed change as a Committee Bill. Rep. Huebert seconded the motion. The motion carried.

Richard Gannon, Kansas Press Association, requested a bill requiring the recording of executive sessions and amending K.S.A. 2003 Supp. 75-4319. Rep. Craft made a motion to introduce the proposed change as a Committee Bill. Rep. Goico seconded the motion. The motion carried.

Rep. Goico requested a bill relating to wood shake shingles and covenants. Rep. Goico made a motion to introduce the proposed legislation as a Committee Bill. Rep. Huebert seconded the motion. The motion carried.

Rep. Holland requested a bill relating to the district reapportionment process. He also requested a bill relating to campaign contributions to candidates for the office of insurance commissioner. Rep. Holland made a motion to introduce the proposed legislation relating to district reapportionment as a Committee Bill. Rep. Storm seconded the motion. Motion Passed. Rep. Holland made a motion to introduce the proposed legislation relating to campaign finance as a Committee Bill. Rep. Melody Miller seconded the motion. The motion carried.

Rep. Beamer requested a bill relating to recreation boards appointed by school districts. <u>Rep. Beamer made a motion to introduce the proposed legislation relating to recreation boards as a Committee Bill. Rep. Holland seconded the motion. Motion Passed.</u>

Sen. Gilstrap testified in support of the bill (<u>Attachment 1</u>). He explained that the 30-day time frame in the current law is problematic for cities where the official city newspaper is published on a weekly basis.

Chairman Vickrey closed the hearing on **SB 164**.

TESTIMONY BEFORE THE HOUSE GOVERNMENTAL

ORGANIZATION AND ELECTIONS

Tuesday, 17 January 2006

Thank you for hearing SB 164 today.

SB 164 deals with publication of quarterly financial statements for first and second class cities.

Publication of quarterly financial statements in the official county newspaper within thirty (30)

days of the end of each quarter is required by law. These financial statements show the

total amount received into each fund and the total amount expended from each fund, and the cash

balances of each fund at the beginning and end of each quarter. These quarterly statements show

the amount of outstanding registered warrants, temporary notes, bonds, and all other obligations

and liabilities of the city. If the official newspaper is a daily paper there is no problem. If,

however, the official newspaper is published weekly problems with timing can arise. To meet

the deadline, submission for publication must be timed just exactly right. For myriad reasons this

often cannot be done, good intentions to the contrary. Changing the law to allow forty-five (45)

days for publication would solve the problem.

Third class cities which publish this same information yearly after December 31 would likewise

be impacted by being allowed the longer period of forty-five (45) days to meet publication

requirements.
