## **HB 2082** Initiative and referendum; extended to counties

Rep. Otto made a motion for the favorable passage of **HB 2082**. Rep. Brunk seconded the motion. Rep. Menghini made a substitute motion to remove the 15 percent requirement for signatures and to replace with a requirement of 25 percent. Rep. Lane seconded the motion. The substitute motion by Rep. Menghini passed. Rep. Brunk made a motion for the favorable passage of **HB 2082** as amended. Rep. Lane seconded the motion. Rep. Menghini made a substitute motion that the governing body shall submit the ordinace or resolution, without alteration, to the vote of the electors of the city or county at the next regular eelction scheduled no sooner than 90 days thereafter.
