After the hearing on February 7, 2007 Chairman Hayzlett asked Don McNeely, President of KS Automobile Dealers Association and Thomas Steele, Tiger Financial Management Services to work together to come up with a resolution on their differences on this bill. Today Mr. McNeely reported back that they had resolved their differences with an amendment to the original bill. The amendment provided that on and after July 1, 2007, only one lien could be taken or accepted for security for an obligation to be secured on a certificate of title; exempt refinancing of a loan from the limitations of the act; and ensure that a second lien will not be perfected upon a motor vehicle title.

Representative Ballard made a motion to accept the amendment to **HB 2373**, seconded by Representative Swanson and the motion carried.

Chairman Hayzlett asked for questions, comments or motions on <u>HB 2373, as amended</u>. <u>Representative Sloan made a motion to favorably pass HB2373, as amended out of Committee, seconded by Representative George and the motion carried.</u>
