# Organization of electoral process in Kansas

One state election office—SOS is chief state election officer

105 county election officers—104 elected county clerks, 4 appointed election commissioners

#### County role—

Conduct official elections

Duties in each election include:

Print & distribute ballots

Designate polling places

Appoint, train, pay poll workers

Tabulate election results, provide information to county canvassers

Report to SOS

County clerks have many other duties

#### SOS role—

Provide state perspective

Interpret laws

Train county election officers

Prescribe ballot forms, other forms used in elections

Complaints, allegations of illegal activity

Work with election officers, local prosecutors, state & federal agencies

State role is greater in election administration under HAVA

## Build calendar

Election day, voter registration deadline, advance voting, federal services (military) ballot distribution, publications, candidate filing deadline

#### Key parts:

Candidate list

Ballot preparation

Voter registration

Canvass & certification

New areas of emphasis under HAVA—

Consistency, uniformity

Training of poll workers

Ballot preparation includes programming machines, providing audio ballots

Accessibility

Physical accessibility of polling places

Accessibility to ballot—adjustable, ADA-compliant machines

Language accessibility—6 Spanish counties
