KS - - Proposed new or amended statutory language

- 1) Purpose: impose requirement on VoIP providers to contribute to KUSF. Amend K.S.A. § 66-2008(a) as follows:
- (a) The commission shall require every telecommunications carrier, telecommunications public utility and wireless telecommunications service provider that provides intrastate telecommunications services, and every VoIP provider as defined by K.S.A. 12-322, to contribute to the KUSF on an equitable and nondiscriminatory basis. Any telecommunications carrier, telecommunications public utility, or wireless telecommunications service provider, or VoIP provider which contributes to the KUSF may collect from customers an amount equal to such carrier's, utility's or provider's contribution, but such carrier, provider or utility may collect a lesser amount from its customer.
