Senator Huelskamp opened committee meeting with <u>SB 519</u>—concerning mail ballot elections; pertaining to mailing of ballots to inactive voters in local question submitted elections conducted by mail ballot; amending K.S.A. 25-433 and repealing existing section.

There were no opponents to SB 519.

Motion was made by Senator Donovan and seconded by Senator Barone to move out favorably as amended SB 519 to become effective when printed in the register.

Brad Bryant stated the names are also put in this order by last name of candidate. Rotation goes with how many candidates there are. The number of precinct in each county are used to determine if rotation is necessary. Each county does there own rotation. The object is to get a balance as close as they can. A fair distribution is the goal.

The state is saying we need this to re-arrange the order if needed to balance the count. The purpose is to allow the candidates name to be at the top as many times as possible.

Senator Huelsamp referred to Bryan Caskey's testimony on February 12 as an example of the distribution process (Attachment 1).

Discussion concluded with no motions.

Senator Huelskamp brings attention to <u>SB 575</u>—An act concerning campaign finances; prohibiting the use of public funds and certain other public assets to influence the nomination or election of a candidate; amending K.S,A, 25-4169a and repealing the existing section.

Senator Donavon moved and Senator Wilson seconded to accept technical amendment 105a and 105b in SB 575..
