MINUTES OF THE SENATE FEDERAL AND STATE AFFAIRS COMMITTEE

The meeting was called to order by Chairman Pete Brungardt at 10:30 a.m. on February 7, 2008 in Room 526-S of the Capitol.

Senator Jim Barnett requested a bill introduction that has to do with radon awareness.

Senator Vratil moved that this request should be introduced as a committee bill. Senator Lynn seconded the motion. The motion carried.

Thomas Groneman, Director, Alcohol Beverage Control Division, provided the committee a brief overview of the Alcoholic Beverage Control Division (ABC). (Attachment 1) The number one priority of the alcoholic Beverage Control Division is to fairly administer and enforce the liquor laws in Kansas to ensure compliance and to maintain a level playing field among all licensees; and as part of the Department of Revenue, is to see that all applicable liquor taxes due and owing are collected. Licenses are issued and renewed on an annual basis; licensing collects gallonage taxes, liquor drink taxes, liquor excise taxes, sales taxes and withholding taxes. 10% of gallonage tax goes to SRS Community Alcoholism and Intoxication Program and the remainder to the state general fund. 70% of Liquor Excise Tax goes to Local Alcoholic Liquor fund, 5% goes to the SRS Community Intoxication Program and 25% to the state general fund.

The ABC administrative unit performs general staff support for the Director and Chief Enforcement Officer and related work such as budget preparation, personnel record keeping, property management, records management, performs background investigations on licensees and coordinates the division's activities. The Enforcement unit provides investigative support for the ABC Director and Chief Enforcement Officer. Enforcement agents are certified law enforcement officers. They conduct criminal and administrative investigations to determine compliance with liquor laws.

The Licensee Administrative Action (LAA) section is staffed by the Assistant Attorney General assigned to the ABC, and reviews the cases presented by the enforcement section and local law enforcement agencies to determine the appropriateness of the charges and administratively prosecutes violations of the liquor laws before the Director or his designee.

Over the years ABC has been assigned other duties, including conducting the compliance checks required under the Synar amendment, where the state must maintain a minimum compliance rate of 80% for sales of cigarettes to minors or risk losing a portion of the block grant monies allocated to SRS under the agreement. In addition, ABC agents are responsible for levying drug tax assessments across the state.

Provided were maps reflecting Kansas on premise licenses, off-premise licenses, cities/counties adopting expanded hours, and cities opting to be dry. Also provided were brochures on the Alcoholic Beverage Control Division and underage cooperating individuals.

Discussion on the wine shipping bill from 2007; there are 39 wineries that signed up to ship into the state.

Discussion was opened on SB 397-Consumption of alcohol at national guard armories.

Senator Vratil moved an amendment to strike "or unknowingly" in KSA 41-2615, because there are two statutes that cover the same offense. Senator Francisco seconded the motion.

The committee heard from ABC that just because a server was not paying attention that they should not be held responsible. The action that is taken is against the licensee, not the server. This is the administrative part of the statutue.

With permission from the second, Senator Vratil withdrew his motion.

Senator Brownlee moved an amendment that the would increase the Class A person misdemeanor with a minimum fine of \$1,000 and six months in jail. Senator Barnett seconded the motion. Senator Barnett with the second requested ABC to provide their view on the amendment. ABC did not agree with the increased penalties. The motion failed.

Senator Vratil moved to amend KSA 41-346 to conform to the picture amendment in both administrative and criminal sections. Senator Reitz seconded the motion. The motion carried.

Will hold the discussion till Staff presents a balloon with all the changes.

The chariman closed the discussion on SB 397-Consumption of alcohol at national guard armories

The meeting was adjourned at 11:50 am. The next scheduled meeting is February 12, 2008.

Briefing on Alcoholic Beverage Control Division to The Senate Committee on Federal and State Affairs

Mr. Chairman, Members of the Committee, it is my pleasure to appear before you today to present a brief overview of the Alcoholic Beverage Control Division (ABC).

The number one priority of the Alcoholic Beverage Control Division is to fairly administer and enforce the liquor laws in Kansas to ensure compliance and to maintain a level playing field among all licensees. Also, as part of the Department of Revenue, it is our duty to see that all applicable liquor taxes due and owing are collected.

The division is divided into three organizational units: licensing, administration and enforcement. Licensing is functionally part of the Customer Relations Bureau within the Division of Tax Operations, but under the authority of the Director of ABC for issues related to liquor licenses.

In 2007, licensing processed in excess of 4,000 renewal and new license applications for retail liquor stores, distributors, manufacturers, farm wineries, microbreweries, on-premise establishments (class "A" clubs, class "B" clubs and Drinking Establishments), caterers, suppliers and temporary permit holders. In addition, licensing handled 34,684 phone calls and assisted 1,833 walk-in customers. Licenses are issued and renewed on an annual basis. Following is a breakdown of licenses by license type for years 2005 through 2008:

The ABC administrative unit performs general staff support for the Director and Chief Enforcement Officer and related work such as budget preparation, personnel record keeping, property management, records management, performs background investigations on licensees and coordinates the divisions activities. ABC has 37 full-time funded positions and 8 temporary positions funded through a KDOT grant (2) and an interagency agreement with SRS for tobacco enforcement activities (currently 6). FY07 and FY08 budgets for the division are as follows:

The Enforcement unit provides investigative support for the ABC Director and Chief Enforcement Officer. Enforcement agents are certified law enforcement officers. They conduct criminal and administrative investigations to determine compliance with liquor laws. Agents provide training to licensees and local law enforcement officers; conduct controlled buy operations and bar checks; investigate complaints and hidden ownerships; and perform routine compliance checks. Enforcement works closely with local, state and federal law enforcement agencies as well as the Division of Taxation in carrying out these activities. Investigations resulting in alleged violations are presented to the County or District Attorney for criminal prosecution against the individual, and/or the ABC Assistant Attorney General (AAG) for administrative action against the licensee.

The Licensee Administrative Action (LAA) section is staffed by the Assistant Attorney General (AAG) assigned to the ABC, a legal assistant and two support staff. The AAG reviews the cases presented by the enforcement section and local law enforcement agencies to determine the appropriateness of the charges and administratively prosecutes violations of the liquor laws before the Director or his designee. The Director and the AAG are responsible for the disposition of all liquor related administrative citations brought forth by the investigative activities of the Enforcement section and other law enforcement agencies. Following are the number of citations issued for FY2006 through FY2008 and the total fines collected for those years:

Over the years the ABC has been assigned other duties, including conducting the compliance checks required under the Synar amendment. Under Synar the state must maintain a minimum compliance rate of 80% for sales of cigarettes to minor's or risk losing a portion of the block grant monies allocated to SRS under the agreement. During FFY2007 ABC agents and Underage Cooperating Individuals (UCI's) performed 580 random buy attempts resulting in 70 sales for a 88.1% compliance rate. This compares to FFY2005 and FFY2006 results as follows:

In addition, ABC agents are responsible for levying drug tax assessments across the state. During FY2007 agents made 433 drug tax assessments totaling \$4,621,953 resulting in collections of \$1,051,508.

During the 2007 session, SB30 was passed exempting charitable organizations and political committees conducting fundraising activities, which included the complimentary service of alcohol, from obtaining a license or temporary permit. Since the law went into effect May 24, 2007, we have seen a small decline in the number of temporary permits issued. There have been no problems encountered or complaints received as a result of the change.

Map showing Kansas on-premise licenses


Map showing Kansas off-premise licenses






Active Kansas Farm Winery and Outlet Licenses
