Chairman Owens opened the meeting by thanking Dr. Stuart Little for providing lunch for the committee.

Chairman Owens called on Ray Dalton to brief the committee on the involvement Disability & Behavioral Health Services (DBHS) has in the DUI process. DBHS includes Addiction and Prevention Services (AAPS) which provides oversight and manages the substance abuse services funded by the federal block grant, Medicaid and the 4th time DUI program known as <u>SB 67</u>. SRS is responsible for the licensing of drug and alcohol treatment facilities and utilizes an electronic system of record management that standardizes the assessment and documents every unit of service a consumer receives. Regional Alcohol and Drug Assessment Center (RADAC) determines the appropriate level of services needed for an individual and then is responsible to ensure that ongoing care coordination and communication occurs with the treatment provider and KDOC staff. Chairman Owens requested a map showing the RADAC regions, where the agency offices are located and which regions each agency covers. Treatment completion rates were explained in regards to the 4th Time DUI Program and the Substance Abuse Prevention and Treatment Block Grant. Mr. Dalton included with his testimony copies of the 4th Time DUI Treatment Locations in Kansas, graphs showing the Department of Correction's 4th Time DUI Clients Admitted or Assessed, and a list of the licensed Alcohol/Drug Facilities in Kansas (Attachment 1). Mr. Dalton stood for questions.

Chairman Owens brought to the attention of the committee a template for House Substitute for SB 214 (Attachment 2). Also furnished to the committee was a copy of an email to Chairman Owens from Legislative Research concerning DL penalties and a hardship license (Attachment 3). He requested each member study the template and bring questions and suggestions to the next meeting of the committee. This template emphasizes more treatment for earlier offenses and less treatment and more punitive measures for each subsequent offense. The Department of Corrections, Sentencing Commission and SRS are researching how this possible bill will impact their individual department. Legislative Research was asked to report to the committee what other states charge on DUI's and information on demographics of a DUI offender.

The next meeting will be Thursday, March 20 at 11:30 a.m. in room 526-S.

The meeting was adjourned at 12:35 p.m.

Chairman Owens and members of the Committee, I am Ray Dalton, Deputy Secretary of Disability and Behavioral Health Services (DBHS) at SRS. The division of DBHS includes Addiction and Prevention Services (AAPS), which provides oversight and manages the substance abuse services funded by the federal block grant, Medicaid and the 4th time DUI program, known as SB 67. SRS and Addiction and Prevention Services is designated by the Substance Abuse Mental Health Administration (SAMHSA) as the single state agency on substance abuse.

The over arching principle that guides all of these functions is one of accountability. SRS is responsible for licensing of drug and alcohol treatment facilities in Kansas. Through licensing standards, Addiction and Prevention Services is able to assure that minimum standards of care are being utilized on behalf of consumers of alcohol and drug programs. These standards cover all aspects of program oversight including counselor competence, programming and curriculum requirements, documentation standards, consumer rights and confidentiality laws. These standards are the foundation by which all treatment facilities, regardless of funding streams, must follow in order to legally operate in Kansas. However, the standards for treatment licensure do not apply to those facilities only providing evaluation and education per KSA 8-1008, otherwise known as the Alcohol and Drug Safety Action Programs (for 1st, 2nd and 3rd time DUI offenders). By law, these programs are certified by the Chief Judge in each Judicial District.

For over 10 years, Addiction and Prevention Services has utilized an electronic system of record management that standardizes the assessment and documents every unit of service a consumer receives which is then tied to provider reimbursement on a fee for service basis. The data collected from this electronic system has afforded SRS the ability to monitor trends, evaluate outcomes and direct new funds to address gaps in services and target populations. This electronic assessment was also built on best practices to ensure that each consumer is evaluated on multiple life dimensions, which then recommends the appropriate level of care for that consumer.

SRS has contracted with Value Options Inc., a managed care company to oversee and manage the block grant and Medicaid funded services. Value Options is responsible to ensure that an adequate network of providers is available across the state and to help AAPS consumers receive the level of care they need.

Addiction and Prevention Services is also responsible for the administration of the 4th time DUI program as established through an Inter-Agency agreement between the Department of Corrections and SRS.

Since 2002, 2,396 offenders have been referred to the program and 69% of those have completed the program successfully. To enter the program, each offender is given a neutral and objective alcohol and drug assessment by the assigned Regional Alcohol and Drug Assessment Center (RADAC) which determines the appropriate level of services needed for that individual. The RADAC is then responsible to ensure that ongoing care

coordination and communication occurs with the treatment provider and the Kansas Department of Corrections staff. This care coordination model effectively supervises a population that tends to be resistant to change, highly transient and often needing more than one service by more than one provider. For example, as an offender begins the recovery process, it may become necessary to transfer that individual to a different treatment provider depending on the services needed at that particular time. The care coordination services provided by the assigned RADAC ensures that this transfer can occur in a timely manner with information following the offender to the new treatment provider. Effective communication is also facilitated by the RADAC between the KDOC staff and the treatment provider (with the involvement of the offender), which ensures that expectations are clearly articulated and followed. Any problems that may arise are resolved more quickly, again with the offender understanding that all the parties are acting on behalf of and in the best interest of the offender. As a result of these efforts, this model has been highly effective in retaining offenders in treatment services, a best practice cited by the National Institute of Drug Abuse as one that predicts successful treatment outcomes.

Treatment Completion Rates

The effectiveness of this program and particularly the addition of the care coordination efforts of the RADAC, is apparent by the following discharge rate comparisons of the 4th time DUI program with the block grant funded program:

4th Time DUI Program discharge rates:

Of the 2396 offenders assessed and referred to treatment since 2002,

- **69% have completed Treatment
- **12% self discharged from treatment
- **3% Treatment not completed, agency decision

979 offenders assessed under this program are still receiving treatment services.

The average length of stay in treatment services for these offenders is 315 days.

Substance Abuse Prevention and Treatment Block Grant discharge rates for SFY 2006

- **38% treatment completed
- **43% self discharged from treatment
- **8% treatment not completed, agency decision

The average length of stay in treatment services for block grant funded clients is 139 days.


To ensure that available funds are expended in the most cost effective manner possible, a \$3,000 cap was set per offender. This reimbursement methodology, coupled with utilization review by the RADAC ensures that each offender is receiving the services he needs in the least restrictive, least expensive treatment service possible. 82% of all offenders assessed are referred to outpatient treatment services which enables the offender to maintain gainful employment while addressing his alcohol dependency.

In closing, SRS is responsible for the oversight and management of the alcohol and drug programs identified in my testimony. Through SB 67 and SB 123 and other initiatives, we have had the opportunity to create and maintain collaborative partnerships with the DOC and the Sentencing Commission to ensure efficiency, effectiveness and accountability as we work to address the needs of this population.












Percent by Race/Ethnicity










Number by Clients Diagnos ed with a Ps ychiatric Problem Prior to Treatment




Percent of Clients Diagnosed with a Psychiatric Problem Prior to Treatment




Department of Correction's DUI Clients Admitted to Addiction and Prevention Service's Programs

1st DUI

- B misdemeanor sentence of mandatory 5 days house arrest, up to 6 months
- Fine: \$1,000; if no injury/property damage, court may, in cts. discretion, reduce to \$500
- Must be evaluated pursuant to K.S.A. 8-1008, presentence alcohol and drug evaluation, cost of assessment assessed against the offender
- If evaluation includes recommendation for treatment, offender sentenced to treatment. If in-patient treatment, and not 5 days, upon completion of in-patient treatment, offender completes remainder of 5 days under house arrest
- If evaluation does not include recommendation for treatment, offender sentenced to 5 days under house arrest

2nd DUI

Attached are two documents from the Chief Counsel's Office at the National Highway Traffic Safety Administration (NHTSA). These were in response to potential legislation over the past few years and they answer the questions concerning DL penalties and a hardship license.

There are two federal programs affected, the Section 164 Repeat Offender Program and the Section 410 Impaired Driving Incentive Program. The 410 Program has two ways for a state to qualify, one is to have an alcohol-related fatality rate of .50 or below (data). Kansas has qualified under this criteria the past two years, but may not in 2008 after a spike in fatalities in 2006. The other way is as a programmatic state, which requires a state to comply with five of eight criteria. Kansas currently does not meet five criteria and cannot qualify as a programmatic state. When we qualify for this program, we receive approximately \$1.5 million per year in funds that have to be used for alcohol programs. The question on DL penalties is answered in the first paragraph under the heading SB 119 in the document titled DL Penalties.

The Section 164 Program has different criteria, and currently Kansas is in compliance. If changes in Kansas law put us out of compliance we are penalized. The penalty would be a transfer of core construction funds to safety or hazard elimination programs. This is money that pays for the large road construction projects. The penalty would be approximately \$8 million per year each year we are out of compliance. Any hardship license that allows someone convicted of a 2nd or subsequent DUI to have a license suspension period of less than one year would put Kansas out of compliance. The document titled Hardship License has the determination of NHTSA legal staff.

As is obvious from the two documents, the suspension criteria is different for each of these programs, we can be in compliance with one and not with the other. The criteria for each program is independent of the criteria for any other program. Whenever potential changes come up that we believe could affect our federal funding, I send it to NHTSA for their official determination. There have been times that we disagreed with their interpretation, but they control the funds, and their determination is the only one that matters.

On February 21, 2007, OCC received a proposed amendment that would remove repeat DUI offenders from the class of habitual violators that would be eligible to receive a restricted license for "motorized bicycles." KAN. STAT. ANN. § 8-235(d), as revised by the proposed amendment. Under such an approach, habitual violators who are repeat DUI offenders would be required to serve the required minimum period of license suspension before having their driving privileges restored. Accordingly, if the amended version of SB 6 were enacted into law without change, it would enable the State to maintain compliance with the license suspension requirement of Section 164.

III. SB 119

Under the administrative license suspension or revocation system criterion, one of the eight programmatic criteria under Section 410, the State must have a system for suspending the license of individuals that operate vehicles under the influence of alcohol as evidenced by BAC test refusals or failures. In accordance with the criterion, the State must administratively suspend the driving privileges of a first offender for a period of 90 days and a second or subsequent offender for a period of one year. A first offender, however, may receive a restricted license after 15 days, and a second or subsequent offender may receive a restricted license after 45 days. In both cases, the restricted license must permit the offender to drive only a motor vehicle equipped with a certified alcohol interlock device and only to and from places of employment, school, an alcohol treatment program or an interlock service facility. Additionally, license suspensions must take place within 30 days of the test refusal or failure.

SB 119 would allow "anyone who served in active [military] service since September 11, 2001" to be eligible to have one traffic infraction dismissed upon proof of service in the armed forces. Traffic infraction would be defined in accordance with the offenses listed in Section 21-3105 of the Kansas Statutes Annotated, which includes by citation the statutory violations listed in Section 8-2118. The statutory violations exempted under this section include "refusal to submit to a preliminary breath test." *Id.* § 8-2118(c). We take this to mean that a qualifying individual, by reason of their service in the military, would be allowed to refuse a breath test without receiving a license suspension. Additionally, this approach would allow individuals who refuse a second breath test to avoid facing the license suspension sanctions associated with multiple test refusals. These exemptions are not allowed under the Federal statute. Accordingly, the enactment of SB 119 into law without change would be inconsistent with meeting the requirements of the administrative license suspension or revocation system criterion of Section 410.

Please note that Kansas qualified as a "low fatality rate State" in FY 2006 and, on that basis, received a Section 410 grant. Because of this, the State was not required to achieve compliance relying on any of the eight programmatic criteria. Should the State not qualify as a low fatality rate State in FY 2007, it will be required to meet four of the eight programmatic criteria in order to receive a Section 410 grant.

This is in response to your request that the Office of Chief Counsel (OCC) review proposed legislation, House Bill (HB) 2089, from the State of Kansas. Specifically, you have requested that OCC determine whether enactment of the legislation would enable Kansas to remain in compliance with the repeat intoxicated driver requirements of 23 USC § 164 and its implementing regulations, 23 CFR Part 1275.

On August 14, 2001, this office determined that legislation signed into law in Kansas complied with all requirements of Section 164. At that time, the agency also accepted the State's compliance certification. More recently, on January 26, 2005, the agency reviewed proposed legislation that would amend the driver's license suspension provisions under State law and provide a hardship license to qualifying repeat offenders.

In accordance with the agency's implementing regulations, 23 CFR Part 1275, to avoid a transfer of highway construction funds under Section 164, a State must have a law that requires, for all repeat intoxicated drivers, a mandatory minimum one-year hard driver's license suspension. (23 USC § 164(a)(5)(A)). Kansas' law currently requires that individuals convicted of a second, third or fourth DUI have their driving privileges suspended for one year. (KAN. STAT. ANN. § 8-1014(a)(2)). After a fifth or subsequent DUI conviction, driving privileges of the offender are revoked permanently. (Id. § (a)(3)). We have previously determined that these provisions comply with the "driver's license suspension" requirement of Section 164.

HB 2089 would add a hardship license provision to the existing DUI law, giving repeat offenders the opportunity to receive a hardship license after they have served 180 days of the license suspension period. The hardship provision would limit the repeat offender's

driving to places of employment, education or treatment care. Because the legislation would allow repeat offenders to serve a license suspension of less than one year, the provision would not comply with the Section 164 requirement. The Federal statute mandates a hard one-year license suspension period with no exception for hardship. Accordingly, we have determined that HB 2089, if enacted into law without change, would not allow Kansas to remain compliant with the "driver's license suspension" requirement of Section 164.
