MINUTES OF THE HOUSE VETERANS, MILITARY AND HOMELAND SECURITY COMMITTEE

The meeting was called to order by Chairman Don Myers at 1:30 p.m. on February 12, 2009, in Room 711 of the Docking State Office Building.

Moved by Representative Seweirt, seconded by Representative Crow for approval of minutes of the House Committee on Veterans, Military and Homeland Security, held February 10, 2009. Motion Carried

The Chairman recognized Jack Fowler, Executive Director of KCVA and indicated he would speak later on behalf of <u>HB 2267 - Requires senate confirmation of KCVA appointees</u>.

The Chairman opened discussion on <u>HB 2171</u> - Veterans; Vietnam war medallion program. <u>Moved by Representative Tafanelli, seconded by Representative Goyle, to amend HB 2171 by striking the reference on Page 2, line 36 - 39, which recommends transferring funds in the "Veterans Cemeteries Federal Construction Grant Fund" to the "Vietnam War Veterans' Recognition Award Fund" since these funds are no longer available. <u>Motion Carried</u></u>

Representative Tafanelli, introduced an amendment to <u>HB 2171</u> to change the title of the "Vietnam War Veterans Recognition Award Fund" to "Vietnam War Era Veterans Recognition Award Fund."

Discussion followed. The point was made that although it is indicated on the DD-214 that a veteran who actually served in Vietnam is marked "in country," it would be difficult to discern those veterans who were part of the support staff, but did not serve "in country." By adding the term "Era" the recognition would be inclusive. The definition of "veteran" was clarified by Representative Goico to mean active duty service of 180 days of those who have served in combat or in support of combat. Representative Goyle reminded the Committee that HB 2171 not only provides recognition of service for Vietnam War Era Veterans, but it also creates a tool for outreach. Representative Seiwert suggested that two medallions be created, one for those who served "in country" and one for others who served as support during the Vietnam War Era. Representative Crow said KCVA should not be put in the position of determining eligibility for this recognition and that those who were not actually in Vietnam also served to train and support those in combat. Representative Meier stated that the Department of Defense has a certificate for those who served during the "Cold War Era."

The chairman recognized Robert Payne who agreed that if the recognition awards were designated as the Vietnam War Era, rather than Vietnam War it would be inclusive and better supported by veterans. (Attachment 1)

Moved by Representative Tafanelli, seconded by Representative Garcia to amend HB 2171 by inserting "Era" after the word "War" where references are made to the Vietnam War Veterans Recognition Award Fund." Motion Carried.

The Chairman requested Representative Tafanelli carry the bill.

The Chairman opened discussion on <u>HB 2267 - Requires senate confirmation of KCVA appointees</u>. Being none, it was <u>Moved by Representative Goyle</u>, seconded by Representative Crow for favorable passage of **HB 2267**. Motion Carried.

The Chairman recognized Jack Fowler, Executive Director of the KCVA (N o written testimony), who favored HB 2267 and said it will have a positive effect on the KCVA and the community.

Being no further discussion, the Chairman appointed Representative Meier to carry the bill.

Representative Meier announced that she has been called to active duty military service and will soon be serving in Balad, Iraq as Command Inspector General with the 304th Sustainment Brigade. She expects to return in January 2010. Chairman Myers congratulated Representative Meier on her willingness to serve.

Chairman Myers announced that February 17 will be the last day for afternoon committees to meet and that the Agent Orange Resolution will be worked after "turn around day." February 17 will be the next meeting. Carmen Alldritt, Department of Vehicles, Department of Revenue, will brief the committee on the success of the REAL ID, a bill introduced by this committee several years ago to improve security for drivers' licenses and identification cards.

The meeting was adjourned at 2:00 p.m..
