Approval of Minutes

Senator Schodorf moved to approve the minutes of March 10, 2009, amending them to show Senator Hensley as excused. The motion was seconded by Senator Teichman. Motion carried on a voice vote.

Continued Hearing on HB 2001 - School districts; number of pupils in USD No. 409, Atchison

The hearing on <u>HB 2001</u> was continued from the meeting of March 9, 2009. J. Russell Jennings, Commissioner, Juvenile Justice Authority, appeared to answer additional questions from the committee. Dale Dennis, Deputy Commissioner, Kansas Department of Education, explained the difference in the source of funding from the Juvenile Justice Authority to becoming the responsibility of USD #409. Previously they were specifically excluded from the School Finance Law and being counted.

The hearing on HB 2001 was closed.

Senator Vratil moved the committee recommend HB 2001 favorable for passage. The motion was seconded by Senator Hensley. Motion carried on a voice vote.

HB 2002 - School finance; military children, determination of enrollment

Senator Teichman moved the committee recommend HB 2002 favorable for passage. The motion was seconded by Senator Owens. No action was taken on the motion.

Senator Vratil offered a substitute motion by moving to adopt an amendment to **HB 2002** making the second count date included in **HB 2002** applicable to all school districts. Motion seconded by Senator Owens. Motion carried on a voice vote.

Senator Vratil moved the committee recommend **HB 2002** as amended favorable for passage. The motion was seconded by Senator Owens. Motion carried on a voice vote.

Senator Wagle offered a substitute motion to table **HB 2002**. Motion seconded by Senator Huelskamp. The motion failed with five 'yes' votes and five 'no' votes.
