The Chairman opened the hearing on <u>SB 5 - Designating part of U.S. 160 as the 1011th Quartermaster Co. U.S. Army Reserve memorial highway.</u>

Chairman Umbarger recognized Senator Derek Schmidt who introduced Bill Wullenschneider, retired Sergeant First Class with the Army Reserve, 1011th Quartermaster Co. U.S. Army. Appearing as a proponent, his main reason for wanting a memorial highway named after the 1011th Quartermaster Company, is simply that the former and current members deserve it. The 1011th was activated and served in the Vietnam Conflict, Operation Desert Shield/Desert Storm, and Operation Iraqi Freedom, one of just a few units to do so. Mr. Wullenschneider provided six local letters of support, noted that the funding responsibilities are known, and that this highway designation is a way of recognizing our veterans' contributions (Attachment 1).

There being no other conferees, the hearing on <u>SB 5</u> was closed.

Senator Umbarger indicated that he would like to work the bill today. Senator Petersen inquired if it would be possible to put this on the consent calendar. <u>Senator Donovan moved</u>, <u>Senator Kultala seconded</u>, to recommend **SB** 5 favorably for passage and be placed on the consent calendar. Motion carried.

The Chairman opened the hearing on SB 59 - Primary seat belt law, penalty.

Terry Heidner, Legislative Liaison, speaking on behalf of Deb Miller, Secretary of Transportation, State of Kansas, testified in support of the bill. The proposed legislation will make the law a primary law, cover all occupants in the vehicle, not just the front seat, and increase the fine from \$30 to \$60. The passage of this law will save lives and, if in place by June 30, 2009, Kansas will be eligible to receive an additional \$11.2 million under the current federal transportation program, SAFETEA-LU. Mr. Heidner requested a minor amendment on the last line of the bill, that the law would be in force after it's published in the Kansas Register (Attachment 2).

Secretary Bremby, representing the Kansas Department of Health & Environment, presented testimony in favor of <u>SB 59</u>. According to the National Highway Transportation Safety Administration (NHTSA), safety belt use is the single most effective counter measure available to passenger vehicle occupants in preventing fatalities and injuries in traffic crashes. Passing a primary law in Kansas would result in a 10% increase in

the state's seat belt usage rate, approximately 30 fewer deaths, and 300 fewer serious injuries on Kansas roads. The medical bills of unbelted crash victims are 50% higher than belted victims and society bears 74% of the cost through increased insurance premiums, taxes, and health care costs (Attachment 3).

Colonel Terry Maple appeared on behalf of the Kansas Highway Patrol (KHP) as a proponent of <u>SB 59</u>. This is a public safety issue and this bill will undoubtedly save lives. The KHP will actively support compliance by diligently enforcing the law (<u>Attachment 4</u>).

Kathy Porter, representing the Judicial Administration, State of Kansas, requested that the committee consider adding the statutory docket fee for safety belt violations (<u>Attachment 5</u>).

James Hanni, Executive Vice President, AAA of Kansas, spoke in support of the bill. The national average of seat belt use is 83%. Kansas's rate is 77.4% which ranks 44th among the 50 states. The average usage rate of states with a standard seat belt law is 88%. Standard seat belt laws have a proven track record of increasing a State's seat belt use rate (<u>Attachment 6</u>).

Darlene Whitlock, on behalf of the Kansas State Nurses Association and the Kansas Emergency Nurses Association, presented testimony in favor of <u>SB 59</u>. Their primary goal for support of this bill is that preventing injuries is better than the best trauma care that they can deliver (<u>Attachment 7</u>).

Ed Klumpp, representing the Kansas Association of Chiefs of Police and Kansas Peace Officers Association as a proponent, testified on the bill. Unrestrained vehicle occupants are thrown about inside the passenger compartment striking other occupants. The result is many cases of serious injuries and deaths to a restrained occupant being struck by an unrestrained occupant of the vehicle in a collision. Restraints also secure the driver so they have increased vehicle control. The bill addresses this problem (Attachment 8).

Testimony in Support of Senate Bill 5 Presented to the Senate Transportation Committee By Bill Wullenschneider

January 29, 2009

Mr. Chairman and members of the Senate Transportation Committee:

I'm Bill Wullenschneider and I want to thank you for allowing me to present my reasons for wanting a Memorial Highway named for the 1011th Quartermaster Company, United States Army Reserve.

The first reason is simply that the current and former members of the unit deserve it. The 1011th was activated and served in the Vietnam Conflict, Operation Desert Shield/Desert Storm and Operation Iraqi Freedom. The 1011th was one of just a few units to do so. The 1011th distinguished itself in all three deployments, supporting units of the Royal Thai Army from Camp Bearcat South Vietnam where the unit lost two members killed in action, to Saudi Arabia and Operation Desert Storm where the unit supported Coalition Forces from several base camps and Locations in Saudi Arabia, to Operation Iraqi Freedom where the unit supported Camp Anaconda/Balad Air Base with rations, purified water, fuel, and repair parts and where one member lost a leg.

The next reason is very personal. I'm very ashamed that I was shipped home and left around a hundred and twenty of the members of the 1011th in Iraq while I finished my tour at Fort Riley. I have been awarded three Army Commendation Medals and one Army Achievement Medal and several other lesser commendations and awards in my thirty-four year career, but my failure in Iraq is what dominates the memories of my career. There is a scene in the movie "Lawrence of Arabia" where Anthony Quinn's character is looking for "something honorable" to take back to his village. I'm hoping that this will be my "something honorable" and with my continued VA counseling I can put some "demons" to rest.

I call this request "feel good" legislation, the letters of support have been obtained and the funding responsibilities are known, this is one of the win-win scenarios we hear of. The Legislature is able to have a bill supporting veterans in a time of tight budgets and the veterans get a memorial.

I have been asking my elected representatives for a better Veterans Preference Bill for the past three years and there is always something more important than veterans. The first year it was the tax break for industrial machinery, then it was school finance, then it was disaster relief and now it is budget, always something more important than veterans.

The first outside agency to respond to the Southeast Kansas floods was the Kansas Army National Guard, some of them already veterans of Iraq, and they stayed in tents and ate MRE's, not motels and restaurants. This highway designation is just a little way of recognizing veterans' contributions to our great state and our great nation.

Again thank you for this opportunity to speak to you.

TESTIMONY BEFORE THE SENATE TRANSPORTATION COMMITTEE

REGARDING SENATE BILL 59 RELATING TO A PRIMARY SEAT BELT LAW

January 29, 2009

Mr. Chairman and Committee Members:

I am here to provide testimony in support of Senate Bill 59, a primary seat belt law. This proposed legislation will do three things (1) makes the law a primary law, (2) covers all occupants in the vehicle not just the front seat and (3) increases the fine from \$30 to \$60.

Simply put, seat belts save lives and prevent injuries; and having a primary seat belt law is the best way to ensure more Kansans will wear their seat belts. With this law in place, we can project that approximately 30 lives would be saved and there would be 300 fewer people with serious injuries each year in Kansas.

While the potential to save lives is a compelling argument, it's not the sole reason to support this bill. The passage of SB 59 would make Kansas eligible to receive an additional \$11.2 million under the current federal transportation program, SAFETEA-LU. While one million of these funds must be spent on safety programs, the remaining 10 million can be spent in a variety of ways including highway construction improvements. These additional dollars would be very advantageous to our state especially this year when budgets are so tightly stretched. To receive these funds, the law must be in full-effect by June 30, 2009.

Currently, Kansas seat belt usage rate is about 75 percent, which is considerably lower than the 87-percent average rate of states with primary seat belt laws. This is significant considering that two-thirds of traffic fatalities in Kansas are from people not wearing their seat belts. Also, when seat belts are worn the risk of injuries is reduced by 50 percent. Based on the experiences of other states, we can project Kansas to see an increase in seat-belt usage of about 10 percent following the passage of this bill, which would result in about 30 lives saved and 300 fewer serious injuries each year.

Finally, the Driving Force, a task force created by the Governor to study ways to reduce traffic fatalities and injuries, has recommended the passage of a primary seat belt law. Based on months of studies and discussions, the Driving Force concluded that a primary seat belt law is a critical tool for saving lives and preventing injuries on our highway system. I completely agree.

Testimony on Senate Bill 59 Primary Seatbelt Law

Presented to Committee on Transportation

Chairman Umbarger and members of the Committee on Transportation, I am Roderick Bremby, Secretary of the Kansas Department of Health and Environment. I am pleased to present testimony today in support of SB59, which proposes a primary seat belt law for Kansas. This legislation will cover all occupants in the vehicle, not just the front seat, and will increase the fine from \$30 to \$60.

According to Former Transportation Secretary Norman Mineta, "We are in the midst of a national epidemic. If this many people were to die from any one disease in a single year, Americans would demand a vaccine. The irony is we already have the best vaccine available to reduce the death toll on our highways – safety belts."

In 2007, an average of 112 people died each day in motor vehicle crashes in the United States — one every 13 minutes. Additionally a crash that results in injury occurs every 10 seconds and a crash causing property damage occurs every 7 seconds. Non-use of safety belts in these crashes cause needless deaths and injuries costing society an estimated \$26 billion annually in medical care, lost productivity and other injury related costs. The medical bills of unbelted crash victims are 50% higher than belted victims and society bears 74% of the cost through increased insurance premiums, taxes, and health care costs. On a state level, the annual economic cost of motor vehicle crashes in Kansas is \$1.884 billion.

According to research data provided by the National Highway Transportation Safety Administration (NHTSA), safety belt use is the single most effective countermeasure available to passenger vehicle occupants in preventing fatalities and injuries in traffic crashes. And, states with a primary safety belt law have higher usage rates resulting in lower fatality rates.

Because of the proven benefits of primary enforcement, 26 states (as of December 2007) have upgraded from a secondary to a primary law. According to NHTSA:

Passing a primary law in Kansas would result in:






In addition, the passage of SB 59 would result in substantial progress toward meeting Healthy People 2010 goals to increase seat belt usage and to reduce death rates due to motor vehicle crashes. Healthy People 2010 provides a framework for prevention for the Nation. It is a statement of national health objectives designed to identify the most significant preventable threats to health and to establish national goals to reduce these threats.

We know that it takes strong laws, education and enforcement working hand-in-hand to address the fatalities and injuries happening on Kansas roadways. We are here today to show our commitment to working together through education and enforcement and ask that you help by passing SB 59 which will send a message to motorists that safety belt use is an important issue being taken seriosuly in Kansas.

Thank you for your consideration of this important public health issue. A vote for SB59 is your chance at saving a life in your district. I will be pleased to stand for questions.

Testimony on Senate Bill 59 Senate Transportation Committee

Presented by Colonel Terry L. Maple Kansas Highway Patrol

Good morning Mr. Chairman and members of the committee. My name is Terry Maple and I appreciate the opportunity to appear before you today regarding Senate Bill 59. This bill would require all vehicle occupants, not subject to the provisions of the Child Passenger Safety Act, to wear a seatbelt. It would also make failure to do so a primary violation.

K.S.A. 74-2105 establishes the principal function of the Kansas Highway Patrol as the enforcement of traffic and other laws of this state relating to highways, vehicles and drivers of vehicles. Consistent with this mandate is the Agency's Mission and Goals which state in part, that the "Patrol will promote the use of child restraints and safety belts through aggressive enforcement" and we will "reduce the number and severity of traffic crashes through the enforcement of impaired driving and occupant protection laws."

It is not my intent to inundate you with statistical data regarding the number of lives that will be saved or injuries reduced because of a primary seat belt law. The research in this regard speaks for itself.

I would, however, like to address two prevailing schools of thought regarding opposition to a primary seat belt law. First, some say such a law would give law enforcement officers a legal excuse to make what would otherwise be an illegal stop. The simple fact is this. As in any other career field, there are those who would abuse their authority in law enforcement. Illegal conduct on the part of these officers is unimpeded by the existence of a primary or secondary seat belt. They will find a way to perpetrate their wrong-doing. Second, many think the decision to wear a seat belt is a personal choice and should be made absent intrusion on the part of the government. Unfortunately, when an unrestrained vehicle occupant is killed in an automobile crash, many people are affected. Family members, teachers, mental health professionals, social services and others must deal with grieving children and spouses. Insurance premiums and medical costs are influenced by traffic fatalities at a cost to all consumers.

The Kansas Highway Patrol supports this bill because it will undoubtedly save lives. How many lives, five, ten, fifteen? One life needlessly lost is one too many, especially when the opportunity exists to save it.

I encourage you to vote in support of Senate Bill 59 and its life-saving measures. I would be happy to address any questions or provide follow-up information should the committee deem necessary.

Testimony Requesting an Amendment to SB 59

Thursday, January 28, 2009

Among other provisions, SB 59 would increase from \$30 to \$60 the amount of the fine imposed for those persons who commit the safety belt violations specified in K.S.A. 2008 Supp. 8-2503. However, K.S.A. 2008 Supp. 8-2504 specifies that the fine shall include court costs. "Court costs" are the docket fee, and no other court costs are imposed.

K.S.A. 2008 Supp. 28-172a sets the amount of the docket fee at \$75.

Passenger restraint violations are the only traffic infractions for which a docket fee is not charged. While this does not present great difficulties in administering the law, imposing a docket fee in these cases would make traffic infractions uniform and would simplify matters to some extent.

I would request that the committee consider adding the statutory docket fee for safety belt violations. If so, and if the committee desires, a more modest fine could be considered.

TESTIMONY, SB 59

Presented by James R. Hanni, Executive Vice President, AAA Kansas January 29, 2008 Senate Transportation Committee

AAA supports SB 59 which would make Kansas the 27th standard seat belt enforcement state. Since wearing a seat belt is indisputably the most effective safety measure anyone traveling in a motor vehicle can take, there is no reason why we should not enforce our seat belt law the same way we enforce any of our other traffic laws we have: with standard enforcement.

Why enact a standard seat belt law in Kansas?

- The national average of seat belt use is 83%. Kansas's rate is 77.4%, which ranks 44th among states. The average usage rate of states with a standard seat belt law is 88%. Standard seat belt laws have a proven track record of increasing a State's seat belt use rate.
- The National Highway Traffic Safety Administration (NHTSA) estimates that if Kansas were
 to pass a primary seat belt law, belt usage could rise by approximately ten percent.
 Considerable research has shown that upgrading from a secondary to a standard seat belt law
 will significantly raise seat belt use rates when combined with education and enforcement,
 and those States that have also adopted high-visibility enforcement campaigns have achieved
 increases of 20 percentage points or more.
- According to NHTSA, passing a standard law can increase seat belt use rates among non-users by 40%. The Federal Government also reimburses a portion of States' Medicaid expenditures, typically rates of between 50 and 75%. Accounting for this reimbursement, millions of dollars could be saved in Kansas from year to year. A March, 2007 NHTSA study of potential ten-year savings in four states, including neighbors Colorado and Arkansas, showed those two states could save over \$19 million and \$11 million, respectively, on their annual state budgets in medical costs alone by implementing a standard seat belt law.
- Each year, Kansas would save about 30 lives, over 300 serious injuries and \$79 million in economic costs.
- Traffic crashes cost the Nation about \$230 billion each year in medical expense, lost productivity, property damage, and related costs.
 - > Kansans incur about \$1.9 billion of these costs each year.
 - > That is \$701 for every Kansas resident, each year.
 - About 74 percent of that cost is paid by citizens not involved in the crashes.
- Crashes cost employers about \$313 million annually in the State, and about \$250 per employee.
- The Safety Belt Performance Grants in Section 406 of SAFETEA-LU would *provide the State about \$11.2 million if it enacts standard safety belt language into our present law.*
- About 23 percent of Kansas' population over 627,000 people is still not buckling up.

How many people who died in car crashes weren't wearing their seat belts?

- In 2007, 330 people died while riding in cars and light trucks in Kansas. Of these, 58 percent,, or 191 of them, died while not wearing their safety belts compared to 54 percent nationwide. (2007 FARS Data).
- About 78 percent of the State's traffic deaths occur in rural areas, and the fatality rate per 100 million vehicle miles traveled is over four times higher in rural Kansas than in urban communities. (2006 FARS Data)
- In 2007, 69 percent of nighttime fatalities in Kansas were unrestrained compared to 48 percent of daytime fatalities. (2007 FARS Data)
- In Kansas, a much larger percentage of pickup truck fatalities (82%) are <u>um</u> restrained compared to passenger car fatalities (48%).

Does a standard seat belt law precipitate racial profiling?

No, research disputes the belief held by some that standard seat belt laws may contribute to the harassment of African Americans. According to the *American Journal of Preventive Medicine*, studies of states that changed from a secondary to a standard law found either no difference in the rate of white versus nonwhite ticketing or they found a greater increase in the proportion of whites ticketed after the enactment of a standard law.

According to research by the Air Bag & Seat Belt Safety Campaign and the National Black Caucus of Legislators, less than one-half of one percent of all African Americans report racerelated harassment problems as a result of the seat belt law in their state. Nine percent of African Americans in standard seat belt states report experiencing problems of any kind related to the seat belt law, while 13 percent of African Americans who live in secondary states report experiencing a problem. Of those who report experiencing problems, only one half of one percent report racerelated problems, the other "problems" mentioned were – specifically – being required to wear a seat belt or being ticketed for not wearing a seat belt. The study also found that African Americans living in states with an enforceable seat belt law favor the law 3-to-1. And when asked if they experienced problems with a primary seat belt law, nine out of ten said they had "almost no problems at all."

Does a standard seat belt law infringe on a citizen's personal rights?

No, actually it is an imposition on others' rights when society is forced to pay more money for the health costs of people who are unrestrained.

Driving on the public roadways is a privilege. Therefore, enforcing the safety belt law in the same manner as other traffic laws does not infringe on a motorist's liberty. When we share the public roadways and we expect the assistance of police and other emergency responders, we should be able to have the expectation of each other that we have each taken that simplest and most effective precaution: buckling-up. On behalf of AAA's 250,000 Kansas motorist-members, I urge your support of SB 59.

Senate Transportation Committee Members:

My name is Darlene Whitlock. I am an Acute Care Nurse Practitioner. I am here today speaking in support of Senate Bill 59, the Standard Enforcement Seat Belt bill. I am here as a representative of the Kansas State Nurses Association (KSNA) and the Kansas Emergency Nurses Association (KENA). I have been an Emergency Department (ED) nurse for more than 30 years.

I am currently employed in Trauma Services by Stormont-Vail Health Care here in Topeka. I have also worked in 7 other hospitals in Kansas. In Emergency Departments all around the state, nurses see death and severe injury from motor vehicle crashes. Even if the injuries are not life threatening, they are painful, physically limiting and financially burdensome. KSNA and KENA believe that evidence shows, wearing a seatbelt could reduce these negative outcomes. I believe that your support could prevent injury much more effectively than hospital personnel and physicians are able to treat it after it occurs.

As the co-chair of KDOT's Driving Force a couple of years ago, the science supporting primary seatbelt legislation as a method of decreasing roadway deaths was presented to us. This diverse group identified primary seatbelt legislation as one of our lifesaving priorities. I know that many members of the legislative community share that view and seatbelt legislation was improved for teenagers. This is simply a public health issue that needs urgent attention to improve legislation for the rest of the population.

I would also mention that the American College of Emergency Physicians and the national Emergency Nurses Association are both supportive of this type of legislation as a method of decreasing motor vehicle fatalities. They have asked their members nationwide to actively support efforts in their states. A unique concern for rural states is that research has shown rural residents have a higher mortality from motor vehicle crashes than urban residents.

In this time of critical financial concerns, this legislation could have a monetary impact on health care expenses. Fewer severe injuries would result in lower health care costs. At one time there were federal incentives for these types of safety initiatives. It would be unfortunate not to benefit from these incentives if they are still available.

As nurses who have stood at the bedside with grieving families, our primary goal for support of this bill is clear, we believe preventing injuries is better than the best trauma care we can ever deliver. We will appreciate your assistance in saving lives.

Testimony to the Senate Transportation Committee In Support of SB 59 Primary Seat Belt Law

January 29, 2009

Chairman Umbarger and committee members,

The Kansas Association of Chiefs of Police and the Kansas Peace Officers Association supports the provisions of SB 59. It is time for Kansas to join the majority of other states in establishing a primary seat belt law.

There are many reasons to support this bill. First, it will save lives. Data clearly shows that an increased rate of seat belt use reduces fatalities and injury severity. This preserves families, preserves the family support, and reduces enormous medical costs resulting from unnecessary injury severity. The cost to Kansans resulting from these needlessly lost lives and lost physical capacity is substantial. These losses are not only financial, but also emotional and many times strips families of their earning abilities.

The answer lies with our will to assure a simple safety device is used. The benefits of seat restraints even go beyond the safety of the person wearing the restraint. Unrestrained vehicle occupants are thrown about inside the passenger compartment striking other occupants. There are many documented cases of serious injuries and deaths to a restrained occupant being struck by an unrestrained occupant of the vehicle in a collision. This bill addresses this problem.

Restraints also secure the driver so they have increased vehicle control capability during evasive maneuvers or while attempting to control the vehicle during recovery from leaving the road or other similar event. This additional vehicle control produces an increased opportunity to keep or regain control of the vehicle, potentially preventing a collision from occurring. One of my many experiences during my 35 year law enforcement career was serving as our department's lead emergency vehicle operator instructor. In our course we demonstrated to every officer we trained how being unrestrained during an evasive maneuver created a situation where the driver uses the controls as a handle to stay in their seating position and the loss of ability to use the controls to maintain or regain vehicle control on the roadway.

Another experience of my law enforcement career was supervising the accident investigation unit of our department. Countless times I saw firsthand the death and injury that could have been avoided with the use of seat belts. For example, I can recall a young woman in her mid 20's who was thrown from a vehicle she was a passenger in seconds before I drove up on the scene. I found her laying in the median of I-70 gasping for air which her injuries denied her from achieving. The male driver was lying on the shoulder of the interstate and also succumbed to his injuries within minutes. And I recall speaking with their families and seeing the pain they suffered which was completely avoidable. The vehicle passenger compartment was primarily intact and it was clear they would both have survived had they

vehicle when the driver lost control on a city street in Topeka and struck a tree. As this vehicle slid sideways into and over the curb, this young woman was partially ejected from the vehicle just prior to impact with the tree resulting in her head being crushed between the vehicle and the tree. Imagine the parents' distress not only in the loss of their child but the inability to see their daughter's face again.

Clearly Kansas has done a spectacular job at educating and encouraging people to use their seat restraints. But data shows we have achieved about all we can with those programs. The next step in this lifesaving endeavor is to reach the 25% who just don't get it. This can only be accomplished through aggressive primary enforcement of this law coupled with a meaningful fine. This bill addresses both of those needs.

If that isn't enough, in this time of great economic stress coupled with a great need for highway maintenance and improvement, this bill will produce an opportunity for Kansas to receive substantial federal highway grant funds that otherwise will not be available.

We urge you to support reduced death and injury on our highways and to support reduced suffering by the victims of these tragedies and suffering of their families by supporting this bill. Doing so is good for Kansas, good for families, good for public safety, and good for our economy.

Testimony Presented to the Senate Committee on Transportation Senate Bill 59

Safe Kids Kansas, a nonprofit coalition of 67 statewide organizations and businesses is dedicated to preventing accidental injuries to Kansas children ages 0-14. Safe Kids Kansas is pleased to support SB 59, which promotes seat belt use in our state by making enforcement of the law standard – just like every other traffic safety law.

Adult Seat Belt Use Will Increase – Standard seat belt use laws have been shown to increase seat belt use. Primary enforcement sends a clear message to motorists that the state considers belt use necessary for their safety.

When Adults Buckle Up, Children Buckle Up - The National Transportation Safety Board found that when adults buckle up, child passengers are buckled up 87% of the time, but when adults are not buckled, child passengers are buckled up only 24% of the time. When Louisiana adopted its primary enforcement law, child restraint use jumped from 45 to 82%, even though the state's child passenger safety law did not change.

An unbelted adult becomes a flying projectile in a crash. What child stands a chance against an adult hurled into them at an enormous force – even if the child is restrained. If parents are not belted in and are seriously hurt, who will care for their children? Or worse yet, who will raise them if they survive and their parent does not?

Money – Needless deaths and injuries that result from non-use of belts and child safety seats cost Kansas approximately \$1.844 Billion annually - a Kansas crash tax of \$693 for every Kansan. Unbelted crash victims have medical bills 50% higher than belted victims - and we all bear 74% of these costs through increased insurance premiums, taxes, and health care costs. In addition, Kansas would receive a substantial incentive from the Federal Government if a primary enforcement law is enacted.

Dear Senator Umbarger and members of the Transportation Committee

In the Richardson & Houston, 2006 study, "Safety Belt Use and the Switch to Primary Enforcement", evaluated seatbelt use in 47 states and the District of Columbia from 1991 to 2003. They found that states could increase belt use by 10 percent and improve public safety considerably by upgrading to standard enforcement of seat belt laws, perhaps reducing the nation's 42,000 traffic deaths each year. Their data shows that seatbelt use increased when states upgraded to standard enforcement laws, resulting in lives saved.

Alabama, Alaska, California, Connecticut, Delaware, District of Columbia, Georgia, Hawaii, Illinois, Indiana, Iowa, Kentucky, Louisiana, Maine, Maryland, Michigan, Mississippi, New Jersey, New Mexico, New York, North Carolina, Oklahoma, Oregon, South Carolina, Tennessee, Texas, and Washington now have standard enforcement of their seat belt laws and are eligible for federal funding through the SAFETEA-LU grants. Kansas needs federal support to carry out highway safety programs.

States that started the study with secondary enforcement laws and then upgraded to standard enforcement laws experienced the greatest average increase in belt use. States that had standard enforcement laws throughout the study saw seatbelt use increase from 68.4 to 86.1 percent, whereas states that upgraded saw an increase from 55.5 to 82.7 per cent. Upgrading to a primary enforcement provision had significant positive implications for traffic safety. On average, states that made this upgrade experienced an increase in belt use of about 10 percentage points (Houston & Richardson, 2006).

In Kansas, children..... even if not injuredface the loss of a parent or loved one simply because the occupants in a crash were not buckled up. In 2008, there were 384 deaths of occupants – of those 61.5% were unrestrained (KDOT, 2008). Please take a look at the Kansas crash summary that provides a glimpse into how many loved ones were lost this past year.

Children's Mercy Hospitals and Clinics support SB59 to upgrade the Kansas seat belt law to a standard enforcement of seat belt use of all occupants, regardless of age or seating position in the vehicle.

 Vehicle 1 then entered east ditch, traveling north in ditch, when V1 struck field entrance with culvert. Vehicle 1 then vaulted across entrance, landing on it's wheels on the other side, bursting into flames. Safety restraint was not used.
- Driver of vehicle 1, male age 21
- Occupant of vehicle 1, female age 22 died on 2/28/08 in Doniphan Co as a result of vehicle 1 southbound on street at a high rate of speed. Driver lost control of the vehicle and drove off the west shoulder. Vehicle went sideways, turned on the passenger's side and struck a tree. Safety restraints were not used.
- Driver of vehicle 1, male age 37 died on 2/28/08 in Leavenworth Co as a result of vehicle 2 (semi) eastbound on highway in the number 2 lane and vehicle 2 northbound on street. Vehicle 1 failed to yield to the right of way to vehicle 2. Vehicle 2 struck vehicle 1 in the driver's side. Safety restraint was not used.
- Driver of vehicle 2 (semi), male age 74 died on 2/27/08 in Haskell Co as a result of vehicle 1 (semi) making a U-turn on highway at the intersection. Vehicle 2 was southbound behind vehicle 1 and struck the trailer of vehicle 1 on the driver's side rear. Vehicle 2 entered southwest corner of intersection and rolled onto the driver's side. Safety restraint was used.
- Driver of vehicle 1, male age 21 died on 2/26/08 in Sedgwick Co as a result of driver northbound on street, lost control and hit curb with rear passenger tire, causing vehicle to overturn.
- Driver of vehicle 1, male age 89 died on 2/26/08 in Seward Co as a result of vehicle 1 southbound on highway, when for unknown reasons it drifted off the road to the west, going thru pastures and ended up in a ravine.
- Driver of vehicle 1, female age 47 died on 2/23/08 in Butler Co as a result of vehicle 1 traveling southbound on highway when the vehicle lost control and crossed over into the northbound lane of highway. Vehicle 2 was traveling northbound and was not able to stop before striking vehicle 1.
- Occupant of vehicle 1, female age 18 died on 2/23/08 in Butler Co as a result of vehicle 1 southbound on road covered with heavy snow and slush. Vehicle 2 struck vehicle 1 in the passenger side.
- Driver of vehicle 1, male age 63 died on 2/23/08 in Sedgwick Co as a result of vehicle 1 southbound on street
 when he lost control of the vehicle as he entered the bridge striking the east guard rail head-on causing the
 vehicle to roll over ejecting driver from the vehicle. Safety restraint was not used.
- Driver of vehicle 1, female age 32 died on 2/23/08 in Allen Co as a result of vehicle 1 eastbound on highway.
 driver lost control and entered the east ditch. vehicle rolled mutiptle times (approximately 4) coming to rest on it's top facing east. Driver was ejected. Safety restraint was not used.
- Driver of vehicle 1, female age 32 died on 2/23/08 in Allen Co as a result of vehicle westbound on highway. Driver lost control and entered the north ditch. Vehicle rolled multiple time (approx 4) coming to rest on it's top facing north. Driver was ejected. Safety restraint was not used.
- Driver of vehicle 1, male age 21 died on 2/23/08 in Republic Co as a result of vehicle 1 westbound on gravel road when the driver lost control. Vehicle 1 went into the north ditch, struck a power pole, overturned, ejecting both occupants. Vehicle 1 came to rest on its wheels in the roadway. Safety restraint was not used.
- Driver of vehicle 1, male age 19
- Occupant 2 of vehicle 1, male age 18 died on 2/23/08 in Jefferson Co as a result of vehicle 1 eastbound on highway. For an unknown reason vehicle left the roadway and folled. Vehicle struck a utility pole and came to rest on all four tires facing southwest. Safety restraint was not used.
- Driver of vehicle 1, male age 24 died on 2/21/08 in Harvey Co as a result of vehicle 1 found in the west ditch on the road. Driver 1 was located on the outside of vehicle 1 on the passenger side. Safety restraint was not used.
- Driver of vehicle 1, male age 21 died on 2/20/08 in Nemaha Co as a result of vehicle 1 westbound lost control, veering southwestbound into, then p0ast the oncoming lane into embankment.
- Driver of vehicle 1, male age 24

- Occupant 2 of vehicle 1, female age 27 died on 2/20/08 in Osage Co as a result of vehicle 1southbound on road.
 Vehicle went off the roadway and rolled numerous times. Driver had to be extracated from vehicle, and passenger was partially ejected. Safety restraints were not used.
- Driver of vehicle 1, female age 59 died on 2/12/08 in Douglas Co as a result of vehicle 1 southbound on road and left roadway on right shoulder. Vehicle 1 traveled several feet in ditch and struck a field drive causing it to leave the ground and overturn. Safety restraint was not used.
- Driver of vehicle 1, female age 22 died on 2/12/08 in Anderson Co as a result of vehicle one was eastbound on highway. Vehicle one drove off the southside of the roadway. Overcorrected and entered the south ditch. Vehicle overturned coming to rest on the passenger side. Driver was ejected. Safety restraint was not used.
- Driver of vehicle 1, male age 40 died on 2/9/08 in Smith Co as a result of vehicle 1 southbound on highway where
 there was a curve in the roadway, driver entered the south ditch, overcorrected and rolled the vehicle. Driver was
 ejected. Safety restraint was not used.
- Driver of vehicle 1 (motorcycle), male age 33 died on 2/9/08 in Sedgwick Co as a result of vehicle 1 northbound on street. Vehicle 2 was southbound in left turn lane on street and failed to yield right-of-way turning left in front of vehicle 1.
- · Driver of vehicle 1, female age 22;
- Occupant 2 of vehicle 1, male age 29 died on 2/7/08 in Montgomery Co as a result of vehicle 1 northbound on highway and vehicle 2 (semi) southbound on highway. Vehicle 1 drove off onto the east shoulder, over corrected, and drove into the southbound lanes. The right front of vehicle 1 struck vehicle 2. Vehicle 1 spun from the impact and was struck in the rear by vehicle 2. Vehicle 1 came to rest in the east ditch facing sout west. Vehicle 2 came to rest in the west ditch facing south. Safety restraint was not used.
- Driver of vehicle 1, male age 41 died on 2/4/08 in Cloud Co as a result of vehicle 1 traveling westbound when it hit
 the bridge guardrail. Vehicle 1 continued westbound and rolled. Driver was ejected from the vehicle. Safety
 restraint was not used.
- Driver of vehicle 1, female age 21 died on 2/3/08 in Chase Co as a result of vehicle 1 eastbound on highway, attempted to pass and hit westbound vehicle 2 head on.
- Driver of vehicle 1, male age 23
- Occupant 2 of vehicle 1, male age 25 died on 2/01/08 in Morris Co as a result of vehicle 1 southbound on Dunlap Road. Vehicle 1 failed to make a turn on a curve in the roadway. Vehicle 1 entered a ditch, failed to correct and following the ditch for 100 yars. As vehicle 1 attempted to re-enter roadway, vehicle over corrected returning to the ditch and rolling 2-3/4 times. Vehicle 1 came to rest on the driver side. Safety restraints were not used.
- Driver of vehicle 1, male age 57 died on 1/30/08 in Reno Co as a result of vehicle 1 northbound on highway, drove
 off the roadway into the east ditch, and struck a tree. Vehicle overturned and came to rest facing east on the
 drivers side of the vehicle.
- Occupant 3 of vehicle 1, male age 27 died on 1/28/08 in Stevens Co as a result of vehicle 1 eastbound on road.
 Vehicle 1 then went into the south ditch where it drove down the ditch. The vehicle then made a sharp turn back across the road, vehicle entered the north ditch where it rolled and ejected the passengers. Safety restraint was not used.
- Driver of vehicle 2, female age 72 died on 1/26/08 in Osage Co as a result of vehicle 1 pulling a trailer southbound on highway when the vehicle hit a slick spot and lost control. Vehicle 1 went sideways into on-coming traffic.
 Vehicle 2 was northbound and struck vehicle 1 and the trailer. Safety restraint was used.
- Driver of vehicle 2, male age 17 died on 1/26/08 in Wyandotte Co as a result of vehicle 2 stopped for red light.
 Vehicle 1 struck vehicle 2 in the rear.
- Driver of vehicle 1, female age 17 died on 1/25/08 in Atchison Co as a result of vehicle 1 northbound on highway.
 Vehicle 2 (semi) was southbound on highway. For an unknown reason, vehicle 1 went left of center, struck vehicle 2 head on, at which time, both vehicles became engulfed in flames.
- Driver of vehicle 1 died on 1/25/08 in Wilson County.
- Driver of vehicle 1, male, age 23 died on 1/24/08 in Sedgwick Co as a result of vehicle 1 headed westbound in the
 eastbound lanes on highway when he struck eastbound vehicle 2 head on. Safety restraint was not used.
- Driver of vehicle 2, male age 33 died on 1/23/08 in Wyandotte Co. Safety restraint was not used.
- Driver of vehicle 1, male age 24 died on 1/22/08 in Ellis Co. as a result of vehicle 1 eastbound on highway when it
 entered the north ditch, struck a tree and caught on fire.

- Driver of vehicle 1, male age 22 died on 1/21/08 in Johnson Co as a result of vehicle 1 that struck a stone
 residential development sign and then a tree. Safety restraint was not used.
- Occupant of vehicle 1, male age 14 died on 1/19/08 in Reno Co as a result of vehicle 1 eastbound street
 approaching another street. Vehicle 1 lost control and entered north ditch. Vehicle 1 rolled one complete time
 ejecting both occupants. Vehicle 1 came to rest right side up in field. Safety restraint was not used.
- Driver of vehicle 1, male age 21 died on 1/9/08 in Johnson Co as a result of vehicle 1 southbound on road. Vehicle 2 was turning left from eastbound road to go north on road.
- Driver of vehicle 1, male age 54 died on 1/9/08 in Butler Co as a result of vehicle 1 northbound on highway when
 it left the roadway, struck a guardrail overturned ending up on it's top in a river bed. Safety restraint was not
 used.
- Driver of vehicle 1, male age 57 died on 1/9/08 in Montgomery Co as a result of vehicle 2 traveling southbound on highway. Vehicle 1 was traveling eastbound on highway. Vehicle 1 failed to stop at the stop sign. Safety restraint was used.
- Driver of vehicle 1, male age 19 died on 1/9/08 in Morris Co as a result of vehicle 2 northbound on road and vehicle 1 was coming around the corner from the east. Driver 2 tried to voide the collision but was unable to avoid the collision. Safety restraint was not used.
- Occupant 3 of vehicle 2, female age 63 died on 1/6/08 in Johnson Co as a result of vehicle 1 northbound on street. Vehicle 2 was southbound on street, turning left onto eastbound street. Vehicle 2 made the turn against a posted No Left Turn sign and was struck by vehicle 1. Safety restraint was used.
- Driver of vehicle 2, male age 55 died on 1/6/08 in Shawnee Co as a result of vehicle 1 westbound on street and failed to yield the right of way and struck vehicle 2 which was northbound on street. Safety restraint was not used.
- Driver of vehicle 1, male age 63 died on 1/5/08 in Butler Co as a result of vehicle 1 and vehicle 2 westbound on highway. Vehicle 2 was turning left (southbound) into highway. Driver of vehicle 1 did not see or could not see that vehicle 2 was turning and struck the rear of vehicle 2.
- Driver of vehicle 1, female age 37 died on 1/2/08 in Labette Co as a result of vehicle 1 eastbound on highway
 when the driver got off the south edge of the road, lost control and came back on the roadway, over-corrected
 and entered the south ditch, overturning, ejected the driver. Safety restraint was not used.

Mr. Chairman, Members of the Committee: My name is Bill Sneed and I am Legislative Counsel for the State Farm Insurance Companies. State Farm is the largest insurer of homes and automobiles in Kansas. State Farm insures one out of every three cars and one out of every four homes in the United States. Please accept this memorandum as our support of S.B. 59.

As we read S.B. 59, this bill would amend current law and allow primary seat belt legislation, and would permit enforcement for all ages. Traffic-related injuries are the leading cause of all injury deaths in America. This problem is serious and an important public safety issues. Those who refuse to buckle up indirectly shift financial costs to all Kansans, which are then passed on to our children, society and businesses.

The National Highway Traffic Safety Administration ("NHTSA") estimates Kansas could save \$230 million dollars each year on medical expenses, lost productivity and property damage if a primary seat belt law were passed. Further, NHTSA estimates that if Kansas raised the seat belt use rate from 69% to 100%, each year Kansas would prevent an additional 97 fatalities and 1,780 injuries. Finally, passage of the primary seat belt law would make Kansas eligible for an additional \$11.1 million dollars in federal grants to fund infrastructure safety programs such as intersection improvements, pavement and shoulder lining, traffic calming, etc.

Based upon the foregoing, my client respectfully urges the Committee to act favorably on S.B. 59. I am available for questions at your convenience.
