## HB 2446 - State educational institutions; gifts and donations; investments

Representative Lane made a motion to pass out favorably as amended. Representative Aurand seconded the motion and the motion passed unanimously on a voice vote.

#### HB 2739 - School districts; mandatory local levy; state financial aid; BSAPP

Rep Aurand moved to amend **HB 2739** by introducing a substitute bill which would incorporate the provisions of: **HB2739** (in its original version): **HB2607**, which increased the amount of the BSAPP, eliminated the high enrollment weighting, simplified the statutory provision concerning the low enrollment weighting and adjusted the weighting factors in the computation of other pupil weightings in relation to the increase in the statutory dollar amount of the BSAPP.; **HB2647** (as amended by the House committee), which authorized school districts to adopt a local activities budget; the provision in **HB2280** which allowed school districts to transfer certain moneys from the capital outlay fund to the contingency reserve fund; **HB2719**, which authorized school districts to adopt an equity budget (modify so that it applies to school districts under the state-wide average combined LOB and general fund budgets); and add a new provision giving school districts more flexibility to transfer certain moneys in various funds, and any additional changes that are necessary to conform to the policy changes expressed by the committee.

## SB 362 - Teachers and administrators, contracts; notice of non-renewal

Representative Aurand made a motion to amend this bill, and move the May 1 deadline back to May 15. Representative Carlson made the second, and the amendment passed. Representative Lane made a motion to sunset the deadline change to three (3) years. Representative Aurand seconded the motion, and the motion carried on a voice vote. Representative Aurand, then, made a motion to amend **HB 2699** into **SB362**. **HB 2699** extended the tenure for a teacher from three (3) years to five (5) years. Also, Representative Aurand's motion would leave tenure to three (3) years and allow a two (2) year one-time waiver. This would, also, be subject to the agreement of the school district. Representative Landwehr provided the second and the motion passed on a voice vote. Representative Aurand made a motion to pass **HB 362** out favorably as amended. The motion was seconded by Representative Siegfreid and the motion carried.

# HB 2718 - School finance litigation; duties of the revisor of statutes

Representative Aurand made a motion to pass out **HB 2718** favorably and ask that it be placed on the consent calendar. Representative Carlson seconded the motion and the motion passed on a voice vote.

# HB 2559 - School districts; expenditures over \$20,000
