HCR 5030 - Supporting a statewide statistical survey of high school football players' families regarding use of major university stadiums as host venues for football championship games.

Chairman Aurand closed the hearing on HCR 5030.

The meeting was adjourned at 10:30 a.m. The next meeting is scheduled for February 17, 2010.

I am Gary Brockus, and thank you for giving me the chance to speak here. I am from Overland Park. My one and only goal, is to help provide a once in a lifetime opportunity to student athletes as a reward for their hard work and excellence by playing the state championship football games at the states most impressive venues, as 87% of other states do. I have been to 10 state championship games in both large and small venues. I have also served as Chairperson of a large sports and recreation commission which serves tens of thousands of families. I and others have done extensive research regarding this matter and have been responsible and professional in our efforts.

PROCESS AND HISTORY

Beginning in November 2007, we presented a proposal to rotate all five of the 11 man championship football games in a year to year alternating fashion between large venues, such as KU or KSU, and the five small venues currently used. We call the proposal 50/50. The 50/50 aspect of our proposal recognizes there are differences in opinions about where the games should be played. It shows respect for the preferences of all, and to the existing 5 venues and cities which currently host the finals. These venues usually provide adequate service, though occasionally there can be problems with inadequate seating for the two participating schools.

In March 2008, at the athletic directors' annual convention, KSHSAA staff presented the issue. After the convention, I was notified 90 out of 100 members wanted to keep the current format. But there remain questions as to what important information was presented, or not.

During December 2008, we conducted our own statewide survey, and a month later we presented the results to the KSHSAA Executive Board. The survey involved questions about increased ticket prices, game days and times, and stadium atmosphere, which were issues the KSHSAA had given for not using major venues. After considering all those factors, 70.4% of 305 families (6% margin of error) surveyed statewide from 32 schools preferred KU or KSU to the existing venue. Despite overcoming all their previous issues, the Executive Board made no motion for change, citing lack of support from members who were not hearing from families a desire for change. The reason for that is simple. Only 4% of schools play in the state finals each year, it affects very few. A family from Ottawa for example, which is my hometown, will not contact their local school official and complain about the state finals not being at a major venue, when they haven't been to the state finals in 41 years. That is a common scenario statewide. Relying on self initiated patron feedback will make it very unlikely change will ever occur, if that's the desired result. Most families aren't aware KU or KSU are even potential options. The KSHSAA decision to leave KU/KSU after 2003 was not based on self initiated feedback from citizens. The KSHSAA has said the past 7 years that KU and KSU remain "under consideration".

My local district activities director agreed to present our proposal at the AD's March 2009 annual convention. Unlike at the 2008 convention, the proposal was backed by the statewide survey which overcame the issues the KSHSAA had raised, and other supportive data. He expected a close vote. It was 65-3. The only 3 "yes" votes in the whole state were from his district. Given the overhwhelming facts to support it, how could this be? Why would every school official whose school was closer to KU or KSU have voted to make their patrons drive up to 7 hours further round trip to the existing venue? Why would one school official who was in the state finals at Hays, vote to go back when we surveyed his patrons and they had voted 13-1 for KU or KSU. That is a perfect example of how relying on passive feedback from the public does not tell you what the families and students want.


CONCLUSION

My wife and oldest daughter are teachers. Many of you have past or current personal ties to education, as a teacher or school board member. I'll ask you to broaden your geographic scope. You can see by the map, the large majority of educators nationwide would support the use of large venues. The

My name is Tony Sherman from Shawnee, KS. Thank you for the opportunity to speak in support of HCR5030. During our time involved in this cause, we have done extensive research. Not only have we been talking to students and families in Kansas, but we have been in contact with several other states across the country. We have found Kansas to be in a very small minority not only with this issue, but in overall focus as well. We also found a common theme among other states that we have struggled to find in Kansas. Que Tucker is the Deputy Director of the North Carolina High School Athletic Association. During a phone conversation in May 2008, I asked her why they were utilizing 3 major college venues for their championship games. She responded with obvious pride in her voice, "We want to provide the best experience possible for our families and students. These kids grow up watching games at these universities and most will never get another opportunity to play on these fields. Playing at (North Carolina, North Carolina State and Wake Forest) is a treat for the kids who have worked so hard to achieve greatness."

We have performed two surveys of student athletes and families in Kansas. The more expansive survey was performed in December 2008 and January 2009. A group of volunteer citizens conducted a formal statewide survey of parents to gauge their interest in utilizing The University of Kansas and Kansas State University as hosts for all five 11-man championship football games in a two-day event format. The survey was spread evenly between classes 2A-5A, as well as between the east and west regions as defined by the Activities Association. The questions addressed all of the reasons the Association had given for not utilizing these venues. Those reasons were: a possible increase in ticket prices due the higher costs associated with using these stadiums, the potential for games to be held at any time on either Friday or Saturday during Thanksgiving weekend, and the differences in atmosphere between smaller and larger venues.

The first survey question asked if your son were participating in the state championship football game, where would you like it to be held: KU, KSU, or the existing venue. 80% (244) of our 305 respondents answered with KU or KSU. For those, the survey continued, allowing the opportunity for the participant to change their choice to the smaller existing venue after each issue was presented.

Next, they were asked about possible ticket price increases of up to \$3.97% of those asked still chose the larger venue. Keep in mind, ticket price increases are not the only means by which the association can account for the additional costs of using these venues. Other options include corporate sponsorships, which almost every other state in the country currently utilizes, or the large surplus of cash reserves the Activities Association holds, as revealed in a recent legislative audit. With that said, based on their voting it appears the association members are not concerned with any potential cost to their patrons or the schools. Every administrator from a school district closer to KU or KSU than the existing venue voted against the proposal at the most recent KIAAA meeting in March 2009. Some of those votes would result in their teams and patrons driving up to seven hours further round trip. Additionally, during the last three years, the average travel distances of the 10 teams which participated in the 11-man state finals would have been less if all the games were held at either KU or KSU than the five venues (Hutchinson, Topeka, Salina, Hays, and Emporia) they were sent to.

The second issue addressed was the varying game times. Participants were told of the potential of playing their game anytime from Friday afternoon through Saturday night on Thanksgiving weekend. 94% of those asked still chose the larger venue.

Finally, they were asked for their opinion on stadium atmosphere. Although 38% felt the smaller venues would provide a better atmosphere, only 3.5% decided to change their vote to the smaller venue because of this issue. Regardless of whether people believe the smaller venues could provide a better atmosphere, they still want their championship game to be a once in a lifetime experience in a large venue.

After all the issues had been addressed 70.4% (215 of 305) of the participants chose KU or KSU as their venue of choice. Every issue the Activities Association raised was easily defeated when we surveyed those who are most affected; the families and student athletes. Yet not one member school other than the presenting district would support the proposal to play at KU and/or KSU 50% of the time. Further details of this survey are available for your review in Appendix A. Detailed results are in Appendix D.

When we presented these results to the Activities Association Board, we received more reasons why they could not support our proposal. One new reason given was a concern for a lack of on-field post-game celebration time due to games being held back to back. Three games can easily be played within normal game time boundaries currently practiced by the KSHSAA with ample celebration time on the field. 77% of players we surveyed after the 2007 championships would have rather been at KU or KSU in spite of unlimited celebration time at the existing venue.

The most recurring reason we were given this time is the process. The Association maintains there is a system in place for the patrons to have their opinions heard if change is truly desired. According to this process, patrons should contact their administrators to voice their opinion. We believe there are many faults with this system. First, we have previously demonstrated how patron feedback is unlikely on this issue. Second, there was no outcry from the public to quit using these venues after 2003, based on the Association's past testimony. Third, what assurance is there this system would ever produce change for the patrons? If we have all our survey participants call their administrators, what would result? Are any regulations in place requiring the administrators to act on phone calls? Where is the accountability in this system? Why can the results of a survey not be seen as "X" number of phone calls into administrators? This resolution should be seen as support for the Activities Association, not an encroachment. Effecting change state wide on this issue is not like raising money or resources for a struggling local recreational board or a high school gymnasium project. To expect a groundswell effort to rise up large enough to convince more than half of the AD's state wide to change their minds is unreasonable.

A statewide Activities Association should take the lead in finding out what their patrons' desire in their high school activities. Yet they oppose a simple, cost-free resolution to provide unquestioned data regarding their patrons' wishes on this issue. These are the same patrons who are most affected by these decisions and who the association calls "their most important clients". Your support and influence is needed, which is why this resolution is necessary.

Appendix A.

Details of the survey performed by citizens between December 2008 and January 2009:

- Survey was performed by volunteer citizens using a script certified by two independent market research firms as unbiased toward the larger venues at KU and KSU. The script is available for review in Appendix II.
- 305 families participated in the survey from classes 2A to 5A. Class 6A was left out of this survey due to the large proportion (approximately 40%) of 6A schools residing in Johnson County. Based on other informal surveys we had previously performed, we are confident the survey results would have only been more skewed toward the large venues had class 6A been included. The surveys were spread evenly between the classes as well as between the east and west regions as defined by the KSHSAA. The survey participants were limited to those whose school had posted online rosters and whose home phone numbers were listed for public access.
- Of the 305 families surveyed, 89% were completed with the parents only answering the questions. The other 11 % involved the parents as well as student athlete input.
- Once the survey began, the participant was asked, "If your team was in the state championship football game, would you prefer to play the state championship game at KU, K-State, or at (the existing venue) where they currently play the game for your classification?" Exactly 80% (244 of 305) answered either KU or KSU. If the participant answered with the smaller/existing venue, the survey was concluded with the follow-up questions (the last two on the survey form). The script did not allow for these participants to change their answer from that point forward.
- For the remaining participants, the survey then began to address the issues brought forth by the KSHSAA. The second question asked, "Would you still be willing to play at (KU/KSU) knowing the cost might be up to \$3 more per ticket than at (the existing venue) where it is currently held?" Only 7 of the 244 (2.8%) families asked decided to change their vote to the smaller/existing venues at this time. If the participant's vote remained for the large venue at this time, the surveyor moved to the next issue.
- The third question asked was, "would you still choose (KU/KSU) knowing the game time there could be Friday afternoon or evening, or anytime Saturday between 11am and 6pm?" Only 14 of the 237 (5.9%) families asked decided to change their vote to the smaller/existing venues at this time. If the participant's vote remained for the large venue at this time, the surveyor moved to the next issue.
- The fourth question asked was, "Do you believe that overall, a smaller college or high school stadium like (existing venue) would be a better championship game atmosphere than a major college stadium at KU or K-State?" Although 85 of the 223 (38.1%) thought that the smaller venue would provide a better atmosphere, only 8 of those 85 (9.4%) families decided to change their vote to the smaller/existing venues at this time.
- The participants were then asked to validate their vote based on all the issues discussed, which verified that 215 of 305 (70.4%), with a 6% margin of error, would rather see their children play state championship football games in large venues such as KU or KSU.
- The follow up questions were asked of all 305 survey participants. None of the families we surveyed could recall being asked by any school administrators for their opinion in this issue. 286 families gave permission for us to provide their name if requested.


The following is potential details of how a future survey would be handled if this resolution is passed:


- The survey would once again target the student athletes and their parents, who we feel are most directly effected by these decisions. After all, it is most often the parents themselves who are most effected by possible ticket price increases, travel expenses, and coordinating holiday celebrations with attending their child's championship event. These are also the voices that are continually being ignored in favor of the school administrators.
- An independent market research firm would likely formulate the questions based on input from any of the following parties: citizens, the legislature, and the Activities Association.
- The size of the survey would be a minimum of between 200 and 400 respondents. According to the research firm we have been in contact with, this is the recommended size for the type of survey we are attempting to conduct in order to ensure a relatively small margin of error while keeping costs at a reasonable level. Since citizens will be responsible for the costs incurred, the size of the survey will depend on the funds available or that can be raised. The thought of a census involving all school and student athletes has been negated due to the costs incurred from such a process.
- This survey would also attempt to spread the participants across all classes and regions just as the citizens' survey did. It would involve classes 1A (11-man only) through 6A and the east/west regions divisions established by the KSHSAA.
- The schools and participants chosen would likely be determined by a random number generation process within each region and class.
- The independent research firm would contact the school boards affected and coordinate the surveys through them. This would help to ensure the greatest possibility of full participation, accuracy and unbiased validity.
- Results can be returned in several possible ways:
 - Online survey options for easy access to all participants.
 - Paper forms that could be mailed to the research firm or returned to the school board.
- Results would be tabulated by the research firm and reported back to all parties involved.
- The cost incurred by utilizing an independent research firm will be the responsibility of volunteer citizens and funds they may be able to raise in support of this cause.






These charts are indicating the citizens' survey results broken out for each class (2A-5A) and region (east/west):














Hello, I am Marsha Cook, and I would like to thank you very much for allowing me this time with you today. I have lived in Kansas all of my life. I was born here in Topeka and at the age of 22 months we moved to a small town southwest of Topeka. I left small town life for four years but returned home, because I wanted my children to grow up in a small town community atmosphere, like I did. I wanted them to be able to attend a smaller school so that they would have the opportunities to participate not only in a closer teacher student academic relationship but other activities like band, FCCLA, FFA, the Big/Little program and athletics, just to name a few.

I am not saying life in a small town is perfect but as I remember it growing up, the people cared about you and your activities. It was where all activities were well attended not only by your family members, but by your neighbors and friends. Where the Vo-Ag teacher, a board member and even the school principle would be sitting right along beside you and never thought twice to whether they did or did not belong there with you. A place where achievements of a few could be celebrated by many and shared, so that others might become interested and have future great experiences. Friday night high school football for me as a very young child was running up and down the sidelines hanging on to my dad with one hand and a Carmel apple in the other.

The people I grew up watching on that football field, basketball court or in that school play, were some of my teachers. In the old days my kids would now be being taught by their kids. But over the years our schools have merged and we are becoming more diverse, with more kids, more parents, and more opportunities. Most of our educator's don't even live in our communities anymore, they commute. I know that can add a strain, as I had to commute for over 33 years to a job, since I could not find one locally. But even so the administrators in our schools see our children everyday, they know what get's them excited, and what get's them down. What helps them learn and grow. But along the way we seem to be loosing touch with each other. So that is why when a volunteer service organization I am in, the Telephone Pioneers of America, was asked by Mr. Brockus to help with a survey of high schools around the state and what the topic was, I was thrilled to get to participate. I have a son who played football and other sports as well as a daughter who participated in sports. The survey went well and the few folks I got to talk to were, for the most part positive too shall we say excited to think that their kids might get an opportunity that they did not. So when I heard that the idea to have the state championships in the large venue stadiums was shot down by the KSHSAA Board, I was shocked. The sad side of that story for me is that my son's high school football is now finished. Though they had great records both his junior and senior years, they were just shy of what they needed both times. But had they made it to state, they would have missed out on an opportunity of a lifetime by not getting to play at a large venue stadium.

Although his high school football seasons are over and his opportunity has passed, there are still other great kids in other towns who made it to state. And once again they too missed out on a chance to play at a big venue stadium. However, there could be a good ending to this story yet. We can still make a change and future players with their support group of parents', family and friends could get that chance. We should not let it pass us by yet again. The state championship high school football game is one of, if not the biggest school-related event and memories of a participating students' high school life.

I think there are two primary reasons that most Kansas citizens do not initiate feedback to the KSHSAA about this issue. The first being the existing small venues used for the championships are usually nicer than the ones the teams play at every Friday night during the regular season. Secondly, I discovered from working on the survey, most families and players do not know that large venues are even a potential option for a championship game.

The thousands of students and parents and extended family members who participate and attend the games are those most affected. Yet, none of the 305 families that were surveyed had been contacted by their school administrator about this issue. I don't expect administrators to have to get feedback on everything they do, but on a major life experience like this issue, when it is offered to them as it was in the survey results, it should be welcomed.

Testimony to the Kansas House Education Committee February 16, 2010

Thank you for the opportunity to share our thoughts about the proposed survey to gauge support for moving 11-man high school football championships to the KU, KWU and WSU stadiums. Salina is opposed to such a proposal for several reasons:

Overall, addressing this situation legislatively is unnecessary. The status quo allows for KSHSAA to contract with those venues and to co-locate games if that were the best format and beneficial to the championships and the venues.

Playing in a huge state university stadium has been referred to as potentially the 'chance of a lifetime' for the teams and fans. We contend that playing in a stadium filled with the roar of enthusiastic fans creates the better environment and makes for a much more memorable experience for everyone. The largest paid attendance we've experienced at a state football championship in Salina has been about 3,700. That crowd in a 45,000 seat stadium does not translate to an exciting, high energy experience. KSHSAA carefully selects sites that are appropriate in size and scope to the needs of each Class and they create the environment that is memorable for players, parents and fans.

Hosting these events currently provides economic activity in several Kansas communities. The activity reflects a significant commitment by a host city. Visit Salina serves as the host entity for the 4A Championship game at Salina Stadium. The significant investment of manpower by staff and volunteers, and local funds to cover various expenses related to hosting the event are the local investments that has allowed KSHSAA to keep ticket prices steady for several years. The university stadium format will surely increase costs and manpower needs and will create unnecessary logistical challenges regarding locker room access, clearing the stadiums, etc. We do not want to see the \$225,000+ in estimated visitor spending lost from Salina, and wonder where the additional dollars will come from to utilize the university stadiums. Will that lead to higher ticket prices and potentially greater travel costs for families?

To survey the 11-man families may seem a logical step, but we suggest that the issue may be a solution looking for a problem. Families involved in high school activities are usually not shy to share their thoughts about events with their administration, and in turn, with KSHSAA. KSHSAA has always taken constituency input very seriously, and continually strives to improve the 'product' wherever possible. From the standpoint of the families involved, if there was a problem with the existing championship format, it would be evident.

Gentlemen: Thank you for taking the time to read this email. I am the superintendent and principal of all of the schools in USD 245, LeRoy-Gridley. Mr. Otto is our representative and I request that you all consider the impications of more cuts to education now and in the future. We in USD 245 have made major changes in the administration of our district over the past few years and have made changes in all areas to continue to offer a quality education to our students while continuing to receive less in funding each year.

A part of the less funding is a decrease in enrollment but then this year hit us and we, along with most school districts in the state are in a world of hurt. Further cuts will cause us to lower the quality of education in our district and / or cause the closure of buildings and possibly of the district. Neither one of these options are in the best interest of the students of our school system.

I urge you to continue to support public education and make every effort to return funding to an amount that will ensure that EVERY student in our state has the opportunity to receive a quality education. In my mind that is back to the area of \$4400 - 4800 per student without changes in weighting.

I would also like to address the Concurrent Resolution 5030 that I understand will be heard on Tuesday. I feel that we have much bigger fish to fry in our state to be worried about where 11-man football championships are played. Over the past two or three years this issue has been discussed at the KSHSAA Executive Board meetings, at the KIAAA (Athletic Directors Association) annual meeting, and at meetings with school administrators throughout the state. In every instance the participants have voiced support for holding the state championships at the venues currently being used. To place a class 1A-2A championship game in a stadium that will hold upwards of 50,000 fans and have about 3,000 in the seats does not give the athlete a sense of being in front of a big audience, but place those same 3,000 fans in a stadium that holds 5,000 and you have that atmosphere that makes for excitement.

In today's Capital - Journal Representative Aurand was attributed with saying that in the Montoy case that "he hopes that the courts will stay out of the case and leave funding questions up to lawmakers." I would agree with that statement but would then add this thought to the HCR5030 issue: "I would hope that the lawmakers would stay out of the issue and leave finding locations for state championships up to the KSHSAA."

The schools of Kansas have spoken on numerous occasions and continue to like what is happening with high school activities. Please spend your efforts on something that is truly important to ALL Kansas students and not what appears to be important to a SMALL group (my understanding is two or three people).

If at anytime you would like more information from USD 245 concerning our issues and how we are trying to cope, please contact me. I would be happy to make the effort to testify if needed on these or other issues that directly affect the students in Kansas schools.

- D) Has this group 'surveyed' the communities that currently host each of the KSHSAA State Events. I seriously doubt they want to loose the economic revenue that is brought to those communities during Championship week-end!
- E) School officials are constantly concerned with accommodating parents/patrons and our children. Championship week-end, not only affects the Football team, but cheerleaders, pep bands, student body pep squads, coaches, administrators, teachers, bus drivers...get the picture? It's Thanksgiving.

I sincerely thank you for reading this, and understanding my concerns. Without question, if you would like, I would not hesitate to speak to you personally, or the Committee, but unfortunately I feel that I have more important duties, actually 250 of them, my kids, that need my full attention on Tuesday.

Testimony before the House of Representatives – Education Committee (HCR 5030)

Gary Musselman, Executive Director On behalf of the Kansas State High School Activities Association February 16, 2010

Mr. Chairman and Members of the Committee:

The Kansas State High School Activities Association is opposed to the adoption of HCR 5030. As a private association of member schools, the governance of the KSHSAA is vested in the members of the Board of Directors and Executive Board, who serve as the elected representatives of the 776 member schools.

In accordance with statue, the KSHSAA reports to the Kansas State Board of Education. Given that responsibility we respectfully submit a letter of February 11, 2010 signed by Sue Storm, Legislative Coordinator and State Board of Education Member from District 2, Johnson County. Janet Waugh, Chair of the Kansas State Board of Education has served the last two years on the KSHSAA Executive Board and Board of Directors. On two separate occasions Ms. Waugh has heard the presentation of the proponents of this resolution.

For the last three years, TWO individuals not affiliated with a member school, have brought this issue before the KSHSAA Executive Board on repeated occasions. At three Executive Board meetings, the KSHSAA granted the opportunity for Mr. Brockus and Mr. Sherman to present their information. In total, they have had more than three hours of time on this issue before the KSHSAA Executive Board. While the Board has respectfully listened to the presentation and asked for input from school athletic directors, they have not made changes to the format and venues of KSHSAA state football championships as there has been little to no support from the member schools to do so.

In March of 2008, the Executive Board directed further discussion on the proposal via the annual meeting of the Kansas Interscholastic Athletic Administrators Association. High School athletic directors attending this convention **voted 86** - **10** in support of the current championship format and venues. In March 2009, at the request of Mr. Brockus, the district Athletic Director of Blue Valley USD #229, again presented the issue to the KIAAA membership at their annual meeting. The question presented was, "Should the KSHSAA change their practice of assigning 11 man state championship football games at a variety of locations with single games, to multiple games at one site using either Kansas University or Kansas State University?" The vote was 3 Yes 65 No.

While proponents make a point of comparing Kansas' football championship format to other states across the nation, it should be noted each state's high school athletic/activity association is unique in it's' structure, governance, history and culture. The National Federation of State High School Associations as the governing body of high school sports has no authority or requirement of standardized rules, activities, seasons or championship formats. Each state association is unique and answers to the will of its member schools.

In recent years, the availability of artificial turf on numerous college facilities has created opportunities for state championship games to be played in college stadiums more appropriate to the size of our crowds. (2009 state attendance at the five 11 man games totaled 16,395) (11,018 adults & 5,377 students). The operational expenses at these venues are more in line with revenues from these events. Managing costs by use of stadiums favored by our member schools, has enabled the KSHSAA to maintain the lowest ticket price in the nation at \$5 students and \$6 adults. These prices have remained unchanged since 1999, which is a service to the people of Kansas. The KSHSAA has not ruled out possible future use of KU or KSU stadiums. It has simply acted on the wishes of its member schools by using more appropriately sized facilities.

In closing, the KSHSAA respectfully requests support for its ability to make operational decisions about its programs and services without intervention by the Kansas Legislature. One can envision a myriad of issues that will follow if legislators choose to become involved in the day to day operation of the KSHSAA. Thank you for your consideration.

I wanted to make contact with you regarding HR #5030. As I am sure you are aware, the resolution deals with the hosting of State Football games at Kansas State, the University of Kansas and Wichita State University. I have several points that I would like to address regarding this issue.

First of all, the KSHSAA member schools are not asking for this change. In two separate years, the issue has been brought before the Kansas Interscholastic Athletic Administrators Association (KIAAA) and been soundly defeated. In 2008 the vote was 86-10 against and in 2009 the vote was 65-3 against. The two men that have championed this cause (Gary Brokus and Anthony Sherman) have been given an audience at the KSHSAA Executive Board twice. The change is not a change that the member schools of the KSHSAA are interested in making at this time.

Second, the change to a single site would mean that the current hosts would no longer have the opportunity. This would mean schools like Emporia State, Washburn and Fort Hays would lose the economic impact that the games bring to their schools and communities. Hutchinson Community College and Newton have served as hosts for a few years and the communities have benefited from this. The current sites "fit" the schools more appropriately. Playing in a packed house with standing room only is an amazing atmosphere. In my experience at Liberal and at Hutchinson High School, I have taken teams to KU and KSU. While the fans were excited to be there, the stadium swallowed them up.

Lastly, I would say that this resolution comes at a time when the focus of our elected officials should be on more important issues. Where the KSHSAA chooses to play its championship games is important but not when you look at the big picture and the issues that are affecting our state. To spend valuable time and resources on this issue would seem ridiculous, given the amount of time it has been given by the KSHSAA, KIAAA and the member schools of Kansas. The issue is being brought to you because these two gentlemen didn't like the answer they were given after careful consideration by the member schools.

I appreciate your service to Kansas. I would be happy to visit with you more about this issue if you feel the need. Thank you for your time and attention to this matter.
