Bill Introductions

Representative Vincent Wetta requested that the committee introduce an annexation bill, which last year was referred to as a "snake annexation" bill. Represented Otto moved the Committee introduce this bill, seconded by Representative Seiwert. The motion carried.

Representative Mah moved the Committee introduce a bill that would deal with unilateral annexation of land. Her motion was seconded by Representative Gordon. The motion carried.

Doug Mays, City of Olathe, requested the Committee introduce a bill regarding facility conservation improvement. It was moved by Representative Goico and seconded by Representative Otto that the Committee introduce such a bill. The motion carried.

On behalf of the State Treasurer, Representative Mah moved that the Committee introduce two bills regarding unclaimed property (1) to allow the Department of Health and Environment to share information with the State Treasurer and (2) to allow the Department of Revenue to share information with the State Treasurer. The motion was seconded by Representative Goico. The motion carried.

Chair Schwartz requested the Committee introduce a bill concerning land use relating to certain military installations. The motion was seconded by Representative Gordon. The motion carried.

Chair Schwartz stated she has received a request from the Majority Leader's office that the Committee introduce a bill having to do with the annexation of land by cities. <u>It was moved by Representative Goico and seconded by Representative Mah that the Committee introduce this bill. The motion carried.</u>

Representative Otto moved the Committee introduce a bill to prohibit a city from using a charter ordinance to overturn a change in government without submitting the proposal to the voters. The motion was seconded by Representative Mah. The motion carried.

Highlights/Summary of Proposed Legislation Relating to Common Interest

Communities

- The bill seeks to address critical aspects of association governance, with focus on the relationship between the association and its individual members.
- The proposed legislation applies to all common interest communities in the state that contain 12 or more units.
- The powers and duties of the unit owners association and the board of directors are described. The power to borrow money was added to the powers of the association.
- The bill includes treatment of the association bylaws, rule making, operation and governance, notice methods, meetings of the unit owners and board of directors, meeting and voting procedures and provisions for adoption of budgets and special assessments.
- The board of directors is given flexibility in determining whether to enforce the letter of each provision of its declaration, bylaws, or rules, or decline to enforce or to compromise on such.
- The bill gives authority to discipline unit owners (within limits) for failure to pay assessments.
- The bill provides guidance for record keeping and record keeping requirements are provided in detail and are consistent with the provisions of the Revised Model Nonstock Corporation Act.
- Procedures for the removal of officers and directors are included.

- The section of the uniform act relating to foreclosure was not included because Kansas foreclosure law is well established.
- Amendments to K.S.A. 58-3119 and 58-3120 are necessary to conform those sections of the Kansas Apartment Owners Act and K.S.A. 59-3830 is repealed because it is fully covered in the bill.
- The bill includes an effective date of January 1, 2011, to allow time to make any necessary changes in bylaws and to allow time for education programs for unit owners, boards and developers.
