Chairman Carlson welcomed the legislative shadows attending the meeting and asked for introductions. Tyler Cochran, Manhattan High School was introduced by Representative Hawk. Representative Julie Menghini introduced Amber Schaefer and Eric Roland and Representative Goico introduced his legislative shadow, Hayley Yocum from St. Marys. Shadowing Representative Lukert was Deanna Toenjes, also from St. Marys.

There were no bill introductions.

Chairman Carlson called for continuation of the hearing on:

HB 2475 - Increase in rate of sales tax.

Committee members were given the opportunity to present questions for the proponents of <u>HB 2475</u>. Time constraints during the hearing on Thursday, January 21, did not permit questions for conferees at that time. Mark Tallman, Kansas Association of School Boards, stood for questions at the request of Representatives Hawk, Siegfreid, Goico, Menghini, Frownfelter and King. Representatives Menghini, Frownfelter, Rardin and George presented questions to Duane Goossen, Budget Director.

There were no further questions presented to the conferees on HB 2475.

The Chair closed the hearing on HB 2475.

Chairman Carlson called upon the committee to work **HB 2475** with no objections.

<u>Siegfreid moved that **HB 2475** be reported not passed out of committee. The motion was seconded by Representative Brown.</u>

Representative Menghini objected to the motion and asked that the bill remain in committee. Representative Menghini made a substitute motion to table the bill. The motion was seconded by Representative Frownfelter in a non-debatable motion. The motion failed on a vote by show of hands.

Representative Rardin associated himself with Representative Menghini and agreed that <u>HB 2475</u> should not be tabled at this time.

On Representative Hawk's request for point of clarification, Chairman Carlson stated the exempt status of the Taxation Committee allows for bills introductions late in the session. Should <u>HB 2475</u> be reported unfavorable and not passed out of Committee, the Chair would allow bill introductions later in the session.

Representative Siegfreid moved to report **HB 2475** unfavorable and not passed out of committee. Representative Brown seconded the motion. The motion carried to report **HB 2475** unfavorable and not passed out of committee in a vote by show of hands. Representatives Siegfreid, Goico, Powell and Hayzlett
