
### Provisions of Senate Bill 9 (2007).

Senate Bill 9 (2007) initiated fundamental changes to the State's DL and ID issuance processes.

- Division was required to:
  - issue temporary DL/ID to individuals with temporary lawful status:
  - complete fingerprint-based background check on all employees;
  - 3. provide fraud document and imposter recognition mandatory yearly training to all employees;
  - 4. retain questionable breeder documents; and
  - 5. provide yearly report to legislature.
- Applicant was required to:
  - 1. submit to full facial image capture;
  - 2. provide a verifiable social security number, full legal name and principal residence address;
  - 3. provide proof lawful presence and/or documentation allowing lawful presence; and
  - 4. provide proof of age and identity such as a birth certificate, passport, etc.
- SB 9 expanded the ability of the Division to exchange identity information with over state agencies. Created authority for the Division to create law enforcement positions for purposes of fraud prevention.
