<u>HB 2078 - State schools for the deaf and blind; authorization to contract for training programs year round</u>

Chairman Aurand opened the hearing on HB 2078.

Sue Storm, Legislative Coordinator Kansas State Board of Education spoke to the Committee as a proponent of <u>HB 2078</u>. Ms. Storm urged the Committee to visit the School of the Deaf and the School of the Blind. Ms. Storm is impressed with the energy, competence and creativity of the people who work there. Ms. Storm also expressed with confidence that the faculty and staff at both schools are meeting the educational needs of many hearing and vision impaired young Kansans. (Attachment 1)

Madeleine Burkindine, Superintendent, Kansas Schools for the Deaf and Blind, spoke to the Committee as a proponent of HB 2078. Ms. Burkindine expressed to the Committee a need for technical language clean up to allow the two schools to provide training for students on a year round basis. We are asked, more and more, to provide services to students in a variety of settings and at different times of the year – that better fit the schedule and needs of the student. Because of the wording of the current statute we are limited to providing these services in the summer only. Current statute language no longer fits the needs of our students. Your support of this technical language clean up would be greatly appreciated. (Attachment 2)

A question and answer session followed the presentation.

Chairman Aurand closed the hearing on HB 2078.

HB 2079 - Authorizing transportation of students residing on Fort Leavenworth military reservation

Chairman Aurand asked if anyone was here to speak to <u>HB 2079</u>. Chairman Aurand advised the Committee would work the Bill when it comes from the Senate.

Representative Spalding moved to introduced a bill regarding the 700 students who currently live out of state but attend Kansas public schools. Chairman Aurand asked those in favor to say "aye", those opposed to say "no". The motion carried.

Representative Spalding moved to introduced a bill for local school districts to increase local funds to pay for non-proficient students. Chairman Aurand asked those in favor to say "aye", those opposed to say "no". The motion carried.

Representative Colloton moved to introduced a bill that would request a bill related to a Post Audit study on vocational education that was done in 2006 which suggests that some beginning general courses should not receive the extra .5 weighting vocational education per student. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". The motion carried.

Representative Howell moved to introduce a bill to explore requirement of the 3rd grade students that did not meet the Standard of Excellence in Reading be held back as is being done in Florida and Georgia. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". The motion carried.

Representative Goodman moved to introduce a bill that would allow State Universities providing remedial classes to recoup costs of the classes from students' local school districts. It would be limited to a certain number of courses. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". Chairman Aurand was unable to determine and asked to have a show of hands. The motion failed by show of hands.

Representative Ward moved to introduce a bill that would phase out Schools of the Deaf and Blind. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". The motion carried.

Chairman Aurand moved to introduce a bill that would allow for extension of teachers probation period from three years to five years. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". The motion carried.

Chairman Aurand moved to introduce a bill that would mandate the first 10% of the LOB be counted as part of school district foundation funding. Chairman Aurand asked those in favor to say, "aye", those opposed to say "no". The motion carried.

The meeting was adjourned at 10:00 a.m. The next meeting is scheduled for February 7, 2011.
