Election candidate filing deadlines

Jerry, Forrest

I hope you are keeping warm today. It is thirteen degrees here in Erie.

I have a problem with conflicting statutes, or at least what I call conflicting statutes. In the spring of Odd-Numbered years, such as 2011, there are City-School Elections to be held. The candidate filing deadline for the City/School elections is 10 weeks before the April election of each of the odd-numbered years. This year the candidate filing deadline is January 25th.

Now we have an Extension District formed by Allen County and Neosho County, Southwind Extension District #10. Next July I understand that Bourbon County will join the Southwind Extension District. The members for the County Extension committees were not elected at a formal county election. The governing body of the Extension District is by statute to be elected in a county-wide election by qualified electors of the county. There are two members to be elected, from each separate Extension District member county, to serve a four year term. Then, two more elected in two years from each county to serve a four year term.

As stated above all other candidates for all the cities, all the school districts, and community colleges must file for office by January 25th for their chosen offices. The statute 2-264 pertaining to elections for Extension District governing body contains the language in paragraph (c) (2) (IN PART) Not later than 12:00 noon of the Wednesday next following the Tuesday, five weeks preceding the first Tuesday in April in odd-numbered years, each person desiring to be a candidate for the membership on the governing body, in any election, shall file a declaration of candidacy with the county election officer of the county represented by the member of the governing body whose successor is to be elected, as a candidate in such election. The county election officer in up the ballots and in placing making the names thereon shall place the names on the ballots in alphabetical order.

This statute is essence says that the person wanting to be on the board of the Extension District has to file, this year by noon on Wednesday, March 2nd, 2011. IF, there were a primary election on March 1st, the County Election officials of the counties in question would transmit the winners of the primary election to the company that puts together our ballots, and the Wednesday filing of Extension District candidates would be part of the rush to get the April election slate of candidates to the company that arranges our ballots.

THE PROBLEM IS: Quite often in City/School election years there are not enough candidates to cause (the extra expense of) having a primary election. In those years such as 2009 we were able to get our ballot slate information to the ballot arranging company in the last week of January. This year because of the Statute 2-264 concerning filings for Extension District board member seats, we WILL have to wait until March 2nd at noon before we can transmit that ballot slate information to the ballot arranging company (ES&S), who then has to put the information in a workable format and counsel with Lockwood Company of Atchison. Lockwood does a draft of the ballot(s) and sends them to our office. We send back corrections and / or approvals to Lockwood. Lockwood then has to send the ballot arrangements to the printer, who then prints the ballots for Neosho County. All of the foregoing has to be completed so we may begin mailing advance ballots by the 10th of March, or the mandated mailing by the 16th of March! You see the squeeze on the timeframe can be most difficult to

get two ballot companies plus the printer company to drop everything else and do our work in our allotted timeframe. There are many county clerks interested in having the Extension District candidate filing deadline statute amended to coincide with the City/School statutes.

The original statute saying when candidates are to file is 25-2007 for schools, 25-2109 for cities, and 71-1414 describing the filing deadlines for office. They all say that the deadline is 10 weeks before the April election. The Extension District statute 2-264 says the filing deadline is 5 weeks minus one day before the April election.

An amendment to this statute 2-264 should contain the wording that: the filing deadline would be 10 weeks prior to the April election date. It would therefore coincide with all other City/School election candidate filing deadlines.
