The Vice Chair opened the hearing on <u>SB 103 – Elections</u>; <u>absentee voting by military and others</u>; <u>federal services absentee ballot</u>. Katherine McBride, staff revisor, reviewed the bill.

Brad Bryant spoke in support of <u>SB 103</u> stating that this bill will enhance voting opportunities and to comply with two federal laws governing the voting process for military and overseas voters. The major provisions of the bill wil allow overseas voter to: (<u>Attachment 1</u>)

- Vote a full ballot at all elections
- · Apply for, receive and return their ballots by email or other electronic means, and
- Vote a write-in ballot if needed.

Chairman Schwab arrived and took Chair of the committee. Testimony was concluded and discussion followed. There being no further conferees, the hearing on **SB 103** was closed.

The Chair opened the hearing on <u>SB 125 – Elections; certain local units of governments; primaries.</u> Doug Taylor, staff revisor, reviewed the bill.

Sherrie Riebel appeared in support of the bill and stated that the deadline for mailing Federal Service ballots in 9 ½ days is not enough time for ballots to be created and printed. The bill would eliminate possible errors on "makeshift" ballots. She stated that if the filing deadline is moved to June 1st, this would alleviate some of the problems and give both the Secretary of State more time to correct certified names and their office more time to prepare the ballots. (Attachment 2)

Don Pyle spoke in support of the bill stating that the change in the deadline will greatly assist elections officials and make it easier for them to meet the deadline for the delivery of Uniformed and Overseas Citizens Absentee Voting Act ballots. By allowing the election officials an additional 9 days it will make the ballot preparation process more manageable and reduce the chance of errors. (Attachment 3)

Testimony on Senate Bill 103

Brad Bryant, Deputy Assistant Secretary of State Elections and Legislative Matters

March 9, 2011

Mr. Chairman and Members of the Committee:

Thank you for the opportunity to testify in support of Senate Bill 103. The Secretary of State proposed this bill to enhance voting opportunities and to comply with two federal laws governing the voting process for military and overseas voters. There have been amendments to the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA), and Congress passed the Military and Overseas Voter Empowerment (MOVE) Act in 2009.

Senate Bill 103 is identical to 2010 Senate Bill 426, which was considered by this committee last year.

The major provisions of Senate Bill 103 will allow overseas voter to:

- Vote a full ballot at all elections.
- Apply for, receive and return their ballots by email or other electronic means, and
- Vote a write-in ballot if needed.

More specifically:

Section 1—

This section will allow UOCAVA voters to vote in all elections, including special elections. Currently, K.S.A. 25-1215 limits them to primary and general elections, which leaves out special elections.

Section 2—

a. This section changes the effective period of UOCAVA voters' ballot applications from two federal general elections to one calendar year. Before 2004, Kansas law had a provision similar to the one-year application period proposed in this bill. The Help America Vote Act of 2002 (HAVA) required the period to be changed so that ballot applications would be effective from the date of submission of the application by the voter through the second succeeding federal general election, a period spanning two to four years. The MOVE Act reversed that provision from HAVA, allowing states to revert to their pre-HAVA rules.

b. This section allows UOCAVA voters the option of applying for, receiving and returning their ballots by email or other electronic means, as required by the MOVE Act.

We propose this provision not just because it would comply with the new federal law, but because it expands voting opportunities for a group of voters who often are in situations that make it very difficult to vote. Ballots are sent to overseas voters by county election officers beginning 45 days before the election, and Kansas law also allows the process to be completed by fax, but we find that in some cases these

HOUSE ELECTIONS DATE: 多(9)。 ATTACHMENT:) conveniences are not enough. Mail does not get delivered timely, and overseas voters often do not have access to fax machines. We have learned that they are more likely to have access to the Internet than to a fax machine, so email is a better alternative for them.

Section 3—

This section allows UOCAVA voters to vote a full ballot. Since 1976, federal services voters' ballots have excluded two races: (1) local question submitted elections and (2) political party precinct committee positions, which are elected in the August primary each even-numbered year. Before 1976, dating back to 1943, these ballots excluded even more races. The only reason for these exclusions that we know of was that, at the time the law was passed, many overseas voters received little information about local races and thus may have been uninformed about these issues. With recent improvements in the availability of political information, especially through the Internet, we assert that federal services voters are no longer limited by this factor and thus should be allowed to vote on all issues that other voters have on their ballots. Senate Bill 103 therefore would expand voting opportunities and promote fairness and equality. Another benefit of Senate Bill 103 would be to simplify the ballot preparation process for county election officers. They would no longer need to prepare a separate and different ballot for federal services voters. This would allow them to issue the same ballots to federal services voters as are issued to all other voters.

Section 3 also allows overseas voters the option of voting a Federal Write-in Absentee Ballot (FWAB) as provided for in UOCAVA. The FWAB is used when overseas voters have applied for regular ballots but the ballots were lost or not delivered. If there is not enough time to apply for a replacement ballot, voters may obtain a FWAB and write in the names of their preferred candidates for federal offices (President/Vice President, U.S. Senate, U.S. House of Representatives).

We urge the committee to recommend Senate Bill 103 favorably for passage.

For the committee's information, following are the main provisions of the 2009 MOVE Act.

- Begin distributing ballots to overseas voters 45 days before the election (this was already in Kansas law, but now it is in federal law).
- Allow overseas voters to obtain all voting information electronically.
- Collect ballot applications and transmit ballots by email or "other electronic means."
- Provide a method for overseas voters to submit Federal Write-in Absentee Ballots electronically.
- Allow overseas voters to track their ballot (whether it's been sent and received) electronically.
- Provide candidate lists electronically to overseas voters.

Honorable Chair and Members of the Committee:

Thank you for the opportunity to testify in support of Senate Bill 125. Senate Bill 125 would move the filing deadline for Federal, State and Local offices from June 10th to June 1st.

Kansas County Clerk's and Election Officials Association supports this legislation.

One, currently Election officials have to create ballots before the final ballots are printed due to the mailing deadline being 45 days before Election Day. The problem being that from June 10th at noon until June 20th deadline for mailing Federal Service ballots is 9 ½ days. This is not enough turnaround time for actual ballots to be created and printed; therefore we are creating "makeshift" ballots for our most important voters, the ones serving to keep our freedom so that we can vote. I have attached calendars from the Secretary of State's office and Election Systems and Software (which has at least 85% of Kansas Counties).

Two, it would also eliminate possible errors on "makeshift" ballots. You are trying to get everything on the ballot, and waiting on the Secretary of State's office for the certification of candidates. Secretary of State's office has to wait on lawsuits, therefore time gets pressed and mistakes are more likely to happen. We take every precaution to avoid such errors, but we are human.

Third, if the filing deadline were moved to June 1st, this would alleviate some of the problem and give both the Secretary of State more time to have the correct certified names and our offices more time to prepare the ballots.

KCC&EOA urge the committee to report Senate Bill 125 favorably for passage. Thank you for your consideration.

Chairman Schwab and Distinguished Committee Members,

In my capacity as Crawford County Election Officer, I am very supportive of Senate Bill 125. This bill will move the candidate filing deadline for even-numbered elections from June 10 at noon to June 1 at noon. The change of this deadline will greatly assist election officials and make it easier for them to meet the deadline for the delivery of Uniformed and Overseas Citizens Absentee Voting Act ballots.

UOCAVA is a federal election law that is designed to give American citizens and soldiers that are overseas the same voting opportunities as all other American citizens. I feel that it is very important that our soldiers deployed overseas have the same opportunity to vote on local and national candidates as all other voters. According to this law, ballots for the August Primary Election in even-numbered years must be mailed to the individuals requesting UOCAVA ballots by June 19. With the filing deadline of June 10, it is extremely difficult to finish the formatting of ballot forms, get them sent off to the printers and back and to still have them ready to be mailed out by June 19. This schedule can be even more complicated if a candidate files by petition. By allowing the election officials an additional 9 days it will make the ballot preparation process much more manageable and will reduce the chance for errors.

The Kansas County Clerks and Election Officials work hard to make sure that Kansas Elections are administered in a professional manner. With the support of the Kansas Secretary of State's Office and the Kansas Legislature we will continue to work to make sure that Kansas Elections are a model for the rest of the country. Thank you for your time and we very much appreciate your support in this matter.

Re: Testimony on Senate Bill 125

Honorable Chair and Members of the House Elections Committee:

Thank you for allowing me to present written testimony, on behalf of the Kansas County Clerk's and Election Officials Association and myself, in support of Senate Bill 125.

Briefly, County Election Officers are charged with conducting elections and furnishes all forms for the filings of office. The current filing deadline of June 10th creates problems. For example:

 K.S.A. 25-1220 requires Federal Services Absentee Ballots be mailed no less that 45 days prior to an election.

Statute 25-1220: Same: transmission of ballots, envelopes and instructions to voters. The country election officers of the various counties shall transmit to every person who is eligible to vote by federal services absentee ballot who makes application to vote in accordance with K.S.A. 25-1216 and amendments thereto an official federal services absentee ballot and ballot envelope, voting instructions and an envelope for use in returning the official federal services absentee ballot and ballot envelope. If the application is made 45 or more days before the day of the election, such ballot, instructions and envelopes shall be sent as soon as practicable, but not later than 45 days before the election.

- The 45 day mailing deadline leaves County Election Officers with 5 work days to verify filings and prepare ballots proofs prior to mailing.
- Often times, County Election Officers have not received the "Certified List of Candidates" from the Secretary of State's Office (especially when filings are in question). This further delays ballot preparation and finalization.
- Federal service voters consequently have to vote from ballot "proofs" as opposed to actual ballots.
- County Election Officers must hand tally the Federal Service ballots and manually adjust the tally to include those votes.

Should Federal Services Absentee ballots be sent with errors or missing candidates, this will result in critical and costly errors and, in most cases, will deny the right to vote to our UOCAVA voters. Accurate and timely information is vital in the preparation of ballots, publications and other requirements.



Honorable Chair and Members of the Committee:

Thank you for the opportunity to present written testimony in support of Senate Bill 125. The Kansas County Clerks' and Election Officials' Association has submitted this legislation for consideration and supports its passage.

Currently, the filing deadline for candidates for national, state and county office is noon, June 10th (or the next business day if that falls on a weekend or holiday). The Secretary of State does not finalize the candidate list until June 24th, allowing ten business days for checks to clear and objections to be filed. This does not allow the County Election Officers to finalize a ballot to send to UOCAVA voters in the time required by law, often resulting in UOCAVA ballots being incorrect or incomplete.

With the passage of SB 125, moving the filing deadline from noon, June 10^{th,} to noon, June 1st, the County Election Officers would gain an additional nine days to ensure that our military and civilians stationed overseas can vote a correct and complete ballot and that the County Election Officers can provide said ballots in accordance with federal law.

Therefore, I and the Kansas County Clerks' and Election Officials' Association urge you to vote in favor of Senate Bill 125.

Testimony on Senate Bill 125

Wednesday, March 9, 2011

Thank you for the opportunity to submit testimony in support of changing the filing deadline from 12:00 noon on June 10th to 12:00 noon on June 1st.

The August Primary election is set by statute to be the first Tuesday in August. A filing deadline of June 10th makes compliance with the deadlines of other statutes at least difficult, if not impossible. Specifically, federal and state law both require that ballots be sent to military and overseas civilian (UOCAVA) voters not later than 45 days prior to any federal election. Assuming an election date of August 1st requires that we send ballots not later than June 17th. A filing deadline of June 10th leaves just 7 days before printed ballots must be mailed to UOCAVA voters.

Unfortunately, the day of the filing deadline does not result in a final certified candidate list from which we draw the information to create and print ballots. KSA 25-208a provides that the Secretary of State has 10 days from the filing deadline to certify the candidate list. The full 10 days is necessary if there are candidates who file at the deadline by petition. Verification of petition signatures can take several days. As a result, a filing deadline of June 10th means that certification of the candidate list does not occur until June 20th, well after the federal deadline. Printing of ballots for federal voters can require up to 10 more days meaning that ballots for federal voters may actually be mailed 1-2 weeks after the federal deadline.

A filing deadline of June 1st improves the likelihood that all counties can meet the federal deadline. While an optimum date may well be earlier in the month of May, June 1st gives county election officers the opportunity to have a certified list of candidates from which to prepare ballots before the federal deadline has passed.

I support Senate Bill No. 125 and recommend its favorable consideration.

Re: Senate Bill 125

I am in support of moving the filing deadline to June 1 in even-numbered years. With UOCAVA laws passed to help overseas voters get their ballots back to the US in time for the elections, the filing deadline has become a difficulty in the administration of elections. The deadline for the Secretary of State's office to certify candidates to the County Election Officers is actually <u>after</u> the deadline to mail federal service ballots. That means that the ballots send to federal service folks are 1) usually manually generated ballots and 2) not guaranteed to have the correct candidates on them as the candidates may change after the SOS certifies the list to us.

Even nine days would be helpful in ensuring the federal service voters get correct timely ballots.

Honorable Chair:

Thank you for the opportunity to testify in support of Senate Bill 125 regarding moving the candidate filing deadline from June 10 to June 1 beginning in 2014.

Military and overseas voter ballots must be mailed out 45 days before the Primary Election. In the 2014 Election cycle that will allow 8 business days from filing deadline until the ballots have to be in the mail. If an objection is filed, the time period is shortened even more possibly passing the 45 day time frame forcing Election Officers to send out ballots that are incomplete. Cowley County in a Primary Election has 120 ballot faces to check for accuracy prior to mailing. Even a few extra days would be beneficial at this crucial time in the Election cycle.

Moving the candidate filing deadline back to June 1 should not place a burden on anyone seeking to be a candidate for office while giving election officers a few more days to ensure accuracy of the ballots sent to our military and overseas voters.
