Hearing on:

HR 6020- Urging modifications to the National Broadband Plan for the benefit of rural residents of Kansas.

Matt Sterling, Revisors office, gave a brief overview to the committee of <u>HR 6020 (Attachment 1)</u>. He noted there is a printing error in the bill that includes the word Senate instead of House of Representatives.

Proponents:

Shirley Allen, Kansas Rural Independent Telephone Companies, (<u>Attachment 2</u>), spoke to the committee in favor of <u>HR 6020</u>. She gave the committee the genesis of this resolution and noted this is a bi-partisan issue and does not have a rural versus urban slant to it. She commented that in Washington D.C. the Department of Agriculture has been asked to stay out of this issue by the FCC. Kansas Rural Independent Telephone Companies has a problem with this, as agriculture is affected by the issue.

Questions were asked and comments made by Representatives: Annie Kuether, Vern Swanson, Tom Sloan, and Reynaldo Mesa.

TESTIMONY OF SHIRLEY ALLEN

Mr. Chairman and Representatives:

Thank you for the opportunity to address you today. I am Shirley Allen, representing the Kansas Rural Independent Telephone Companies.

Rural telephone companies exist, and continue to invest, because larger carriers saw no opportunity for sufficient profit in sparsely populated rural areas. The provision of basic communications service available to virtually all Americans has been achieved only through reliance on revenues from outside these high-cost areas, where affordable charges to consumers are insufficient to meet the costs of quality, reliable service.

Kansas rural telephone companies have relied on government's own commitments to meet public goals. Rural companies' long term commitments have enabled expansion of broadband availability to their rural consumers. Rural communities and rural economies face continuing challenges, and advanced communications services are crucial to any effort to arrest or reverse rural declines. Revision of policy is needed to support expansion into underserved and unserved areas, but new policy must be crafted carefully and responsibly to avoid undermining present broadband availability.

The FCC's Notice of Proposed Rule Making (NPRM) to implement the National Broadband Plan would impose untested solutions likely to prove either inadequate or excessively costly. While the plan may result in limited and marginal improvement of broadband availability in some rural areas, it would sacrifice superior results already achieved in other areas. New negative consequences are guaranteed in this plan that would dig one hole for the purpose of filling another. Both basic and advanced rural services would be put at risk, along with existing employment and investment.

HR 6025 is a resolution identical to HCR 5023, which this committee passed out earlier this session. The resolution urges Congress to continue to permit the Kansas Corporation Commission to regulate hydraulic fracturing in compliance with state regulations. The Environmental Protection Agency is currently studying the potential impacts of hydraulic fracturing on drinking water resources. The resolution urges Congress to preserve and maintain the exemption from the Safe Drinking Water Act for hydraulic fracturing.

Hydraulic fracturing is a process that results in the creation of fractures in rocks. The fracturing is done from a wellbore drilled into reservoir rock formations to increase the rate and recovery of oil and natural gas.

A hydraulic fracture is formed by pumping the fracturing fluid into the wellbore at a rate sufficient to increase the pressure downhole to a value in excess of the fracture gradient of the formation rock. The pressure causes the formation to crack, allowing the fracturing fluid to enter and extend the crack farther into the formation. To keep this fracture open after the injection stops, a solid proppant, commonly a sieved round sand, is added to the fracture fluid. The propped hydraulic fracture then becomes a high permeability conduit through which the formation fluids can flow to the well.
