The Chairman said that the purpose of the meeting was to strip the language in <u>SB 25</u> <u>Authorizing temporary licenses for on-premises sales of cereal malt beverage</u> and insert the language of <u>HB 2107</u> <u>Community defense act; sexually oriented businesses regulations</u>, making it <u>Sub SB 25</u>.

Representative Rubin made the motion to strip the language in **SB 25** and insert the language of **HB 2107** as amended by the Committee of the Whole, seconded by Representative Huebert. The motion carried.

Representative Grosserode made a motion to amend the bill to limit the bill to the provisions of New Section 4 concerning the prohibition of establishing a sexually oriented business within 1,000 feet of any school, church, day care, or other sexually oriented business, seconded by Representative Gatewood.

Mike Heim explained that the only thing that would be left of the bill would be the definition section, everything else would be gone except the section dealing with the 1,000 foot limitations.

Representative Goico made a substitute motion to pass this bill as introduced by Representative Rubin as **Sub SB 25**, seconded by Representative Patton.

Representative Huebert said that he would support the Goico substitute motion.

Representative Knox said that organized crime was involved with these businesses and he felt that it would pass on the Senate floor.

Representative Gregory said that part of our function is public protection and she supports the substitute motion.

Representative Loganbill said she would support the Grosserode motion. She said that this is a bigger problem than the bill can address. She said the subject needs more study.

Representative Brunk said that the bill does give the state some standing to ward off some of the industries that want to locate in little towns like Meriden. We passed this overwhelmingly out of the House and there are a number of Senators that want an opportunity to be able to vote on this.

Representative Rubin said that the studies have been done and I support the Goico substitute motion.

Representative Goico moved his motion. The Chairman called for the vote. <u>The substitute motion carried.</u>

The meeting was adjourned at 9:52 a.m.
