SB 122 - Authorizing the director of the Kansas Water Office to grant easements on state property on the Arkansas, Kansas and Missouri rivers

Chairman Ostmeyer opened the continuation of the hearing on SB 122.

The Committee discussed an amendment to the bill, which included:

- clarifying the definition of "conservation project";
- deleting the definition of "interest in or along the river";
- clarifying the conservation projects for which the Director of the Kansas Water Office is authorized to negotiate and grant easements on state property; and
- further defining when notice shall be given to the county or counties, and municipality or other governmental entity when an easement is proposed

Senator Bruce made a motion, seconded by Senator Love, to amend SB 122; motion passed.

There being no further discussion Chairman Ostmeyer closed the hearing and called for final action on \underline{SB} $\underline{122}$.

Senator Francisco made a motion, seconded by Senator Abrams that SB 122 as amended be passed out favorably; motion carried.

SB 124 - Concerning the Kansas Water Office; relating to water supply storage access and creating the Lower Smoky Hill water supply access program

Chairman Ostmeyer opened the hearing on SB 124.

The Committee discussed two amendments to the bill. The first amendment included language that states that the Board of Directors for the Access District shall have an odd number of directors and clarifies that at least one member of the Special Irrigation District shall serve as a director on the Board of Directors, if the Special Irrigation District is formed. The second amendment included a technical adjustment to the bill.

Senator Bruce made a motion, seconded by Senator Pilcher-Cook, to amend SB 124; motion passed.

Chairman Ostmeyer opened the hearing on ERO 36.

Robin Jennison, Secretary-Elect, Kansas Department of Wildlife and Parks, spoke in support of the **ERO** <u>36</u>. (Attachment 1) He stated the creating the Department of Wildlife, parks and Tourism would result in positive economic impact.

Becky Blake, Director of Travel and Tourism, Department of Commerce, presented testimony in support of <u>ERO 36</u>. (Attachment 2) She stated that it would allow tourism to grow strategically and cohesively.

The conferees stood for questions.

There being no further conferees, Chairman Ostmeyer closed the hearing on ERO 36.

Chairman Ostmeyer announced the next meeting is scheduled for March 3, 2011.

Good morning and thank you for the opportunity to testify here today. On behalf of the Department of Commerce and Division of Travel & Tourism, I'm pleased to appear today in support of ERO 36.

Kansas' tourism industry continues to play an increasingly important role in the state's economy. Over 31 million visitors spend nearly \$7.2 billion annually, generating over \$961,000 in state and tax revenue and supporting 125,000 jobs, 9.4% of total non-farm employment.

Tourism revenue for Kansas is obtained from many types of travelers. Whether it is the destination leisure visitor, group visitors (including meetings, conventions, participatory and spectator sports and reunions), day trippers, or the transient visitors that spend money while passing through the state enroute to another final destination, Kansas has a significant opportunity for revenue generation and we will continue to work with the industry to support all of these efforts.
