Introduction of Bills

The proposal will incorporate concepts from last year's Senate bill with a few new modifications.

Chairman Apple explained a proposed 911 fees bill dealing with prepaid wireless.

Moved by Senator Emler, seconded by Senator Lee, to approve introduction of a 911 bill on prepaid fees. Motion carried.

Chair Apple reviewed the agenda for the next two weeks and the approximate time hearings would be held on the two bills scheduled for introduction. No committee meeting will be held on January 20, 2011 as an out of town trip for all legislators is scheduled.
