SB 248 - Legislative compensation and expenses; limited to 90 days

Chairperson McGinn opened the hearing on <u>SB 248</u> clarifying that Legislative sessions, which begin the 2nd Monday of January each year, are limited to 90 calendar days in even-numbered years but are unlimited in odd-numbered years. <u>SB 248</u> applies to the regular 2011 session and eliminates compensation to legislators past the 90th day. In addition, there are no constitutional requirements conflicting with <u>SB 248</u>.

Senator McGinn asked if there was anyone who wished to speak regarding <u>SB 248</u>; there were no individuals requesting to speak. Chairperson McGinn closed the hearing on <u>SB 248</u>.

<u>Senator Vratil moved to recommend SB 248 favorably for passage.</u> <u>Senator Schmidt seconded the motion, which carried on a voice vote.</u>

Report on Budget Conference Committee

Senator McGinn provided a brief report on <u>S. Sub for SB 234</u>, which is currently under consideration by the House Appropriations and Senate Ways and Means Conference Committee. Senator McGinn reported that as of Friday, May 6, there appeared to be little movement in negotiations. Senator McGinn commented that work in the conference committee will continue, however, her proposal (for Ways and Means consideration) is to merge all outstanding issues into one bill, which would provide an alternative option for consideration.

Senator McGinn reviewed the list of "House and Senate Omnibus Positions as of May 4, 2011," that had been considered by the Senate Conference Committee and reported that with all the adjustments and compromises, the Senate proposed budget ends with a \$55.1 million balance. Discussion was heard regarding the various budget issues.

Senator Kultala suggested that language be added to prohibit the Social and Rehabilitation Services (SRS) agency from closing Rainbow Mental Health Facility. Following discussion, it was the consensus of committee members to add language that no expenditures shall be made to close Rainbow Mental Health Facility.

Senator Vratil moved to delete the contents of HB 2383 and to:

- <u>insert the contents of S Sub for SB 234 (as amended and passed by the Senate Committee of the Whole).</u>
- <u>insert the positions to which the Senate Ways and Mean and House Appropriations Conference Committee have agreed (as of the current date),</u>
- insert the Omnibus positions reviewed by the Senate Conference Committee.
- add language requiring all funding appropriated for the Early Headstart program be spent for that program only.
- add a transfer of \$6.7 million, all from the State General Fund (SGF), to the Children's Initiative Fund (CIF),

- capture \$11.7 million in death and disability payments,

- retain the undermarket pay adjustments for FY 2012.
- <u>authorize the Kansas University Engineering Phase 2 Bonding Authority in an amount of</u> \$65 million
