**CONFERENCE COMMITTEE REPORT BRIEF
SENATE BILL NO. 262**

As Agreed to March 29, 2010

Brief*

SB 262 would amend the statutes that deal with Emergency Medical Services (EMS).

The bill would change the title of EMS attendants as follows:

- “Emergency Medical Technician – Intermediate” would be changed to “Advanced Emergency Medical Technician.”
- “First Responder” would be changed to “Emergency Medical Responder.”
- “Mobile Intensive Care Technician” would be changed to “Paramedic.”

The bill would establish a scope of practice for the professions by rules and regulations established by the Kansas Board of Emergency Medical Services (Board). The professions would have to complete a course of instruction approved by the Board and be specifically authorized to perform activities by medical protocol.

Under the bill, all attendant fees for certificates would have to be deposited in the Emergency Medical Services Operating Fund. Current law requires the deposits of fees in the State General Fund.

The bill would appoint a medical advisory council of six members, including two board members and four physicians who are not members of the board, to advise and assist the board in medical standards and practices. Under current law, a medical consultant is appointed by the board. This position would be eliminated under the provisions of the bill.

The bill also would provide additional definitions and transition language for the board between enactment of the legislation and renewal of licensure of attendants.

The bill would take effect on January 1, 2011, and after its publication in the statute book.

Conference Committee Action

The Conference Committee agreed to adopt the bill as recommended by the House (H. Sub. SB 262) and to make technical changes.

Background

Proponents of the bill included the Executive Director of the Kansas Board of Emergency Medical Services, the President of the Kansas EMS Association and the Regional Coordinator for Region 1 Emergency Medical Services Council.

The President of the Kansas EMS Association testified that revamping the title of EMS attendants in Kansas would conform them to the National EMS scope of practice.

No opponents testified.

The Senate Committee of the Whole amended the bill to require the attendants' fee for certification be deposited in the Emergency Medical Services Operating Fund.

The House Committee amended the bill by providing additional transition language; added a medical advisory

council, and deleted some rule and regulation authority that the Senate had provided in the bill. The majority of the amendments to the bill were the suggested by the EMS board.

The fiscal note on the original bill indicates that the passage of the bill would have no fiscal effect on the Board.
