January 24, 2023 - Kansas House Elections Committee hearing on HB 2013, relating to the runoff elections for selected statewide races – Opposition testimony

Chairman Proctor and Distinguished Committee Members,

My name is Rick Piepho, Harvey County Clerk and Chairman of the Elections Committee of the Kansas County Clerks and Elections Officials Association (KCCEOA). The KCCEOA is a statewide organization with 109 members including 103 publicly elected county clerks, 2 charter appointed county clerks, and additionally, four election officers from the most populous counties in Kansas. Our duties are significant under statute and one of our most public facing functions is free and fair administration of elections. We take this duty very seriously.

I am submitting this testimony on behalf of the KCCEOA membership. The KCCEOA prepared a legislative agenda which was agreed to by a majority of the members. One of the items specifically included is: "Maintain the status quo with regard to election, registration and canvass schedules...".

We support maintaining the current system of electing candidates to office who receive the greatest number of votes. We foresee multiple issues with this proposed legislation, including but not limited to:

- Significant costs to conduct an extra countywide election. This would be an unfunded mandate that would be difficult to budget.
- Which results are used to determine whether a runoff is needed is not clearly defined. Some options are:
  - o Preliminary election night results which do not include all valid ballots cast
  - County Canvass results which include all ballots cast, but canvass can occur up to 13 days after an election
  - State Canvass results which include all ballots cast in every county; deadline is December 1
- Significant difficulties with conducting an additional election 28 days after General Election with limited ability to prepare in advance.
  - Very short timeframe to create and produce ballots, including programming and testing voting equipment, and to schedule and secure polling places and election workers
  - Could be difficult to comply with advance voting timelines. Advance ballots begin mailing 20 days prior to election day and Early in-person voting begins up to 20 days prior to election day
- Impossible to comply with 45 day deadline for delivery of ballots to UOCAVA/Federal Service voters

The KCCEOA opposes HB 2013 as currently presented. We ask that the committee hear our concerns and act accordingly. I will gladly stand for questions at the appropriate time.

## **2023 Legislative Priorities**

The members of the KCCEOA want to bring special focus to the following with regard to elections:

- Support manageable procedures and timelines for recounts.
- Maintain the status quo with regard to election, registration and canvass schedules and with regard to partisan/non-partisan elections.
- Advocate for protecting the integrity of the anonymous ballot.
- Advocate for measures that allow provisional ballots to be counted for registered voters who moved within the state.
- Advocate for expansion of eligibility requirements for permanent advance voting status while also making requirements more stringent for all permanent advance applicants to maintain status.
- Support initiatives which build on already secure and transparent election equipment and processes.
- Advocate for establishing lawful, consistent and workable timelines for special elections.
- Maintain local control of usage and placement of drop boxes for advance ballots.
- Ease pollworker employment restrictions for KPERS and unemployment.

The membership of the KCCEOA reviews, discusses and participates in drafting the Kansas Association of Counties (KAC) annual legislative policy. The members of KCCEOA want to bring special focus to the following with regard to county governance:

- Support allowing choice of alternate sources or methods for distributing official publications, including legal notices.
- Support elimination of newspaper publication requirement for Revenue Neutral Rate hearing notices.
- Retain and enhance county home rule authority and maintain local decision making, standing on the principle that government closest to the people will best understand and serve the community's needs.
- Support local control of property taxes.
- Oppose unfunded mandates and support state funding for any current statutory mandates.
- Support flexibility to utilize preliminary values when calculating mill levy rates for shared districts.
- Join with other county office holders in opposing deferment of payments to KPERS and the sweeping of funds intended for transportation.
