1 AN ACT concerning wildlife and parks; relating to hunting and fishing  
2 licenses; exempting disabled veterans from certain requirements;  
3 amending K.S.A. 32-906, 32-919 and 32-988 and repealing the existing  
4 sections.  
5

6 *Be it enacted by the Legislature of the State of Kansas:*

7 New Section 1. **(a) Subject to the provisions of K.S.A. 32-920, and**  
8 **amendments thereto, the secretary of wildlife and parks or the**  
9 **secretary's designee shall issue, free of charge, a permanent license to**  
10 **hunt and fish to any person residing in the state who submits to the**  
11 **secretary satisfactory proof that the person is a disabled veteran. Any**  
12 **such person hunting or fishing in this state shall be subject to the**  
13 **provisions of all rules and regulations relating to hunting or fishing.**

14 **(b) As used in this section, "disabled veteran" means a person**  
15 **who:**

16 **(1) Was a member of the armed services;**

17 **(2) has separated from the armed services under honorable**  
18 **conditions; and**

19 **(3) has a disability certified by the Kansas commission on**  
20 **veterans affairs office as being service-connected and such service-**  
21 **connected disability is equal or greater than 30%.**

22 ~~Section 1.~~ **Sec. 2.** K.S.A. 32-906 is hereby amended to read as  
23 follows: 32-906. (a) Except as otherwise provided by law or rules and  
24 regulations of the secretary *of wildlife and parks*, a valid Kansas fishing  
25 license is required to fish or to take any bullfrog in this state.

26 (b) The provisions of subsection (a) do not apply to fishing by:

27 (1) A person, or a member of a person's immediate family domiciled  
28 with such person, on land owned by such person or on land leased or  
29 rented by such person for agricultural purposes;

 8 the department, during the period of time that the fishing clinic is being  
 9 conducted; ~~or~~

10       ~~(8)~~ *a disabled veteran who lives in Kansas.*

11       (c) The fee for a fishing license shall be the amount prescribed  
 12 pursuant to K.S.A. 32-988, and amendments thereto.

13       (d) Unless otherwise provided by law or rules and regulations of the  
 14 secretary, a fishing license is valid throughout the state.

15       (e) Unless otherwise provided by law or rules and regulations of the  
 16 secretary, a fishing license is valid from the date of issuance and expires  
 17 on December 31 following its issuance, except that the secretary may issue  
 18 a:

19       (1) Permanent license pursuant to K.S.A. 32-929, and amendments  
 20 thereto;

21       (2) lifetime license pursuant to K.S.A. 32-930, and amendments  
 22 thereto;

23       (3) nonresident fishing license valid for a period of five days; and

24       (4) resident or nonresident fishing license valid for a period of 24  
 25 hours.

26       (f) The secretary may designate by resolution two days each calendar  
 27 year during which persons may fish by legal means without having a valid  
 28 fishing license.

29       (g) (1) The secretary shall issue an annual institutional group fishing  
 30 license to each facility operating under the jurisdiction of or licensed by  
 31 the secretary for aging and disability services and to any veterans  
 32 administration medical center in the state of Kansas upon application by  
 33 such facility or center to the secretary of wildlife; ~~and parks and tourism~~  
 34 for such license.

35       (2) All applications for facilities under the jurisdiction of the  
 36 secretary for aging and disability services shall be made with the approval  
 37 of the secretary for aging and disability services and shall provide such  
 38 information as the secretary of wildlife; ~~and parks and tourism~~ requires.  
 39 All applications for any veterans administration medical center shall be  
 40 made with the approval of the director of such facility and shall provide  
 41 such information as the secretary of wildlife; ~~and parks and tourism~~  
 42 requires. Persons who have been admitted to and are currently residing at  
 43 the facility or center, not to exceed 20 at any one time, may fish under an

1 institutional group fishing license within the state while on a group trip,  
2 group outing or other group activity which is supervised by the facility or  
3 center. Persons fishing under an institutional group fishing license shall not  
4 be required to obtain a fishing license but shall be subject to all other laws  
5 and to all rules and regulations relating to fishing.

6 (3) The staff personnel of the facility or center supervising the group  
7 trip, group outing or other group activity shall have in their possession the  
8 institutional license when engaged in supervising any activity requiring the  
9 license. Such staff personnel may assist group members in all aspects of  
10 their fishing activity.

11 (h) (1) The secretary may issue a special nonprofit group fishing  
12 license to any community, civic or charitable organization which is  
13 organized as a not-for-profit corporation, for use by such community, civic  
14 or charitable organization for the sole purpose of conducting group fishing  
15 activities for handicapped or developmentally disabled individuals. All  
16 applications for a special nonprofit group fishing license shall be made to  
17 the secretary or the secretary's designee and shall provide such information  
18 as required by the secretary.

19 ~~(2) Handicapped or developmentally disabled individuals~~ *Persons*  
20 *with a physical or developmental disability*, not to exceed 20 at any one  
21 time, may fish under a special nonprofit group fishing license while on a  
22 group trip, outing or activity which is supervised by the community, civic  
23 or charitable organization. Individuals fishing under a special nonprofit  
24 group fishing license shall not be required to obtain a fishing license but  
25 shall be subject to all other laws and rules and regulations relating to  
26 fishing.

27 (3) The staff personnel of the community, civic or charitable  
28 organization supervising the group trip, outing or activity shall have in  
29 their possession the special nonprofit group fishing license when engaged  
30 in supervising any activity requiring the special nonprofit group fishing  
31 license. Such staff personnel may assist group members in all aspects of  
32 their fishing activity.

22       (c) The fee for a hunting license shall be the amount prescribed  
23 pursuant to K.S.A. 32-988, and amendments thereto.

24       (d) Unless otherwise provided by law or rules and regulations of the  
25 secretary, a hunting license is valid throughout the state, except that the  
26 secretary may issue a special controlled shooting area license ~~which that~~ is  
27 valid only for licensed controlled shooting areas.

28       (e) Unless otherwise provided by law or rules and regulations of the  
29 secretary, a hunting license is valid from the date of issuance and expires  
30 on December 31 following its issuance, except that:

31       (1) The secretary may issue a permanent license pursuant to K.S.A.  
32 32-929, and amendments thereto; *and*

33       (2) the secretary may issue a lifetime license pursuant to K.S.A. 32-  
34 930, and amendments thereto.

35       (f) A 48-hour waterfowl permit may be issued which authorizes  
36 hunting of waterfowl in this state subject to all other provisions of law and  
37 rules and regulations of the secretary. The fee for such permit shall be the  
38 amount prescribed pursuant to K.S.A. 32-988, and amendments thereto.  
39 Such permit is valid throughout the state, is valid from the time designated  
40 on the permit and expires 48 hours after such time. Purchase of such  
41 permit shall not affect the requirement to purchase any federal migratory  
42 bird hunting and conservation stamp or state migratory waterfowl habitat  
43 stamp.

12 (b) The fee for a landowner-tenant resident big game or wild turkey  
13 hunting permit shall be an amount equal to  $\frac{1}{2}$  the fee for a general resident  
14 big game or wild turkey hunting permit.

15 (c) The fee for a big game or wild turkey hunting permit for a resident  
16 under 16 years of age shall be an amount not to exceed  $\frac{1}{2}$  the fee for a  
17 general resident big game or wild turkey hunting permit.

18 (d) The fee for a furharvester license for a resident under 16 years of  
19 age shall be an amount equal to  $\frac{1}{2}$  the fee for a resident furharvester  
20 license.

21 ~~(e) For a resident who is at least 65 years of age, but less than 75~~  
22 ~~years of age:~~

23 ~~(1) The fee for an annual hunting license shall be an amount equal to~~

34 **(2) the fee for an annual fishing license shall be an amount equal**  
35 **to  $\frac{1}{2}$  the fee for a general annual fishing license; and**

36 **(3) the fee for an annual combination hunting and fishing license**  
37 **shall be an amount equal to  $\frac{1}{2}$  the fee for a general annual**  
38 **combination hunting and fishing license.**

39 **(f) Any person who is a resident of this state and satisfies the**  
40 **requirements to be considered a disabled veteran under K.S.A. 32-906 and**  
41 **32-919 section 1, and amendments thereto, shall be exempt from the**  
42 **hunting and fishing license fees listed in subsection (a).**

1 accordance with K.S.A. 32-805, and amendments thereto, different fees for  
2 various classes and types of licenses, permits, stamps and other issuances  
3 of the department which may occur within each item as described under
