SB 213, AN ACT concerning wildlife; relating to hunting; prohibiting nonresidents from hunting migratory waterfowl during the hunting season except on Sundays, Mondays and Tuesdays; applying such restriction to department lands and waters, federal lands and waters managed by the United States army corps of engineers at specified reservoirs, the bureau of reclamation at certain reservoirs and the United States fish and wildlife service at designated refuges; exempting properties designated as walk-in hunting access areas, navigable rivers in Kansas and the conservation order for light geese season from such restriction; reducing fees for migratory waterfowl habitat stamps; amending K.S.A. 32-939 and K.S.A. 2024 Supp. 32-988 and repealing the existing sections.

SB 262 — Requiring government agencies, public utilities and other entities when exercising the power of eminent domain to make a good faith offer for the property prior to filing an eminent domain action, providing the good faith offer, if greater than the appraiser's award, shall be deposited with the court, allowing appeals from that amount, prohibiting the exercise of eminent domain for recreational trails and park and recreational facilities and deleting the power of the legislature to condemn property for economic development.
