#### REPORTS OF STANDING COMMITTEES

Committee on **Judiciary** recommends **HB 2134**, As Amended by House Committee, be amended on page 2, in line 15, after "(4)" by inserting "Upon request, a public agency shall provide to the person requesting access to or copies of public records pursuant to this section an itemized statement of costs incurred by the public agency and charged to such requester. Such itemized statement shall include, but not be limited to, the hourly rates charged for each employee involved in making the requested records available and an itemized list of any other fees charged to provide access to or furnish copies of the requested records.

(5)";

And by redesignating subsections, paragraphs, subparagraphs and clauses accordingly; and the bill be passed as amended.

Also, **HB 2183**, As Amended by House Committee of the Whole, be amended on page 6, in line 41, by striking the second "and"; in line 42, after "522" by inserting ";

- (6) a provider of direct-to-home satellite services, as defined in 47 U.S.C. § 303(v); and
- (7) a multichannel video programming distributor, as defined in 47 U.S.C. § 522(13), or an affiliate thereof"; and the bill be passed as amended.

**HB 2212** be amended on page 2, in line 30, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.

**HB 2371**, As Amended by House Committee, be amended on page 60, in line 5, by striking "statute book" and inserting "Kansas register"; and the bill be passed as amended.
