Dear Representative Tarwater and Members of the Committee,

On behalf of Overland Construction Group (OCG), a Kansas based and run construction company I am writing to express our opposition to House Bill 2119. OCG has completed one construction project in Salina, The Preserve at Oakdale Senior Village (137 units) that involved state housing tax credits in December, recently and under construction on a second in Winfield Kansas, St. James Court (100 units).

HB 2119 would not only cause total construction to stop on the development under construction - St. James Court in Winfield, Kansas, but, it would undoubtedly create tremendous financial strain on our small company, not to mention the countless small Kansas businesses that are sub-contractors on this development. We have attached a list of the sub-contractors on these two projects to show the reach this bill would have causing irreparable damage and likely bankruptcy and closure for many of us.

Working construction in many small Kansas communities, we see the housing crisis constantly with very little improvement, until recently. With this new tool we have seen tangible results happening and progress for the first time. However, HB 2119 would not just take us back to the prior time, it would set our state back 20+ years decimating the already limited small Kansas based sub-contractors and contractors, not to mention the developers which there aren't many of any more since the great recession.

We strongly but respectfully ask you to not advance HB 2119 and to consider the small Kansas businesses and our employees. We have seen firsthand that these developments don't and didn't happen without this new resource. Not to mention what would happen if the rug was ripped out from under all of us, if our home state went back on a commitment of funding that we all trusted and is critical for us to finish these jobs and not be thrown into financial peril.

We respectfully oppose HB 2119 and instead consider amendments that provide a more balanced and sustainable solution. Thank you for your time and consideration of this critical issue.
