KSDE Required Dyslexia Modules



Overview

This training is required for any educator new to teaching, or new to teaching in Kansas who had not had the previous KSDE required training modules in a previous district and who hold the license or endorsements listed below. This is required training and content should be delivered using these modules and **all** information included. There are included activities that accompany this training described in the facilitation guide and accompanying participant handouts. However, districts are free to add **additional** meaningful activities relevant to your local context if they so choose. Module 1 provides a template to encourage schools or systems to customize information so new teachers feel confident in how they meet KSDE requirements and your district expectations.

This training is also recommended for paraeducators and/ or others in your system who assist with literacy instruction and support.. Documentation for completion of this training should be kept by both attendee and district. Completion of this training is currently verified on the SO66 report and may be used when completing documentation for school improvement and/ or accreditation through KESA 2.0. This training consists of five modules with supportive materials and activities. There is also an accompanying Padlet (Password is KSDE) that can be used to support this training and also used for continued professional learning in building and/ or district PLCs.

For Module 4, facilitators may choose the version that works best with the audience in attendance for the training. There is the option to use the Elementary Module, the Intermediate/ Secondary Module or a module that combines the content to address educators from all grade levels. Only one version of Module 4 needs to be completed. Resources to assist in this training include:

- high incidence special education and teaching in grades K-12,
- ELA grades 5-12,
- reading specialists
- school psychologists
