Good evening,

Thank you for considering the opposition testimony regarding the impact of school voucher tax credits on public education and state tax policy. I would like to highlight the fact that there is no evidence and have been no studies to prove that this tax credit scholarship is even working or improving student outcomes (no oversight or data shared) to warrant expanding the program, the proposed changes to the tax credit scholarship program allow for private schools to not need to select at-risk students enrolled in the public schools for the scholarships, and this program already poses risks to the state general fund which impacts our public education system. Why is this body spending so much time inventing new ways for the wealthy to avoid paying taxes, especially when 92% of Kansas families rely on our public schools?

One of the most concerning shifts in education policy in recent years has been the growing movement to privatize the nation's K-12 education system through the expansion of state-funded school vouchers. A key driver of this trend is the use of state voucher tax credits, these tax credits reimburse individuals and businesses for contributions made to organizations that provide tuition vouchers for private schools. Unlike traditional charitable giving, these credits allow taxpayers—often wealthy individuals and corporations—to recoup the full amount of their "donation," effectively redirecting tax dollars away from public education.

Rural students and communities are harmed as public school resources are drained and students in rural areas lack little to no private options. The Tax Credit Scholarship program primarily benefits those in urban areas of our state. Rural taxpayers will end up subsidizing private school tuition for families in metro areas such as Johnson County, Wichita, and Topeka.

Before recent IRS regulations were implemented, private schools and financial advisors openly marketed these credits as a way to generate financial gain, with some organizations encouraging donors to "make money" by stacking state tax credits with federal charitable deductions. While the IRS has taken steps to close this loophole, new tax avoidance strategies have emerged, including the use of the federal business expense deduction in conjunction with state tax credits, further exacerbating the diversion of public funds to private institutions.

Recent data obtained from tax agencies in Arizona, Louisiana, and Virginia

underscore the inequities of these programs. In each of these states, more than half of all voucher tax credits are being claimed by families with annual incomes exceeding \$200,000. This reality directly contradicts the argument that these programs primarily serve low- and middle-income students. Instead, they function as a tax shelter for high-income earners while undermining the funding base of public education.

Our tax dollars should not go to private schools that lack oversight, leaving the public uninformed as to whether or not our tax dollars are really being spent to improve the lives of children. There are no controls in place to ensure eligible at-risk students who apply for a scholarship are granted one, as private schools are allowed to set their own admission standards. And there are no controls in place to ensure those who do receive scholarships receive a quality education. Kansans expect accountability for our tax dollars.

To address these concerns, I urge the committee to consider the following policy solutions:

Repealing voucher tax credits – These credits serve no legitimate public purpose and disproportionately benefit the wealthiest taxpayers at the expense of public education.

Preventing tax avoidance – If outright repeal is not feasible, states should adopt reforms to ensure that contributions made under these programs do not qualify for federal business expense deductions or other tax benefits that result in profit-making. Illinois has already implemented such a provision, which could serve as a model for other states.

Ensuring transparency and accountability – States should require comprehensive reporting on the income distribution of credit recipients and the financial impacts of these programs on public education funding.

Ultimately, the best way to ensure a fair and sustainable public education system is to maintain strong public investment in our schools rather than incentivizing the redirection of public dollars to private entities. I urge this committee to carefully consider the implications of voucher tax credits and take decisive action to protect public education.

Chair Estes and Members of the Committee, thank you for the opportunity to provide opponent testimony for House Bill 2136 on behalf of Mainstream.

Mainstream OPPOSES HB2136. This proposal is an attempt to divert funds from public schools to benefit those who make the choice to enroll their children in private, often religious, schools. This diversion of public funds is another state-sponsored attempt to undermine public schools and favor private, often religious ones.

HB2136 is an expansion of a program beyond its original intent to serve low-income students. Already, the program has been expanded to include students with higher income levels (up to 250% of the federal poverty level which is above the KS median household income). Even before that expansion, only a small percentage of eligible students (approximately 0.5% in 2023) have applied for and received these so-called "scholarships." HB2136 would now expand it even further to include students who have never attended a Kansas public school. **No other state program would receive such a push for expansion so quickly with these results.**

Not only does HB2136 expand student eligibility, but it also increases the tax credit from 75% to 100%. Wealthy donors can essentially get a complete tax write-off for their contributions to a program that only a very small percentage of Kansas students participate in. **These are dollars that should be going to the state general fund which funds public goods, such as public education, and not back into the pockets of wealthy individuals.**

Public schools are accessible to and held accountable by all Kansans. Proposals like HB2136, and other tax credit and voucher programs, benefit those families who choose to enroll their students in private or home schools. These institutions often have limited or no accountability, can discriminate against potential students during the enrollment process, and center religious teachings – and do so at the expense of our general fund and public school funding. This is bad for our schools and for our students who do not fit into specific religious world views.

Kansas residents represent a plurality of religious beliefs and practices, and under the Establishment Clause of the First Amendment, we are protected from our government essentially funding religious institutions. Recent court cases around vouchers continue to

dissolve this fundamental principle of our country's founding, and HB2136, with its inclusion of students who have never attended public school as beneficiaries, is pushing even harder at this wall with the intent to fully break it down.

HB2136 essentially mandates that Kansas residents participate in the diversion of tax dollars away from public schools and into often religious institutions, making Kansans now donate or tithe to churches to which they don't belong.

It also promotes a very specific view of the world that can be based on narrow, extremist religious teachings that don't represent the beliefs of many people of faith. Three of the most popular US textbooks and curricula used by Christian schools and homeschools have been shamed publicly for the way they teach things like science and history. At one point, an Accelerated Christian Education or ACE textbook, taught that the Loch Ness monster is real, and a modern day dinosaur as proof of creationism. These text books have taught that slavery was "black immigration", that Native Americans are savages, primitives, or demon worshipers, as well as presenting negative views of the LGBTQ+ community, non-Christians, and others. Since private schools are not held to the same expectations and standards as public schools, even if students in Kansas are not being taught these things, there's no protection against it and no way to stop it.

I am writing to voice my opposition to bill number HB 2136.

Thank you in advance for reading my testimony. I am a parent of a child with an IEP enrolled in the Shawnee Mission School District. This bill would divert tax money to private schools that have no requirement to serve students with disabilities. In fact, the vast majority of private schools are not at all equipped to serve students with significant support needs, and they will refuse admission to those students. I am a parent of a student with significant support needs. Even if I wanted to take advantage of this program, I would NOT be able to, because there is no school in the state of Kansas that would accept my child. How do I know this? I know this because I am a former private school teacher, and I witnessed how heartbreaking it was to see families have one child accepted to the school, and the other sibling rejected on the basis of disability.

Even if she were allowed, most of those schools are religious schools, specifically Catholic, and I would be a fool to enroll my child, who is already extremely vulnerable to sexual abuse, in any institution that is frankly dangerous for children. A 2023 report released by the Kansas Bureau of Investigation identified 188 clergy in the state "suspected of committing various criminal acts," including aggravated criminal sodomy, rape, aggravated indecent liberties with a child and aggravated sexual battery. This is during a period going all the way up to 2022. These were crimes that were covered up by the dioceses – a pattern we have seen all over the United states. My child cannot reliably report sexual abuse. I would never, ever put her in this situation.

Our tax dollars should absolutely not be funneled into any religious institution, but especially those that have been proven to be criminally negligent in the protection of children.

We should not be reducing state revenues by providing tax credits that funnel money to private schools that can pick and choose which children they want to serve.

Private schools can choose to admit only the best and brightest students, leaving other children behind.

Our tax dollars should not go to private schools that lack oversight, leaving the public uninformed as to whether or not our tax dollars are really being spent to improve the lives of children.

There are no controls in place to ensure eligible at-risk students who apply for a scholarship are granted one, as private schools are allowed to set their own admission standards. And there are no controls in place to ensure those who do receive scholarships receive a quality education. Kansans expect accountability for our tax dollars.

HB 2136/SB 87 are tax avoidance mechanisms for the superrich. Those donating up to half a million dollars to the Tax Credit Scholarship program receive a tax credit of 75% of their donation. For the largest donations, our state's coffers are reduced by \$375,000. These bills expand that to 100% tax credit for donors, i.e., for a \$500,000 donation, the donor can take \$500,000 off what they owe in taxes—a dollar for dollar benefit to rich donors and an incentive to them to undermine public schools.

In Kansas our private schools educate a small fraction of our population. This Tax Credit Scholarship in 2023 went to only 1,340 students in Kansas despite the fact that more than a quarter of a million Kansas students were eligible for it. **Expansion is clearly not needed**. This program, particularly with this bill's expansion, hurts Kansas kids by incentivizing a switch to public schools. Public schools are the lifeblood of democracy. Madam Chair, Members of the Committee:

I am a Kansas resident and proud parent of three public school graduates. I am writing today because I believe this committee should stay focused on ensuring that Kansas public schools – which must welcome and serve every Kansas child – remain the focus of this committee. I am opposed to this bill and any other that seeks to harm children and financially undermine public schools as this one does.

There Is Harm

Fiscal Harm

There are some who say that because this program doesn't take money *directly* away from the General Fund or because it is money that the state *never received* in the first place it is somehow not taking money away from the state so there is no fiscal harm. This is a particularly cynical and self-serving view which deliberately ignores the fact that tax credits are a significant reduction in a tax bill and therefore a significant reduction in state revenue that would otherwise be received and spent on public education and other services.

Harm to Children

Voucher programs encourage the dismantling of public education by bribing Kansans with tax relief to remove their children from public schools and place them in private schools. Our Kansas public schools are publicly accountable and have layers of oversight to ensure children are safe and that they receive a fact-based, dogma-free, quality education. Private schools in Kansas, on the other hand

- are not subject to public oversight
- · can have bigoted and discriminatory selection processes
- can teach objectively false information
- · may promote religious dogma
- may be staffed by unqualified persons.

Allowing millions in tax dollars to evaporate by offering tax credits to families for private school choices without any mechanism to ensure the selected private educations meet minimum state standards for curricula, educational progress, and safety is a dereliction of this committee's obligation to protect Kansas children and ensure all Kansas children receive a quality education.

Where Does the Costly Program End?

It strikes me that this year's version of the bill is larger than previous years' both is the credit percentage and the number of children eligible to participate. How big will we let this program get? This year's version increases the cap, increases the tax credit percentage to 100% and includes more categories of applicants. It is clear that growing the program is the plan, not solving a specific education problem. The more kids that qualify, the easier it is to justify raising the cap. While \$20 million may seem an expendable amount today, what is to keep the legislature from raising the cap to \$50 million or \$500 million? What happens when the cost of

this second, poorly regulated, education funding mechanism becomes a financial burden to the state? Will you cut the program or will you attack public education costs and strip even more from our public schools? Why do you want to create two competing education systems that results in both a funding and quality crisis? Arizona is a perfect example of how this will end – ballooning education costs, poorer educational outcomes, angry citizens.

Public schools are one of Kansas' strengths. If this committee sees room for improvement in Kansas public schools, then please work to make those improvements so all Kansas children can benefit and thrive. Do not continue this effort to strip schools of children and resources. Families wanting an educational experience outside the public schools should always have that option to do so. However, I urge you to remember it is not the obligation of the state to fund or financially reward private choices made in lieu of public services and to vote NO on this bill

Chairperson Estes, members of the Committee:

Thank you for the opportunity to testify in opposition to HB 2136.

Kansas NEA is a member-driven organization that represents all 40,000 educators in the state of Kansas. We have nearly 22,000 members. The positions we advocate for have been proposed, debated, and adopted by several hundred members that were selected by their peers to attend our annual Representative Assembly.

Our members have a strong stance on vouchers that is quite clear. The first part of that resolution reads:

Kansas NEA believes that voucher plans, tuition tax credits, or funding formulas that have the effect of financing private education with public funds, undermine support for public schools. Such programs could lead to racial, economic, and social isolation of students and weaken or destroy the public school system.

The Low-Income Student Scholarship Program is a voucher program that diverts public funds to private schools.

The KNEA resolution on vouchers continues to state:

KNEA acknowledges that it is the right of parents/guardians to choose to send their students to private schools...

...KNEA further believes that any private school or agency that receives public funding through voucher plans, tax credits, or other funding/financial arrangements must be subject to all accountability measures and regulations required of public schools.

HB 2136 does not ensure that private schools that receive public funds are held to the same standards as public schools. As a matter of fact, HB 2136 doesn't require any language regarding accountability, measurement, licensure, accreditation, assessment, or service requirements. The omission of such language is another reason that KNEA opposes this bill.

In closing, the most painful part for teachers when talking about such bills is the rhetoric seems to follow them. These proposals always appear to be predicated upon the assumption that public schools and, in turn, public school teachers are not thriving to meet the needs of Kansas children. This is not the case.

Chair Estes and Members of the Committee,

Thank you for allowing me to share my opponent testimony against HB 2136. My name is Marcel Harmon, and I am a voter in Douglas County. I am writing today to encourage the committee to vote no on HB 2136.

Both of my kids attended public school (USD 497) with the youngest graduating high school in 2023. I'm a former school board member of USD 497. I have volunteered on local and state education committees and tasks forces for a large portion of my adult life, and as a consultant have spent a significant amount of time in public schools for most of my professional career. My parents were both public school teachers (my mom was also a grade school librarian). I know the value of public education to the state of Kansas and its importance to the vitality of our communities.

I have grouped my opposition points into the following topics.

Expansion of the Tax Credit Scholarship Program:

- Why does the program need to be expanded when there are still hundreds of thousands of students still eligible under the current guidelines who are not utilizing scholarships?
- Expanding the program to private school students will only take opportunities from the very students the Tax Credit Scholarship program was intended to help. *Instead of expanding, accountability should be added to the program to understand why these at-risk students aren't receiving scholarships*.

- Increasing the tax credit to 100%, by providing special tax treatment to the doners of this program, provides a greater incentive to funding private schools versus donating to other very worthy nonprofits. They should all be on an equal playing field relative to tax incentives.
- The current tax credit of 75% already is already a huge benefit to those choosing to funnel their tax dollars to private schools. Expanding the tax credit to 100% allows these taxpayers, especially the wealthy, to completely avoid paying taxes in the state of Kansas.

Public tax dollars belong with public schools:

- Public tax dollars should remain with our public schools primarily because a) they accept
 and educate ALL children (private schools can pick and choose which children they want to
 serve) and b) they are accountable to the taxpayers. Accountability is a critical part of
 spending public dollars, as many conservative legislators are fond of pointing out. Private
 and homeschools lack the oversight necessary to confirm whether or not our tax dollars are
 really being spent to improve the lives of children.
- Expanding the Tax Credit Scholarship Program will divert even more funds from public education to subsidize private education, have the same negative impact as a voucher program. This diversion of funds harms public education along with the students served by public schools. This can be particularly harmful for our rural communities as their resources are drained, with little to no private options available. Rural taxpayers will end up subsidizing private school tuition for urban families.
- Instead of providing tax credits to Kansans who choose not to send their kids to public school, the legislature should be using those tax dollars to fully fund special education (currently underfunded by \$173 million).
- Families with children with special needs, disabilities, or those for whom English is not their first language will not benefit from this tax credit expansion as few private schools can accommodate their needs. And taking money away from public schools will make it harder for them to adequately meet the needs of these families and their students. This is extremely inequitable, negatively impacting many of those already struggling the most.

Vouchers are welfare for the wealthy:

Vouchers, tax credit scholarships, etc., take money that could be used to strengthen our public schools that serve all kids and gives it to families who have made a private choice to receive a religious or other non-public education, many who can easily afford that choice.
 This program already allows for tax avoidance, especially for wealthy donors. Expanding the tax credit to 100% is even more egregious. The Tax Credit Scholarship program, like most voucher programs, is welfare for the wealthy.

Public schools are a public good:

- A strong public education system benefits ALL of society, not just the individual students who make use of it. This is because public schools are a public service a common pool resource providing good quality education to EVERYONE, regardless of socio-economic status. A strong public education system ensures we have citizenry capable of maintaining our communities and society as a whole. The potential consequences of diverting public tax dollars to those who choose to homeschool or send their kids to private school undermines the state's ability to fund our public schools, potentially leaving an underfunded public school system and putting this critical common pool resource at risk.

Chair Estes, Vice-Chair McNorton, Ranking Minority Member Stogsdill and members of the House Education Committee, thank you for the opportunity to provide opposition testimony on HB 2136 on behalf of Kansans for Excellence in Education.

We oppose this legislation in that we see this as a back-door way to pass a full blown voucher system in Kansas at the expense of public schools. Increasing the tax credit from 75% to 100% and doubling the permanent cap from \$10,000,000 to \$20,000,000 reduces the revenue available for the state to fund public education and siphons those funds to private schools. When school districts are starved of funds to educate students who require special services, it hurts every public education student and local community.

Kansans for Excellence in Education, which is a non-partisan group supporting the success of all students, believes public dollars, even in the form of tax credits, should be invested in our public schools, and not be siphoned off to private schools, which can pick and chose which students they accept and are not overseen in the same way that legislators have demanded public schools be overseen.

Rural areas will be especially hard hit as funds desperately needed for districts that cover huge swaths of land, but smaller populations, can see budget cuts when the SGF is being starved of funds. The \$20,000,000 cap is greater than the overall operating budgets of districts the size of Girard and Hugoton. Apart from USD 457 Garden City, the 20 largest USDs by square mileage all have total operating budgets below \$20,000,000 to put this cut into the SGF into perspective.

I write in opposition to HB 2136 as it is fiscally irresponsible for the state to, through tax credits, assume additional expenditures that were previously covered by private sector spending. The bill is stretching beyond its original intent to support low-income families; with the proposed expansion, the committee is creating an entitlement that neglects your fiduciary duty that transparency accompanies the collection and spending of tax dollars.

Concerns about the bill's philosophy:

Choosing not to engage with a public service does not mean that one is entitled to the monies that support that public good.

- The state park near me is not to my liking, but there are private country clubs near me. Can I claim a tax credit that may be larger than my tax assessment and receive a refund from the state to pay for private club dues? **No.**
- I disagree with the Kansas Attorney General's use of time and resources to pursue cases restricting voting practices when there is no material evidence of voter fraud. Can I claim a tax credit for my tax dollars that fund the Attorney General's Office because we don't share the same "values"? **No.**

Opting out or disagreeing with a public good does not mean I am entitled to monies that support public goods and services.

Concerns about the bill's logistics:

- Program expansion is ripe for abuse by tax-avoiders: In economic terms, tax credits are incentives. This bill's promise of a dollar-for-dollar reduction in a taxpayer's tax liability and expansion of the income limit extend a benefit meant for low-income families to higher-income families. "Donors" funnel money to private schools and are reimbursed in full by the state.
- No data: I appreciate that there are stringent guidelines for how tax funds are spent. If dollars that were going towards a public good are directed to a private entity, most reasonable people would expect for the standards and reporting would be equivalent. There are no such mechanics in this bill. How will we know if the program is "successful"? Trust, AND verify.

Concerns about the bill's impact:

• Transference of tax burden from rural to suburban areas: Given that over half of Kansas counties do not have a single private school, it's highly likely that this bill would supplement the Kansas families who already pay private tuition in more populated areas like the Wichita metro area and Johnson County.

My professional success in the finance and investment management industry is a testament to the high-quality public education I received. After 15+ years working at hedge funds and asset managers, I know full well that transparency and oversight are vital parts of prudent fiscal policy. HB 2136 lacks a way to assess if taxpayer dollars credited and thus diverted to private or home schools are being used properly or measured.

I respectfully request that you vote no on HB 2136. Please do not create a financial entitlement and neglect your fiduciary duty to Kansas students, 90% of whom benefit from our public education system. Transparency should accompany the collection and spending of tax dollars.
