My husband and I rely heavily on the great education our children receive in the public school system. Not only general education, but the special education two of our three children have needed have allowed them to be successful and thriving students today. This will only help them to be intelligent and good contributing members of our community, state and country in the future. When my husband and I moved to Kansas City 11 years ago, we sought out the best public schools, not only for our children's education, but also knowing that strong public school systems create strong educated and economical communities. Public funds **DO NOT** belong in private schools. This is why **I STRONGLY oppose HB 2136** that would divert public funds into private schools.

Expanding the program to private school students, leaves fewer spots for the at-risk students the program was again intended to help.

I am writing to voice my opposition to bill number HB 2136.

This program has the same pitfalls as any other voucher scheme as it diverts **public** tax dollars to <u>private schools that lack oversight and are allowed to discriminate in admissions</u>. The state government should not allow such lack of oversight and discrimination in any school which accepts public tax dollars, whether directly from taxes or, in this case, from a diversion of public tax dollars.

Additionally, it is a lucrative tax avoidance scheme that is especially beneficial to corporations and wealthy donors. Allowing the such entities to reduce their taxes to benefit private schools should not be allowed.

The expansion proposed by HB 2136, the Tax Credit Scholarship program, is clearly not needed.

Plenty of students under the current guidelines are still eligible for the Tax Credit Scholarship program. There is no need to expand. In fact, expanding the program to private school students will just take limited spots from at-risk students who supposedly were the ones in need.

In 2023, only 1,340 students were participating despite 230,000 public school students being eligible. There were not significant changes to these numbers in 2024.

Because there is no data or accountability within the Tax Credit Scholarship program, we don't know if eligible students:

- applied to a private school and were denied admission because of their religion
- applied to private school but couldn't pass academic admission criteria
- live in one of the 60+ counties in Kansas where there are no private school options
- have special needs that private schools aren't required to accommodate
- are happy with their public schools and thus there is no real need for this voucher program

These voucher programs aren't available to all. **Most importantly**, public dollars belong to our public schools that accept and educate all children. Diverting our state general funds to private schools undermines public education funding.

I am writing to voice my opposition to HB 2136. Despite being called a "tax credit," it's still a voucher program that will cut revenue to our public schools, causing harm to Kansas public schools and shortchanging the education of our youngest Kansans.

Here are a few reasons why educational "tax credits" or vouchers are bad for Kansas's public schools.

- They hurt student achievement. In states that have implemented a similar program, unaccredited school vouchers hurt student achievement more than the 2020 pandemic (sources below).
- They undermine public schools. They divert resources away from public schools, attended by 90% of students, to fund the education of a few select students.
- Private school tax credits or vouchers do not offer real choice. Private schools can choose their students. Public schools are bound by law to accept all students.

<u>Stand Up Blue Valley: Families for Our Schools</u> is a parent and patron advocacy group in the Blue Valley School District. We advocate for legislation that supports Blue Valley Schools and work to help our community understand the importance of their votes to our schools.

We oppose any diversion of tax money to private schools. We oppose any expansion of the Tax Credit Scholarship Program, and we oppose the addition of any other program to divert tax money away from public schools to private schools.

Stand Up Blue Valley opposes the provision in HB 2136 that would increase the tax credit from 70% tax credit to 100%. This would allow a donor to pay into a private school tuition fund and credit **every penny** of that payment toward their Kansas taxes. This type of tax credit is not available to any taxpayer for any other donation, no matter how philanthropic. **Assigning this very special designation to the funding of private schools is not in the best interest of any Kansas student, any Kansas school district, or any Kansas citizen - other than the few who will use this to their financial benefit as they fund private schools of their own choosing.**

HB 2136 would **add eligibility** for students whose parents meet certain arbitrary employment or vocation specifications and students who are *or ever were* in foster care. These designations serve only to increase the number of students eligible for this unproven program. **There is no evidence to support the notion that private school education would benefit the added categories of students, like the students originally designated for program inclusion.**

Private schools often include religious curriculum. While we fully support the right of parents to send their students to any religious school they choose, we don't believe our tax dollars should be paying for religious education.

Private schools are not required to accept or retain any student. We are aware of Blue Valley families whose special needs students were not able to attend BV-area private schools due to their needs not being met there. Expansion of eligibility for students to use Tax Credit Scholarships to attend private school expands the ability of private schools to benefit from accepting/choosing students who are easier to educate and leaving a disproportionate number of students with learning disabilities, physical differences, and behavioral issues for public schools to educate.

Blue Valley taxpayers understand that our taxes go to support our excellent public schools, which provide a quality education to over 22,000 students, support over 3000 jobs in our area, and turn out graduates who return to enhance our community. Our Blue Valley Schools are the backbone of our local economy and result in high home values as businesses and people move here for the schools. We disagree with the premise that some taxpayers would be allowed to get a credit on their taxes (thereby lowering the amount of taxes they are paying) in order to use their money to fund private schools. We disagree with the premise that private schools should be given tax money.

If philanthropically-minded individuals wish to fund scholarships for low income students to attend private schools, by all means they should do that. They should NOT, however, be allowed to deduct 100% of that sum from the tax they owe to the state of Kansas. If private schools wish to provide scholarships for students they choose to admit, by all means they should do that, using the many mechanisms available to them and already in use - but they should not be allowed to use tax money to do so.

We fully support the right of parents to determine whether public school, private school, or home schooling is best for each child in their family. We do not believe the taxpayers of Kansas should pay for that choice.

Stand Up Blue Valley remains opposed to the original Tax Credit Scholarship Program and we oppose any and all attempts to expand the diversion of state tax revenue to private schools. **We urge you to vote no on HB 2136.**

Thank you for the opportunity to submit these written comments in opposition to **HB 2136**, which would expand student eligibility under the tax credit for low-income students scholarship program, increase the amount of the tax credit for contributions made pursuant to such program and provide for aggregate tax credit limit increases under certain conditions.

Blue Valley has a student population of more than 22,400 and consistently ranks in the top tier of high performing schools, both in the state and in the nation. (See "Quick Facts" at the end of testimony.)

The primary goal of the Blue Valley district is **to ensure every student attending our schools has the educational programming and opportunities, delivered by quality educators, to allow them to thrive long after they leave our doors.** We embrace every student who walks through our doors and always work to provide them with the tools to succeed.

The Blue Valley Board of Education has a long-standing priority position that states:

[Blue Valley] opposes public funding of private schools, including offering public tax credits that decrease state revenue, that do not comply with the same standards and requirements of public-school districts.

As stated in our position, our Board believes that private schools receiving public dollars, even by a decrease in state revenue, must be held to the same standards, requirements, and governance as that required of public schools. In addition, it appears the fiscal note of expanding this program may reach \$20M. For these reasons, we must **strongly oppose** HB 2136.

I am writing to voice my strong opposition to HB 2136. As a former Title I school principal with 16 years of service in public education, as well as a parent of two adopted children (from Kansas foster care) in Kansas public schools, I have witnessed the impact of legislative decisions on our schools, teachers, and students. Public dollars should be used for public schools—institutions that serve *all* students, regardless of background, income, or ability. HB 2136 expands a program that lacks oversight, diverts much-needed public funds to private schools, and ultimately undermines the commitment Kansas has made to its public education system.

This bill would:

- Open the program to private school students who have never attended a public school, further straying from the program's original intent of supporting at-risk students.
- Expand eligibility beyond income-based needs to include children in foster care, military
 families, and children of police officers or firefighters—groups that already have access
 to public schools with support services in place.
- Increase the tax credit for donors from 75% to 100%, creating a tax avoidance loophole
 that allows corporations and wealthy individuals to funnel money to private schools
 while being fully reimbursed by the state.
- Raise the program cap from \$10 million to \$20 million, doubling the amount of public dollars diverted from the state general fund.

The most troubling aspect of this expansion is that it benefits private schools that can selectively admit students based on academic ability, religion, or special needs accommodations. Unlike public schools, **private institutions are not required to accept or support every student**. A program that allows tax dollars to flow into unregulated private institutions while public schools struggle with funding shortages is not in the best interest of Kansas students.

Additionally, there is no demonstrated need for this expansion. In 2023, only 1,340 students participated in the program despite 230,000 public school students being eligible. If this program were truly addressing an urgent need, we would see significantly higher participation rates under the existing guidelines. Instead, we have no accountability or transparency in how private schools select students, and we do not know why many eligible students are not participating.

HB 2136 is a tax avoidance scheme that benefits the wealthy while weakening Kansas's commitment to a strong, well-funded public education system. As a former principal, I know how crucial adequate funding is for providing quality education, supporting teachers, and ensuring that every child—no matter their circumstances—receives the resources they need to thrive. Instead of diverting tax dollars to private institutions, the legislature should prioritize fully funding special education and ensuring that all public schools have the resources necessary to serve every Kansas student.

I urge you to vote **NO** on HB 2136. Our children and educators are counting on us.

This bill: The donation limit per "donor" (corporation or individual) is \$500,000. Any amount donated will provide a dollar-for-dollar reduction in the taxpayer's tax liability. "Donors" funnel money to private schools and are fully reimbursed by the state. If the tax liability is less than the donated amount, the tax credit can be carried forward to future years.

This tax avoidance scheme can bring big benefits to corporations and the wealthy while reducing the state general fund used to fund our public schools, maintain our roads and bridges, and more.

I appreciate the opportunity to submit written testimony in strong opposition to HB 2135. This bill seeks to significantly expand the Tax Credit Scholarship voucher program in Kansas, further diverting public tax dollars away from our public schools and into private institutions that lack the same level of accountability and oversight.

The original intent of the Tax Credit Scholarship program was to provide low-income, at-risk students with an opportunity to attend private schools. However, the continual expansion of this program by legislative leadership undermines that initial goal and exacerbates inequities in our education system. This latest expansion proposed in HB 2135 is especially concerning for several reasons:

- Redirecting Public Funds to Private Schools Without Oversight Private schools
 that benefit from these diverted funds are not held to the same standards as public
 schools. They can deny admission based on various criteria, including disability
 status, academic history, or other subjective factors, which effectively limits access
 for many students who could benefit from additional educational opportunities.
- 2. Diverting Funds from Public Schools to Students Who Have Never Attended Them HB 2135 would allow students already in private schools—who have never attended a public school—to receive funding under the program. This shifts resources away from public schools that are constitutionally required to serve all children and redirects them to families who have already chosen private education, further straining public school budgets and limiting opportunities for those truly in need.
- 3. Providing a Full 100% Tax Credit to Donors Increasing the tax credit from 75% to 100% essentially turns this program into a state-funded subsidy for private schools. Donors would receive a dollar-for-dollar return on their contributions, creating an unfair financial incentive that depletes state tax revenue while benefitting a select group of private institutions. This approach removes necessary taxpayer accountability and transparency.
- 4. **Doubling the Program's Funding Cap** Raising the cap from \$10 million to \$20 million further accelerates the diversion of public dollars from our already underfunded public schools. At a time when public schools across Kansas are struggling with teacher shortages, classroom resources, and the need for infrastructure improvements, we should be focusing on strengthening our public

education system—not expanding a voucher program that primarily benefits private interests.

Kansas has a constitutional responsibility to provide a quality public education for all students, and expanding the Tax Credit Scholarship voucher program moves us in the wrong direction. I am a lifelong Kansan, having graduated from a rural Kansas high school and the University of Kansas. We raised our daughter in the Shawnee Mission School District, and she now teaches in the Turner School District.

I believe one of the best traits of our state historically has been our focus on quality public education. This was universally true across the state. Public education was important to my grandparents, to my parents who were educators, to my husband and I and to our children, who are all educators. Strong public schools are critical to the ongoing maintenance of high-quality communities where people want to live and work.

I am vehemently opposed to SB 75 and voucher programs in general. First and foremost, public tax dollars should remain with our public schools that accept and educate all children and that are accountable to taxpayers. Education Tax Credits divert funds that could otherwise be used to improve public education to subsidize the private choices of some parents thus having the same negative impact as a voucher program. This bill takes money that could be used to strengthen our public schools that serve all kids and gives it to families who have made a private choice to receive a religious or other non-public education, many who can easily afford that choice. Instead of providing tax credits to Kansans who choose not to send their kids to public school, the legislature should be using those tax dollars to *fully fund special education* that is currently underfunded by \$173 million. Tax credits for private education are another way for wealthy families to reduce their tax burden and avoid paying their fair share.

Second, private schools are not required to accept all students. Public dollars should provide funding to schools who will accept any child, not those that can pick and choose which families they want to serve. Families with children with special needs, disabilities, or those for whom English is not their first language will not benefit from these tax credits as few private schools can accommodate their needs.

Finally, public schools are critical to the development of healthy communities in our state. Public schools are a public service and paid for by everyone, regardless of whether they use them or not. Just as we would not give a tax rebate to people who buy books instead of using a

That is the power of the K12 systems, whether we are talking about learning disabilities, a child who doesn't speak English as their first language, or someone who has a physical disability. Do you realize what public school delivers? For example, I've had students in my classroom who had feeding tubes, for example. I couldn't do this without the help of the school nurse. In a private school, this child wouldn't be fully integrated in a classroom of peers. Or students who were adopted from Russian orphanages and still working to overcome the trauma of that upbringing. In a private school, this child would have been segregated until they were verbal. Instead, the public school was able to allow them to sit through their "silent period" with the support of a social worker coaching me as the math teacher. They were with their peers which helped them not only learn math, but come out of their shell. Imagine teaching pre-algebra to those students. It took a whole team to help deliver math instruction to them....we did it and they flourish over time.

I am deeply concerned that private schools may not have the necessary resources and staff to adequately meet the needs of the at-risk students the Scholarship program is designed to serve. We have a responsibility to these students, and we cannot afford to let them fall through the cracks.

This bill threatens that kind of help and specialized teaching impossible if you take away resources from the public schools and give it to private schools.

Thank you for the opportunity to share my opposition to bill HB 2136. My reasons are many and I hope you will take the time to consider each of them.

Expansion continues to be unnecessary

The original intent of this program was to help low income (at-risk) kids attending the 100 lowest performing schools. Yet, with each expansion, more and more of the at-risk students get left behind as private schools have a bigger pool of students to choose from. The at-risk kids who would require more resources from private schools can be skipped over in favor of kids with fewer challenges.

There are more than 235,000 free and reduced lunch students eligible for the program and \$6 million in available scholarships. Please put your focus back on these students. Opening the program up to more students and allowing for an increase in the cap is not necessary.

Program lacks data and accountability

Any changes to the Tax Credit Scholarship program should include data collection and reporting requirements to increase accountability and transparency for Kansas tax dollars. Such as:

- Number of students who were eligible and applied for a scholarship vs. number of students utilizing a scholarship. We know private schools are allowed to deny admission for a host of reasons. Were some of these 235,000 at-risk students denied admission?
- Retention rates in the program by income level. Are at-risk students with more challenges returning to public school because they weren't finding success at a private school or because they were counseled out?
- Measures of success for students participating in the program by income level standardized test scores, graduation rates, post-secondary success. Are we seeing the benefits from this program that were promised? Are there some private schools with lower performance? Should they remain in the program?

Kansans expect their tax dollars to be used effectively. If our tax dollars are being diverted to a private entity, we should expect some oversight and transparency.

100% tax credit is egregious, is tax avoidance, and benefits the wealthy & corporations Kansans who make contributions to private schools should not receive preferential treatment over Kansans who donate to charitable organizations. The current 75% tax credit (which was expanded from 70%) is lucrative enough. A 100% tax credit allows taxpayers to essentially make donations for free and is pure tax avoidance. Considering the \$500,000 contribution limit (that can be carried forward to future years), the benefits to corporations and wealthy Kansans are immense and an expansion to 100% is egregious.

This increase would just incentivize more taxpayers to contribute to this program resulting in continued decreases to the state general fund that is used to fund our public schools and other public goods like our roads and bridges. All Kansans should be contributing to the good of our state.

Please vote no on HB 2136

This bill is simply a voucher program in disguise and one that is more egregious than most. Not only does it divert public tax dollars to private schools via these lucrative tax credits, but the benefits to wealthy Kansans outweigh the benefits to the students this program was intended to support. Choosing to send your child to a private school shouldn't be subsidized by the state and choosing to donate to a private school should not be subsidized by the state in a manner that is more beneficial than other charitable donations.
