I am writing in strong opposition to SB 76 which would cause irrevocable harm to Kansas school communities. This bill is deeply concerning to me as a Kansan and life-long educator. I was born and raised in Kansas and I have worked in education for eighteen years.

One of our most central duties as educators is to provide a safe place for students to learn and grow. SB 76 would make Kansas schools punitive and degrading. If SB 76 becomes law, teachers and students will both suffer for it.

Data indicate that 82% of transgender individuals have considered killing themselves and 40% have attempted suicide, with suicidality highest among transgender youth (Austin, Craig,D'Souza, McInroy). I have worked with several transgender youth in my years in education. It is hard enough to find yourself as a young person let alone as one who is experiencing life as a gender that does not align with their true identity.

The harmful effects of deadnaming and misgendering students are well researched and proven. Scholars, activists, and community members agree that the most sensitive and supportive way to interact with transgender youth is to respect their gender identity by using their affirming names and pronouns (<u>Coolhart & MacKnight, 2015; Grossman & D'Augelli, 2006; Hill et al.</u>, <u>2017; Sausa, 2005</u>).

This also affects me very personally as my godchild and cousin are both transgender kids attending Kansas schools. If this bill becomes law, my family will suffer. These kids deserve the same support and respect as any other child. Using someone's correct pronouns and names harms no one. I am asking you please, do not punish my family and other children for bravely being who they truly are.

Children and teachers are facing enough stressors and pressure in their lives and in our schools. I implore you not to allow SB 76 to pass into law. Thank you for this opportunity to share my testimony.

My name is Tom Barker and I am writing as a public school educator in opposition to Senate Bill 76 (SB 76). I have had the privilege to be a public school teacher for the past twelve years. Having completed my Ph.D. in Curriculum and Instruction at the University of Kansas, I choose to work in the K-12 setting instead of further working in higher education. I could rave on for hours about the trials and challenges of being a public school teacher, while also noting many of the successes I have seen. Simply put - I love my job and glad that I have found my calling. I am also grateful for my son's public school education and the many opportunities it has allowed him to have.

My opposition to this bill is that I believe it threatens the well-being of students. As an educator, students come into my classroom with a variety of backgrounds and needs. My job is to simply meet them where they are at and educate them the best I can. Over the years I have had several students who were transgender and use a pronoun or name that may be different then assigned at birth. I hope that by using the name and pronoun that they wish to be used in my class helped them to feel more comfortable and allowed me to build a relationship of trust with them. These relationships are key to being a successful learner in the classroom. I have seen students whose parents have struggled with their student's gender dysphoria and have often had school be the only safe place that reinforces their self-worth.

Additionally, I oppose this bill because it allows for harassment of transgender students by their peers. I find it completely unacceptable that even with a parent's written consent, this bill would allow fellow students to harass and bully a transgender student by not using their preferred name or pronouns, as those who choose to target transgender students cannot be punished. This would create serious issues within a school environment and lead to the decrease in school being a safe place for all students.

Lastly, adolescents is already a difficult time for students as they try to figure out who they are and what they want their roles to be in our society. Transgender youth already have a lot of struggles already in coming to terms with who they are despite societal norms. As research has indicated, like that published in *Nature Human Behavior*, states that have implement anti-transgender laws typically show an increase up to 72% in suicide rates for those between the ages of 13 and 17. Chair Estes and Members of the Committee,

Thank you for taking the time to read my testimony in opposition to Senate Bill 76. I am urging the committee members to vote **no** on SB 76 as it infringes upon the first amendment free speech rights of students and teachers and seeks to make classrooms unsafe for LGBTQ+ students.

I taught middle school English for ten years at a parochial school. During my time in the classroom, I met hundreds of students, some of whom identified as LGBTQ+, and a few of whom were transgender. At the beginning of one of my final years in the classroom, one of my students asked me to call them by a different name than what was printed on their birth certificate. So, I did. The result? That student felt **welcomed** and **affirmed** when they were in my classroom. They smiled and shared their talents and dreams with us. In other words, the result was that a student was able to learn and grow because they felt safe. This is exactly what teachers seek to do: support students so that they can grow in confidence and skills and begin to reach their full potential.

If SB 76 becomes law in Kansas, there will be negative ramifications for both teachers and students. As someone with extensive time spent in a classroom, I know how disruptive it will be for teachers across this state to carry the anxiety of potentially facing a lawsuit for simply supporting and affirming a student. SB 76 also undermines the spirit of unity and solidarity that good teachers establish within their classes throughout the year. Specifically, the damages section in this bill is too broad and opens the path for litigation based on overhearing conversations as it does not require the person who sues for damages to be involved in the conversation at all. How could one bring together a classroom community when in constant fear that treating a student with respect and care will lead to someone else in the school suing you? During a time when we are facing a shortage of qualified teachers, this will be a **deterrent** for many people thinking of entering the education profession.

As a parent, I teach my daughter about respect and care for others. Using a student's preferred name and pronouns is one example of doing just that. Every Kansas student has the right to be called by their gender-affirming name and pronouns. Not only is this a matter of empathy and respect, there are also legal obligations to be considered. Denying students the right to use their gender-affirming name or pronouns at school may constitute a violation of Title IX and the Equal Protection Clause of the U.S. Constitution.

To close, I want to emphasize that this bill is, ultimately, unenforceable. As a middle school teacher, I saw upwards of 50 students a day, and many high school teachers see upwards of 100 students a day. It is impossible for every teacher to know every student's name and sex that is on their birth certificate. **Every year**, when it came time for my eighth grade students to graduate in May, I learned that a student went by a name that was not on their birth certificate because they went by a nickname, a middle name, or sometimes, a completely unrelated name. Calling them by this different name had *no bearing* on anyone's ability to learn. It just made that student feel good to hear the name or nickname they preferred. There will be more burdens, both administratively and financially, placed on an already burdened education system if this bill is to pass.

I encourage the members of the committee to vote NO on SB 76.

I am writing to express my deep concern regarding Senate Bill No. 76, the "Given Name Act," which would require school employees to use only names and pronouns consistent with students' birth certificates and biological sex unless they have written parental permission.

I believe this legislation contradicts core Christian values of compassion, dignity, and respect for all individuals.

I respectfully urge you to consider the following concerns:

- This bill would cause substantial harm to students whose gender identity differs from their assigned sex at birth. Research consistently shows that transgender and gender-diverse youth experience significantly higher rates of depression, anxiety, and suicide when they are not accepted and supported in their identities. By forcing educators to deny students' identities, this bill could contribute to psychological distress among an already vulnerable population.

- The commandment to "love your neighbor as yourself" (Mark 12:31) is central to Christian ethics. This love is not conditional based on someone's identity or conformity to expectations. Jesus taught inclusion rather than exclusion, acceptance rather than rejection. A policy that forces educators to potentially cause distress to students by refusing to acknowledge their identities seems counter to this fundamental teaching.
- While the bill purports to protect free speech, it actually infringes upon the religious freedom of educators whose faith calls them to affirm and support all students. Many people of faith, including Christians, Jews, Muslims, and others, believe that their religious duty is to treat others with dignity and respect, which includes honoring how individuals identify themselves.

Beyond the moral and ethical issues, this bill creates practical problems for educators who would be caught between their professional duty to support student wellbeing and a legal

One of the core principles of social work Code of Ethics is respecting the inherit dignity and worth of a person. This bill would present a threat to social workers, because they would be under risk of litigation for following the required Code of Ethics. One of the standards listed in the NASW Code of Ethics is 3.09d - " Social workers should not allow an employing organization's policies, procedures, regulations, or administrative orders to interfere with their ethical practice of social work." If a social worker could face legal action for upholding an ethical standard, it is extremely likely that this could interfere even subconsciously with their practice. Another social standard listed in the NASW Code of ethics is 3.09e - "Social workers should act to prevent and eliminate discrimination in the employing organization's work assignments and in its employment policies and practices." If this bill is passed, that would make upholding this standard virtually impossible, as not discriminating against student's personal identities would become something allowable by law. If this bill is passed, how many social workers will choose to not work in schooling or educational fields because they are worried about litigation? With Kansas already having a severe child mental health crisis and a deficit of social workers, this bill would do more harm than good on this front. let alone because of free speech and non-discrimination purposes.

As a former teacher, this bill is alarming. In the upper grades, teachers have hundreds of students. It is not practical to expect teachers to look at the birth certificate of every student and re-learn names and/or genders that differ from how students are known now. Thinking about substitute teachers, these challenges multiply. We already have a shortage of teachers and substitutes; I believe that adding this threat of legal action if a mistake is made is likely to compound an already existing problem.

I also have big concerns for trans students' safety and learning under this bill. As a teacher, the work that students and I did relied on a level of basic trust and respect between us. That trust doesn't happen when teachers repeatedly call students by the wrong name. I asked my middle school daughter about this issue, and she told me that there are a few trans kids at her school, with whom she attended elementary school. The only reason she knows that they're trans is that she knew them in early elementary before they transitioned. Many of their middle school peers only know them as their current name and gender. Forcibly outing these kids would almost certainly lead to bullying and potential threats to their safety.

The bottom line is this appears to be an example of burdensome regulation, which would certainly cause or compound more problems than it would solve.

I am a retired high school teacher and high school principal. I spent 30 years in public education, where my mission was to provide high quality education for ALL of the students in my care. As a principal, I was also responsible for ensuring a productive and caring school community for all of my teachers, students, and parents. There are several reasons why I urge you to vote NO on SB76.

1. It is unreasonable to assume that school employees know what it is on a student's birth certificate. In my 30 years in public education, I do not remember EVER seeing a student's birth certificate.

2. Refusing to call a student by the pronouns he/she/they and/or their parents may expect damages relationships with students and families. In order to be an effective teacher and administrator, building relationships is key. Teenagers and families can be difficult to build relationships with, and opposing them on issues of self-identity would only harm this relationship building process.

3. Calling students by a set of pronouns that differs from what they are called outside of the classroom is a recipe for targeting, bullying and harassment by others. This is unconscionable. No adult, let alone an education professional, should be asked to set up a student for targeting in this manner.

4. This intrusive practice is an example of harmful government overreach. It is dangerous and inappropriate for our state government to interfere with matters relating to personal identity and bodily autonomy for anyone, let alone minors. These matters should be between the child, the parents, and their own doctors. Policing personal decisions such as selecting one's pronouns is not an acceptable use of governmental responsibilities.

5. This bill is unenforceable. Education professionals cannot be expected to know what is on a student's birth certificate. Administrators cannot monitor every conversation between students and anyone else. Allowing people who have "overheard" a conversation to make a monetary claim of harm is unfair, dangerous, and invites abuse. We all know how conversations can be mis-heard and mis-interpreted, and how they could be weaponized by someone with an agenda
