Despite being called a "tax credit," it's still a voucher program that will cut revenue to our public schools, causing harm to Kansas public schools and shortchanging the education of our youngest Kansans, especially at a time when special education is underfunded.

Here are a few reasons why educational "tax credits" or vouchers are bad for Kansas's public schools.

- They hurt student achievement. In states that have implemented a similar program, unaccredited school vouchers hurt student achievement more than the 2020 pandemic (sources below).
- They undermine public schools. They divert resources away from public schools, attended by 90% of students, to fund the education of a few select students.
- **Private school tax credits or vouchers do not offer real choice.** Private schools can choose their students. Public schools are bound by law to accept all students.
- **Tax credits or vouchers fail to provide accountability to taxpayers.** Vouchers for private schools do not have appropriate oversight, which is critical when using public tax dollars.

I am writing on behalf of Stand Up Blue Valley to voice our opposition to SB 87.

<u>Stand Up Blue Valley: Families for Our Schools</u> is a parent and patron advocacy group in the Blue Valley School District. We advocate for legislation that supports Blue Valley Schools and work to help our community understand the importance of their votes to our schools. Our members are residents of the Blue Valley School District in Johnson County, Kansas. Our children attend and/or have graduated from Blue Valley Schools.

We oppose any diversion of tax money to private schools. We oppose any expansion of the Tax Credit Scholarship Program, and we oppose the addition of any other program to divert tax money away from public schools to private schools. Stand Up Blue Valley opposes giveaways in the form of tax credits for donations toward funding private schools. This type of tax credit is not available to any taxpayer for any other donation, no matter how philanthropic. Assigning this very special designation to the funding of private schools is not in the best interest of any Kansas student, any Kansas school district, or any Kansas citizen - other than the few who will use this to their financial benefit as they fund private schools of their own choosing.

SB 87 would **add eligibility** for students whose parents meet certain arbitrary employment or vocation specifications and students who are *or ever were* in foster care. These designations serve only to increase the number of students eligible for this unproven program. There is no evidence to support the notion that private school education would benefit the added categories of students, like the students originally designated for program inclusion.

Private schools often include religious curriculum. While we fully support the right of parents to send their students to any religious school they choose, we don't believe our tax dollars should be paying for religious education.

Private schools are not required to accept or retain any student. We are aware of Blue Valley families whose special needs students were not able to attend BV-area private schools due to their needs not being met there. Expansion of eligibility for students to use Tax Credit Scholarships to attend private school expands the ability of private schools to benefit from accepting/choosing students who are easier to educate and leaving a disproportionate number of students with learning disabilities, physical differences, and behavioral issues for public schools to educate.

Blue Valley taxpayers understand that our taxes go to support our excellent public schools, which provide a quality education to over 22,000 students, support over 3000 jobs in our area, and turn out graduates who return to enhance our community. Our Blue Valley Schools are the backbone of our local economy and result in high home values as businesses and people move here for the schools. We disagree with the premise that some taxpayers would be allowed to get a credit on their taxes (thereby lowering the amount of taxes they are paying) in order to use their money to fund private schools. We disagree with the premise that private schools should be given tax money.

If philanthropically-minded individuals wish to fund scholarships for low income students to attend private schools, by all means they should do that. They should NOT, however, be allowed to deduct a credit from the tax they owe to the state of Kansas. If private schools wish to provide scholarships for students they choose to admit, by all means they should do that, using the many mechanisms available to them and already in use - but they should not be allowed to use tax money to do so.

We fully support the right of parents to determine whether public school, private school, or home schooling is best for each child in their family. We do not believe the taxpayers of Kansas should pay for that choice.

My children have recieved an excellent education in public schools due to the effort of district standards, school administrators, and most importantly, teachers. My children spent the first two years of their education, preschool, in private school. I believe the quality of my children's public education to be equivalent to private education.

As a parent of children in public schools, I am aware funds are lacking for not only basic supplies, but additional teaching tools to enhance students learning experience. These additionally needed funds come out of the pockets of dedicated teachers who's salaries are not equivalent to the hard work and long hours they put in to their jobs and working parents. Thank you for the opportunity to submit these written comments in opposition to **SB 87**, expanding student eligibility under the tax credit for low-income students scholarship program, increasing the amount of the tax credit for contributions made pursuant to such program and providing for aggregate tax credit limit increases under certain conditions.

Blue Valley has a student population of more than 22,400 and consistently ranks in the top tier of high performing schools, both in the state and in the nation. (See "Quick Facts" at the end of testimony.)

The primary goal of the Blue Valley district is **to ensure every student attending our schools has the educational programming and opportunities, delivered by quality educators, to allow them to thrive long after they leave our doors.** We embrace every student who walks through our doors and always work to provide them with the tools to succeed.

The Blue Valley Board of Education has a long-standing priority position that states:

This is my written testimony for strong opposition to SB 87. I would appreciate confirmation that my testimony has been received.

As a parent of two children in USD 266, Maize, Kansas—one in 7th grade and the other in 10th—I have seen firsthand both the strengths and struggles of our public schools. In addition to my role as a parent, I spent five years working as an elementary school paraprofessional and currently substitute teach in USD 266. My experience within the public school system has been overwhelmingly positive, but it has also opened my eyes to the many challenges our schools face.

Public schools already operate on limited resources, doing their best with what little they have. SB 87 would only make this situation worse, further draining funding from schools that are already struggling.
