

Contributions and Distributions

For the 2024-2025 school year, there was a total of **\$11,520,122.02** in Contributions. Since the beginning of the program, there have been **\$57,819,629.02** in total contributions received.

In school year 2024-2025, there were **2,678** students awarded scholarships totaling **\$7,954,838.45**. Since the beginning of the program, **9,526** student scholarships were awarded totaling **\$33,953,871.89**.

For the 2024-2025 school year, all SGOs met the requirement to disburse no less than 90% of contributions within 36 months of when the contributions were received.

Includes information on Participating Qualified Private Schools

A qualified private school is any nonpublic school that provides education to elementary or secondary students, has notified the state board of its intention to participate in the program and complies with the requirements of the program. On and after July 1, 2020, a qualified private school shall be accredited by the state board or a national or regional accrediting agency that is recognized by the state board for the purpose of satisfying the teaching performance assessment for professional licensure.
