Testimony in favor of House Concurrent Resolution 5004 Elections Committee Kansas House of Representatives January 23, 2025

At the age of 20, I embarked on the journey to attain my American citizenship. The process was rigorous, demanding my commitment to understanding the history, values, and principles that define this nation. It also demanded my time and money. I will never forget the pride that swelled in my heart as I chose to pledge myself to this incredible country. At age 21, I celebrated my naturalization with a party surrounded by friends and loved ones. It was a moment of profound joy and gratitude, not just for the right to vote, but for the sense of duty and responsibility that came with it. My fellow Americans, the citizenship process is a transformative experience. It is a journey of dedication to the ideals that this country was founded upon. It is an affirmation of our commitment to the principles of liberty, justice, and the pursuit of happiness.

When we advocate for citizen-only voting, we are not merely safeguarding our electoral process; we are nurturing responsible voters—individuals who comprehend the gravity of their choices at the ballot box, who recognize that their decisions have profound consequences for our nation's future. So, let us unite in our conviction that the citizenship process is vital, that it instills in us a deeper sense of responsibility, and that it fosters responsible, informed voters who can be trusted to uphold the values we hold dear.
