Chairman Proctor and Members of the Committee: I appreciate your interest in the views of Kansans on HCR 5021. I am a Kansas voter as are most of the members of my organization. We have canvassed voters encouraging people to vote in federal, state and municipal elections because we believe that the best government is the one where there most citizens participate. For that reason we are opposed to HB 5021 because it will discourage voting. Therefore I encourage your committee members to vote NO on HCR 2051.

There are many reasons why you should reject this resolution and an amendment to the Constitution. First, you have no convincing evidence that there is any significant election fraud due to people who are not eligible to vote exercising the franchise. Will there be a reasonable amount of time for people to obtain eligible IDs, or is the intention to rush this through quickly, close to an election, with the hope that "less than" voters won't be prepared in time? Didn't Kansas try this before and it was a huge failure?

At any rate, I feel the harm outweighs any benefit. It also disproportionately disadvantages the poor, the elderly, the disabled, and women. Changing our state constitution to require voters to present a photo ID when voting is unnecessary. Section 25-2908 of Kansas law requires that voters present a valid form of identification with the name and photograph of the voter. Amending Article 5 of the state constitution is redundant and unnecessary.

HCR 5021 would restrict what types of photo IDs could be used at the polls. This could create confusion and potentially disenfranchise thousands of Kansas voters, who wouldn't be able to use an eligible ID, such as a college student ID or a tribal ID, that they've used in the past.

Changing voting requirements is confusing and could make all voters—Republican, Democratic, and Independent—unsure of the requirements of what is needed to vote, which could lead to voter suppression. Restrictive voter ID laws give voters the impression that politicians are creating bureaucratic barriers to rig the system instead of making it easier for all eligible voters to participate in our democracy.

Kansas elections are already secure. On page 5 of the Kansas Elections 101 document (<https://sos.ks.gov/Pubs/Elections/Elections-101.pdf>) provided by the Kansas Secretary of State Scott Schwab, the year 2022 milestone was that: “Substantial election security bill passed by Kansas legislature. Improvements include enhanced election equipment security, additional election audits, voter database maintenance, ballot watermarks, and chain of custody procedures.” This quote explains recent highlights of Kansas’s election security. There are many other explanations in this document explaining how Kansas elections are secure, including Kansas’s election laws to other states and how election equipment is certified.

The League of Women Voters of Kansas opposes HCR; a constitutional amendment requiring photo ID to vote.

Currently, in Kansas statutes, photo ID is required to vote. It has been a law since 2012 with the implementation of the SAFE ACT. Kansans have learned to bring their photo ID to the polls or provide their ID # or photocopy when applying for an absentee ballot.

The proposed amendment only allows Kansas and United States issued photo IDs, severely limiting who can vote. Current regulations allow for several different government issued photo IDs, including: other states drivers license, public and private school ID, Native American tribal card, or a concealed carry license from any state.

This resolution is unnecessary, un-American and pety to put this type of regulatory detail in our Kansas constitution.

We ask that you vote NO on HCR 5021 as the current statute is more than sufficient.

Testimony on House Concurrent Resolution 5021

House Committee on Elections

Thank you, Chairman Proctor and committee members, for hearing my testimony on House Concurrent Resolution 5021. My name is Dave Maxey. I am a representative in the Wisconsin State Assembly and the Chairman of the Wisconsin Assembly Committee on Campaigns and Elections. In 2025, Wisconsin voters overwhelmingly approved amending the Wisconsin Constitution to require a valid voter ID to vote.

Wisconsin's voter ID law was enacted in 2014 and has not resulted in voter suppression. On the contrary, voter participation has increased since its implementation. In November 2024, voter turnout reached 76.6 percent, compared to 69.5 percent in 2016. At the time the law was enacted, the League of Women Voters argued it would complicate elections and make voting harder. However, after the 2016 and 2018 elections, the League admitted that the elections proceeded smoothly and without major issues. While Wisconsin's constitutional amendment did not change existing law, it ensured that this fundamental voter integrity measure remains the law of the land.

Polling has consistently shown strong support for voter ID requirements, with a 2024 Pew Research Center poll finding nationwide support at 81 percent. Wisconsin is often described as a 50/50 "purple" state, yet nearly 63 percent of Wisconsin voters supported amending our Constitution to require voter ID. If there was one action we could have taken simultaneously, it would be to mandate voter IDs to also confirm citizenship. However, Wisconsin's voter ID law has been largely effective in ensuring election integrity and boosting public confidence in our elections.

With both foreign and domestic threats to our democratic processes, our elections should be at least as secure as your front door when you go to bed, if not more. I urge you to support HCR 5021, keep our republic secure, and allow the voters of Kansas to decide. Ensuring that voter ID is required under the Kansas Constitution will strengthen confidence in the electoral process for generations to come.

Chairman Proctor and Distinguished Committee Members,

My name is Rick Piepho, Harvey County Clerk and Chairman of the Elections Committee of the Kansas County Clerks and Election Officials Association (KCCEOA). The KCCEOA is a statewide organization with 109 members, including all county clerks and election commissioners in Kansas. Our members are responsible for administering voter registration and elections at the local level and are committed to ensuring elections that are free, fair, secure, and efficiently administered.

I am submitting this neutral testimony on behalf of the KCCEOA membership regarding HCR 5021. The intent of this testimony is to provide information from an election administration perspective and to outline general implementation and administrative considerations related to the resolution as introduced.

From an administrative standpoint, placing a voter identification requirement in the constitution may reduce flexibility for future adjustments to accommodate evolving election practices, technology changes, court decisions, or operational realities. County election officials rely on statutory and regulatory frameworks that can be more readily updated to address implementation challenges, training needs, and procedural refinements.

Current Kansas statute (KSA 25-2908) already establishes photographic identification requirements for voting, including a list of acceptable forms of identification and specific statutory exceptions. If a more restrictive identification standard is placed in the constitution, existing statutory provisions that allow additional forms of identification or recognize exceptions may be superseded. This could affect voters whose only photographic identification was issued by another state, an Indian tribe, or a municipal or county government, as well as voters who currently qualify for statutory exemptions, such as those whose religious beliefs prohibit being photographed.

Additionally, from an administrative perspective, the committee may wish to consider whether the election date for submitting this constitutional question to voters should be the General Election on November 3, 2026. Placing constitutional amendments on a Primary Election ballot requires the creation of an additional ballot style for unaffiliated voters and for voters affiliated with parties that do not conduct a primary, increasing ballot programming complexity, testing requirements, printing costs, and logistical planning.

The KCCEOA does not take a position for or against HCR 5021 at this time. These comments are offered to assist the committee in understanding potential operational and voter-experience considerations associated with the resolution. This testimony is submitted in writing only.

Mr. Chair, Members of the Committee:

I serve as Executive Director for Kansas Interfaith Action, an multifaith advocacy group that works for justice and equality for all people across the state of Kansas. I submit testimony today in opposition to HCR 5021.

Our state constitution is a fundamental – some might say, sacred – document. It is the bedrock of our rights as Kansans, and it is supposed to protect citizens from the whims of partisanship. Amending it should be undertaken only after exhaustive due diligence and, most importantly, undeniable evidence of necessity.

While (as constantly needs to be said) ***there is no evidence of widespread voter fraud***, as AG Kobach's hamfisted attempts to find it have shown, there is a lot of evidence that restrictive ID laws cause tangible harm. When asked to study this issue, the United States Government Accountability Office suggested that "the turnout decreases in Kansas beyond decreases in comparison states were attributable to changes in voter ID requirements."¹

By narrowing the types of identification acceptable at the polls, this bill creates bureaucratic barriers that target, not "fraud, but" Kansas voters. By moving toward a strict state or federal photo ID requirement, this resolution would target voters attempting to legally vote using student IDs and tribal IDs. These are our neighbors: young people engaging in likely their first ever election, and Indigenous people who have lived on this land for generations. To tell them their legal ID is suddenly insufficient is a slap in the face to some of the most vulnerable among us. In addition, for many Kansans – such as the elderly, those in rural areas, and those living in poverty – getting a new, specific form of government ID is burdensome. It requires time off work, transportation, and often the cost of underlying documents like birth certificates.

Our faith calls us to build a 'Beloved Community' where every voice is heard. KIFA's position has always been that we should make voting as easy as possible for everyone who is eligible to vote. We are concerned that this bill is more about protecting political power than protecting the ballot box. Election security comes from high participation and a clear, transparent process, not arbitrary hurdles. Making voting more complicated and challenging for eligible citizens does not make an election safer. It only makes it less representative.

We ask you to protect the sacredness of the vote by ensuring that voting remains open, accessible, and supported for all those who are eligible to vote – even if they do not have a photo ID. We ask you to please vote NO on HCR 5021. Thank you.

Chair Proctor and members of the House Committee on Elections:

On behalf of the Health Forward Foundation (Health Forward), I submit this letter of testimony in opposition to House Concurrent Resolution 5021 which proposes amending the state constitution to require voters to present photographic identification to vote. An individual's ability to exercise their right to vote plays a key role in shaping one's living conditions and the communities in which they live; our aim should be to make voting more accessible, not create unnecessary barriers. A Kansas law, passed in 2011, currently requires voters to present a valid photo ID. Placing the voter ID requirements in the state constitution only serves to make it more challenging to increase access and accessibility to voting in response to technology advancements (or constraints, local or national emergencies, etc.) In instances that require Kansas to be adaptable, it'll be significantly more challenged to do so.

Additionally, this legislation further restricts the types of IDs that can be used to vote. According to HCR 5021, the photo ID must be issued by the state or federal government, while current law allows for the use of college IDs and out-of-state IDs. There is no certainty that there will continue to be important exceptions like those that allow seniors to use an expired ID or Indigenous voters whose tribal ID may not include a photo or an expiration date. HCR 5021 will increase barriers to voting by making it harder to obtain an approved voter ID.

The Office of the Kansas Attorney General does not anticipate a direct fiscal impact on the agency. The bill grants the Office discretion to accept or decline referrals for prosecution, which is consistent with authority already provided under existing law.

This bill carries an elevated risk of litigation. At this time, the Office is unable to estimate the potential costs associated with any such litigation.
