Mandating citizenship status on driver's licenses targets individuals based on a personal characteristic and can lead to discrimination and stigmatization of groups within our communities. Many lawful non-citizens contribute to Kansas's economy, culture, and civic life. Requiring a citizenship marker on a widely used identity document could invite profiling in routine interactions with law enforcement, landlords, employers, or service providers.

There is no demonstrated need for a citizenship field on state IDs to ensure secure elections or public safety. Kansas already has systems in place to verify voter eligibility — including citizenship — at the time of voter registration. Adding this information to driver's licenses could create a false sense of security while exposing the state to unintended legal and administrative costs.

Driver's licenses are one of the most commonly used forms of identification in everyday life. Embedding sensitive information, such as citizenship status, increases the risk that this information could be misused or improperly disclosed, particularly if adequate data protections are not fully established and funded. The more personal data on a license, the greater the potential harm if that data is lost, stolen, or accessed without consent.

Creating a two-tiered sense of identity can discourage community members from engaging fully in public life — including work, travel, and interactions with governmental services. Some residents might avoid applying for state IDs altogether if they fear that personal information like citizenship status could be exposed or misused, which could reduce mobility and participation in civic life.

Implementing citizenship status on licenses would require changes to DMV systems, staff training, and potentially new verification procedures. Without a clear public benefit that outweighs these costs, this bill risks diverting resources from higher-priority services that Kansans rely on.

For the reasons outlined, discrimination risk, lack of clear benefit, privacy concerns, and cost implications, I urge this Committee to vote against HB 2448. Thank you.

Chair and members of the committee, thank you for the opportunity to speak today.

I want to begin by saying that Kansans across the political spectrum agree on two things: we value secure elections, and we value fair, limited government that focuses on real, measurable problems facing families.

I respectfully oppose HB 2448 because, while well-intentioned, it does not meaningfully improve election security, and it creates consequences that extend far beyond elections.

Kansas already does not issue driver's licenses or state IDs to undocumented individuals.

Under both Kansas law and federal REAL ID requirements, individuals must already prove their citizenship or lawful presence to obtain a driver's license. Kansans have spent the past several years upgrading to REAL ID, bringing extensive documentation proving their citizenship to meet those standards. I know some of us in the room have braved the long-waiting times at the DMV to get those little gold stars at the top right corners of our REAL IDs.

That means citizenship is determined before a license is issued. Voting eligibility is verified through voter registration systems, not through markings on a driver's license.

In practice, this bill does not close a gap. It adds a label.

The question before us is not whether election integrity matters. It without a doubt does. The question is whether marking citizenship status on a driver's license is necessary, effective, or limited in scope. I don't believe it is.

A driver's license is used dozens of times a week in ordinary life: traffic stops, banking, employment verification, renting housing, picking up prescriptions. Adding a citizenship marker turns a general-purpose ID into something that can invite confusion, profiling, or unequal treatment, especially for naturalized citizens who are fully eligible voters and fully contributing Kansans.

That is not a hypothetical concern; it is an unintended consequence of expanding what government requires to be disclosed in everyday interactions.

I would also encourage the committee to consider priorities. Kansas families are feeling real economic pressure right now.

According to recent Kansas data:

- In Kansas, housing prices and rents have risen significantly over the past several years, contributing to affordability challenges for many families.
- Childcare costs now rival rent in many counties, particularly for working families.
- Utility costs and property taxes continue to climb, squeezing seniors and rural households on fixed incomes.
- And from the personal “data” from members of my community, we’re struggling to feed our families these days without nickel and diming everything thanks to the rising cost of groceries.

These are the issues Kansans raise at kitchen tables and not the markings on a driver’s license.

From a traditional perspective, this bill also expands government involvement in places where it isn’t needed. It adds administrative complexity and unnecessarily advertises personal information without a clear public safety or fiscal benefit.

I know we can protect election integrity without expanding government labeling and without diverting attention from affordability and economic stability.

For those reasons, I respectfully ask the committee to vote ‘no’ on HB 2448 and focus legislative efforts on policies that make Kansas more affordable, more competitive, and stronger for working families.

I work with vulnerable populations as a clinical social worker. In my line of work I often serve victims of abuse who struggle to leave their abusers because of a number of reasons often out of their control. These individuals are maybe citizens and noncitizens. Kansas already has a requirement for residents to get a Real ID. Victims of abuse are often controlled by their abusers when their abusers confiscate their identification. When individuals are severely mentally ill, like those you may see living on the streets, they often lose track of their identification making it difficult for them to access needed resources to begin recovery. Adding a citizenship marker on identification is needless and could potentially harm citizens and noncitizens alike by causing agencies to assume the citizenship of persons seeking assistance and refusing them services. It can take weeks or months to update an ID if people changed their names or do not have matching SSN and birth certificates. I myself had to make changes to my SSN because the name of my SSN did not exactly match the name of my birth certificate and it was a lengthy process to get all the documents in order to get a real ID. Adding another requirement would add unnecessary steps to an already lengthy process when someone has to update an ID.

Chair Proctor and members of the House Committee on Elections:

On behalf of Health Forward Foundation (Health Forward), I submit this letter of testimony in opposition to House Bill 2448 which requires citizenship status to be listed on driver's licenses. Health Forward is a health foundation focused on equitable health care access and outcomes. We oppose this bill because it will increase barriers to obtaining a valid driver's license which will increase barriers to voting.

Access to a driver's license impacts an individual's access to services, ability to freely move around their community, and ability to engage meaningfully in their communities, including voting.¹ This bill will restrict these freedoms for Kansans who do not get a driver's license due to privacy-related or other concerns about displaying their citizenship status.

According to the Health and Democracy Index, there is a distinct relationship between healthier states and inclusive voting policies and voter participation. Driver's licenses are one of the main forms of identification used for voting. As a result, access to driver's licenses directly impacts access to voting. HB 2448 will negatively impact the health of Kansas as it increases barriers to voting and will hinder the ability of Kansans to vote for the issues and candidates that advance our health.
