Dear Kansas Representatives of the House Committee on Federal and State Affairs,

Comments by Dr. Robert W Malone (scientist, biochemist, inventor of mRNA & DNA vaccines and RNA as a drug):

"So this is the WHO Pandemic Accord and the International Health Regulations modifications. And what's in play here, it's going to be voted on quite soon (May 2024), is a major grab for power, sovereignty and also financial power by the World Health Organization under the thesis that they've done such a good job in managing the SARS-CoV2 crisis, the Covid crisis, that they deserve more power and really global control for coordinating all future pandemic responses. And also that they have the right to declare whether or not something is a global public health threat. So they are going, they seek the power or Mr. Tedros, their director general, to be able to declare any thing as a major public health threat that he so desires, just like he arbitrarily and capriciously declared monkeypox a global health threat. And we've all seen how that played out. So this is a treaty, and it's also a modification of the International Health Regulations that have been proposed by Mr. Biden in under this structure what is proposed is that the WHO will be able to tell nation states what they must do and what their people must do, what drugs they

must take, what vaccines they must receive in response to a public health outbreak. And these public health outbreaks can be associated with anything. They can be a climate crisis, they can involve gun violence. They can be whatever it is that Mr. Tedros determines is a public health threat or public health emergency. And it's all part of what's called the One Health Initiative, which basically determines that the rights of human beings are equivalent to that of all other species, animal, plant, etc. So they can declare a public health crisis, an international health crisis, because they believe that there's a threat to a given species in the Amazon or anything they want. Really, it is truly arbitrary and it truly is a threat to your national sovereignty. But that's only one of many threats."

Ex-WHO Scientist David Bell: Pandemic Treaty: "Even though it doesn't directly change sovereignty, in effect, it does. It takes away the ability of the people of that country to make their own decisions," says Dr. Bell. And more importantly, these proposals will create a bureaucracy "whose existence is dependent on pandemics," says Dr. Bell. "They'll have a very vested interest in finding outbreaks, declaring them potential pandemics, and then responding. It's the way that they will survive."
