The success of Southwest Kansas is directly tied to the vitality of our small businesses and local economies. Historic preservation tax credits play a crucial role in encouraging private investment in aging structures, many of which require substantial rehabilitation costs. Without such incentives, property owners may struggle to justify the expense of renovations, leading to deterioration, vacancy, and ultimately, economic decline.

By strengthening SB 227, the Legislature would provide Southwest Kansas with a powerful economic development tool that can help transform neglected properties into vibrant commercial

spaces, residential units, and community gathering places. This program is not just about preserving history; it is about shaping the future of our region by making strategic investments that support long-term economic resilience.
