HB 2396 Oponent Testimony – in person Eliminating Revenue-Neutral Senate Assessment & Taxation Committee Dave Trabert, CEO March 17, 2025



Chairperson Tyson and Members of the Committee,

We appreciate this opportunity to present testimony opposing the elimination of Truth in Taxation / revenue-neutral provisions and providing a state subsidy to local governments that impose tax increases at or below the rate of inflation with certain exceptions.

Truth in Taxation is recognized as being "very effective" by Americans for Tax Reform and as the "gold standard" of property tax transparency Iowans for Tax Reform and other organizations. It came about because voters were fed up with local officials claiming to be 'holding the line' on property taxes while imposing large tax increases. The requirements to notify taxpayers of their intent to raise taxes, hold a public hearing and then vote on the entire tax increase resulted in much more taxpayer engagement.

The accountability aspects of Truth in Taxation are also producing lower rates of tax increases that would otherwise have occurred for many taxpayers. Initially, 52% of local taxing authorities held to revenue-neutral. Data from the Kansas Department of Administration for all counties was not available as this testimony was written, but the actions taken in 102 counties for 2025 (budget actions taken in 2024 for the 2025 budgets) show that approximately 62% of all entities are not increasing property tax this year, and another 13% are imposing increases below 4%!

It's also very encouraging that more of the larger taxing authorities are not exceeding revenue-neutral. So far, Wyandotte County, Riley County, Ford County, and 44 others will not increase property taxes in 2025. More than 200 cities, including Kansas City, Salina, Hutchinson, Leavenworth, Emporia, Louisburg, Liberal, Abilene, Junction City, and Spring Hill, will also not exceed revenue-neutral this year. There is even a growing list of school districts opting not to exceed revenue-neutral where they have the discretion to do so.

Lists of local governments not exceeding revenue-neutral this year and those with increases below 4% are attached to my testimony and are also available at KansasOpenGov.org.

All of this good news goes away if HB 2396 becomes law. Many of the 2,300 taxing authorities that are not raising taxes this year will impose tax increases next year, and that is not good for Kansans. With all the transparency elements gone and an incentive payment coming to those that raise property tax by at least 4%, many local officials will go up to the payment threshold. Inflation is presently about 3%, and spending for debt payments and taxes from new construction are exempt from the payment calculation, making it reasonable to expect HB 2396 to incentivize tax increases of at least 4%. This year, almost 500 local governments are raising taxes by less than 4%, so we can also anticipate many of them to tax more if HB 2396 becomes law.

Using a 'carrot' to encourage lower tax increases may help with tax increases between 4% and 10%, but the local governments raising taxes by more than 10% can probably take in more money on net by foregoing the carrot.

Unfortunately, HB 2396's unintended consequences will lead to higher taxes for many people compared to leaving the revenue-neutral process in place.

- Most of the 2,800 governments not increasing taxes or imposing less than a 4% increase impose higher taxes will likely go up to the limit and still get a state payment.
- Some of the roughly 500 governments with increases this year between 4% and 10% can be expected to have small increases next year.
- The 300 governments with tax increases above 10% will probably not be affected by HB 2396.

Leavenworth County is a good example of HB 2396 likely having no impact on governments that impose double-digit increases.

County Commissioners raised taxes by 9.4% in 2024, taking in \$3.6 million more than the prior year. HB 2396 would provide \$1.3 million to Leavenworth County if it meets the threshold. If we assume a 4% increase is the threshold, Leavenworth County could raise taxes by no more than \$1.5 million (4% of the

previous year's tax) to collect the \$1.3 million state payment, for a total of \$2.8 million. That is \$800,000 less than the tax increase, so Assessment & Taxation Committee Members must ponder what you think commissioners would do. Would they likely forego the state payment and impose a higher tax increase or cut back their spending plans?

Tax trend indicates the need for limits on valuation and tax increases, not repeal of RNR

Absent access to the long list of counties and cities that did not exceed revenue-neutral and the data in the adjacent table, someone could understandably look only at annual rates of increase and think that the RNR process isn't curtailing tax increases. The tax increase on residential property did spike in 2022 and 2023. However, the valuation increase on existing residential property in both years was more the twice as high as in previous years, and the temptation to take advantage and impose big tax hikes was hard to resist for many local elected officials.

Their actions underscore the need for limits on taxable assessed valuations and tax collections rather than repealing an effective revenue-neutral process.

We hope this new information encourages the Committee to reject HB 2396 as written or to amend it by reinstating revenue-neutral and making the 'carrot' contingent upon holding to revenue-neutral. Thank you for your consideration.
