NEUTRAL TESTIMONY BEFORE THE

SENATE TRANSPORTATION COMMITTEE

REGARDING SENATE BILL 119

RELATING TO INCREASING FEES RETAINED BY THE COUNTY TREASURERS

February 11, 2025

Mr. Chairman and Committee Members:

The Kansas Department of Transportation (KDOT) is providing neutral testimony on Senate Bill (SB) 119. This bill provides for an increased amount of the annual vehicle registration fees and all certificate of title fees to be retained by the county treasurers. It would direct \$5.75 for each vehicle registration fee and \$3.50 of every certificate of title fee collected be deposited to a special fund which is appropriated for the use of the county treasurer to pay for expenses incidental to the administration of the duties prescribed in law. The language changes proposed in this bill would amount to approximately a \$16 million reduction in revenue to the State Highway Fund (SHF) annually.

Current law (K.S.A. 8-145) provides that \$.75 per vehicle registration be deposited to a special fund for the county treasurer to pay for expenses incidental to the administration of the duties prescribed in law.

Registration fees under K.S.A 8-143:

•	Motorized bicycles	\$11
•	Motorcycles	\$16
•	Vehicles less than 4,500 pounds	\$30
•	Vehicles greater than 4,500 pounds	\$40
•	Hybrid vehicles	\$50
•	Electric vehicles	\$100

Current law (K.S.A. 8-145) also provides for \$2 of every certificate of title fee collected be deposited to the aforementioned special fund for county treasurers. The remaining portion of revenues collected for vehicle registration goes to the SHF. The remaining portion of the certificate of title fees is split into three different funds: one in the Department of Revenue (\$3.00), one in the Kansas Highway Patrol (\$3.50), and the remainder to the SHF (\$1.50).
