Often contributing no taxable benefit to our County and State, nor devising any genuine worthwhile plan themselves, as we approach the once in a lifetime opportunity to showcase our State's true beauty to thousands of FIFA sports tourists, I plead you join with every viable Wyandotte Countians' plea to move Quindaro ahead and ignore this outside entity perpetuating a glaring economic blight on our treasured, hallowed grounds. *Further*, please consider amending **SB 290** to enactment upon publication in the Kansas register.
