13 *Be it enacted by the Legislature of the State of Kansas:*

14 *New Section 1. (a) The state of Kansas is hereby designated as a*  
15 *purple heart state in recognition of the many citizens of the state who*  
16 *have earned the purple heart medal as a result of being wounded while*  
17 *engaged in combat with an enemy force.*

18 *(b) Each year, the governor shall issue a proclamation recognizing*  
19 *the purple heart day, to be observed on August 7 of each year, following*  
20 *the tradition established by George Washington in 1782 and revived in*  
21 *1932 that distinguishes the purple heart as a decoration of honor*  
22 *awarded to members of the armed forces and United States citizens who*  
23 *were honorably wounded in action. The award has been limited to*  
24 *members of the military since 1997 by congressional action.*

25 *(c) The executive director of the office of veterans services shall*  
26 *promote the observance of purple heart day with appropriate activities*  
27 *and direct each local chapter of all veterans' organizations to plan*  
28 *special activities and events to honor the purple heart recipients in each*  
29 *chapter.*

30 *(d) All residents of this state are enjoined to devote some portion of*  
31 *purple heart day to recognizing and commemorating the recipients of*  
32 *the purple heart who have demonstrated a commitment to fighting for*  
33 *the ideals that have made this nation great, have served this nation so*
