1 AN ACT concerning crimes, punishment and criminal procedure; relating to theft; changing the culpability required for certain types of theft; 2 increasing the criminal penalty when the property is a motor vehicle; 3 increasing the criminal penalty when the property is a motor vehicle 4 of the value of at least \$500 but less than \$1,500; amending K.S.A. 5 21-5801 and repealing the existing section. 6 7 8 Be it enacted by the Legislature of the State of Kansas: Section 1. K.S.A. 21-5801 is hereby amended to read as follows: 21-9 5801. (a) Theft is any of the following acts done with intent to 10 permanently deprive the owner of the possession, use or benefit of the 11 12 owner's property or services: 13 (1) Obtaining or exerting unauthorized control over property or services: 14 15 (2) obtaining control over property or services, by deception; (3) obtaining control over property or services, by threat; 16 (4) obtaining control over stolen property or services knowing, or 17 having reason to know, the property or services to have been were stolen 18 19 by from another; or 20 (5) knowingly dispensing motor fuel into a storage container or the 21 fuel tank of a motor vehicle at an establishment in which motor fuel is offered for retail sale and leaving the premises of the establishment 22 23 without making payment for the motor fuel. 24 (b) Theft of: (1) Property or services of the value of \$100,000 or more is a severity 25 26 level 5, nonperson felony; 27 (2) property or services of the value of at least \$25,000 but less than 28 \$100,000 is a severity level 7, nonperson felony; 29 (3) property or services of the value of at least \$1,500 but less than \$25,000 is a severity level 9, nonperson felony, except as provided in 30 31 subsection (b)(7); 32 (4) property or services of the value of less than \$1,500 is a class A nonperson misdemeanor, except as provided in subsection (b)(5), (b)(6),
(b)(7) or, or (b)(8) or (b)(9);

3 (5) property of the value of less than \$1,500 from three separate 4 mercantile establishments within a period of 72 hours as part of the same 5 act or transaction or in two or more acts or transactions connected together 6 or constituting parts of a common scheme or course of conduct is a 7 severity level 9, nonperson felony;

8 (6) property of the value of at least \$50 but less than \$1,500 is a 9 severity level 9, nonperson felony if committed by a person who has, 10 within five years immediately preceding commission of the crime, 11 excluding any period of imprisonment, been convicted of theft two or 12 more times;

13 (7) property that is a firearm of the value of less than \$25,000 is a
14 severity level 9, nonperson felony; and and

(8) property that is mail of the value of less than \$1,500 from three
separate locations within a period of 72 hours as part of the same act or
transaction or in two or more acts or transactions connected together or
constituting parts of a common scheme or course of conduct is a severity
level 9, nonperson felony; *and*

20 (9) property that is a motor vehicle of the value of less than \$1,500 is
 21 a severity level 10, nonperson felony; and

(9) property that is a motor vehicle of the value of at least \$500 but
less than \$1,500 is a severity level 10, nonperson felony.

(c) As used in this section:

(1) "Conviction" or "convicted" includes being convicted of a
violation of K.S.A. 21-3701, prior to its repeal, this section or a municipal
ordinance which prohibits the acts that this section prohibits;

(2) "mail" means a letter, postal card, package or bag sent through the
United States postal service or other delivery service, or any other article
or thing contained therein;

(3) "regulated scrap metal" means the same as defined in K.S.A. 2024
Supp. 50-6,109, and amendments thereto;

(4) "remote service unit" means the same as defined in K.S.A. 91111, and amendments thereto, and includes, but is not limited to,
automated cash dispensing machines and automated teller machines; and

36 (5) "value" means the value of the property or, if the property is 77 regulated scrap metal or a remote service unit, the cost to restore the site of 788 the theft of such regulated scrap metal or remote service unit to its 799 condition at the time immediately prior to the theft of such regulated scrap 740 metal or remote service unit, whichever is greater.
